In March 2009, The New York Times wrote a lengthy piece about renowned physicist Freeman Dyson, then 85. Four years earlier, Dyson began publicly to express doubts about the global warming or “climate change” alarmism promoted by the likes of former Vice President Al Gore, whom Dyson disparaged as “an opportunist” engaging in “lousy science.”

About Dyson’s intellect and stature, the Times wrote: “Dyson is a scientist whose intelligence is revered by other scientists – William Press, National Laboratory and now a professor of computer science at the University of Texas, calls him ‘infinitely smart.’ Dyson (a mathematics prodigy who came to this country at 23 and right away contributed seminal work to physics by unifying quantum and electrodynamic theory) not only did path-breaking science of his own; he also witnessed the development of modern physics, thinking alongside most of the luminous figures of the age – including Einstein, Richard Feynman, Niels Bohr, Enrico Fermi, Hans Bethe, Edward Teller, J. Robert Oppenheimer and Edward Witten, the ‘high priest of string theory’ . . .”

Described politically as an “Obama-loving, (George W.) Bush-loathing liberal,” Dyson immersed himself in the science of climate change, read the prominent and influential studies and watched Gore’s Oscar-winning documentary, “An Inconvenient Truth.”

After this deep dive, Dyson said he was coming “out of the closet as far as global warming is concerned” while acknowledging “most consider me wrong about global warming.”

About climate change alarmism, Dyson concluded: “The climate-studies people who work with

models always tend to overestimate their models. They come to believe models are real and forget they are only models . . . Most of the evolution of life occurred on a planet substantially warmer than it is now and substantially richer in carbon dioxide.”

One would think that Dyson’s observations would cause at least some of the most ardent climate change alarmists to say, “Dyson is brilliant. What does he see that I don’t? If one of the world’s leading physicists, universally recognized as a genius, thinks climate change alarmism is nonsense and that non-scientist Al Gore is full of it, perhaps I need to rethink this?”

Instead, according to Dyson’s son, his father’s views have “cooled friendships.”

This brings us to Elon Musk, the world’s richest man and a brilliant technologist, whose achievements include the following.

- Co-founding the electronic payment firm PayPal
- Starting the rocket and spacecraft company SpaceX
- Becoming one of the first major investors in Tesla
- Starting an artificial intelligence company
- Founding Starlink, a satellite internet service

He bought the company formally known as Twitter, reined in its discrimination against conservative users and fired nearly 80% of its workforce without any harm to continuing operations.

Musk, along-time member of the political left, renounced the Democratic Party and became not just an admirer of Donald Trump but campaigned on behalf of his second term. Far worse, as far as his former left-wing admirers are concerned, Musk joined the Trump administration as the leader of the Department of Government Efficiency, with a mission to wring out bloat, inefficiency and corrupt spending by the federal government.

Musk recently said: “The government waste and fraud is so high that it’s causing a \$2 trillion annual deficit . . . The cost of our debt has gotten so high that just the interest payments on the debt exceed the entire military budget . . . If a country overspends and doesn’t spend wisely (just like a person), the country will go bankrupt . . . (A)nd if we don’t do something, the ship of America is going to sink. We are all on that ship.”

One would think many on the left (especially those who once admired Musk), would at the very least say: “Musk is brilliant. What does this man behind SpaceX and Tesla see about the Democratic Party, the Republican Party and President Donald Trump that I don’t? Maybe I need to rethink this?”

Instead, Tesla owners have seen their cars defaced and set on fire. Musk is regularly denounced by Democratic officeholders as “dumb,” “evil” and “a Nazi.”

Question: As to the now late Dyson and the still-alive Elon Musk, a recipient of death threats – what’s wrong with this picture?”

The United States Constitution is built on a system of separation of powers, ensuring that each branch of government – the legislature, executive and judicial – operates within its own clearly defined sphere of authority. Article II of the Constitution explicitly vests executive power in the president, granting him the sole authority to run the executive branch, hire and fire federal employees and manage the implementation of federal policy.

However, in recent years, judicial overreach has increasingly threatened this fundamental structure. Activist judges have repeatedly interfered with executive decisions, particularly regarding federal employment and budgetary matters, effectively attempting to seize control of the executive branch. This kind of judicial activism is not only unconstitutional but also dangerous to the very principles of self-governance and democratic accountability.

The Executive Power Belongs to the President Alone

Article II, Section 1 of the U.S. Constitution states: “The executive power shall be vested in a President of the United States of America.” This is not an ambiguous statement – it makes clear that executive authority belongs to the president, not to Congress, not to the courts and not to unelected federal bureaucrats.

Among the responsibilities that come with executive power is the authority to hire and fire federal employees. The president, as the head of the executive branch, is responsible for ensuring that federal employees serve the interests of the American people effectively and efficiently. If an administration determines that certain employees are unnecessary, redundant or incompetent, it is well within the president’s constitutional authority to dismiss them.

No federal employee has a constitutional right to a government job. Employment in the federal government is not a protected right, and courts have no legitimate authority to override the president’s decisions on workforce management.

Despite this clear constitutional framework, we have seen repeated attempts by liberal judges to interfere with the executive branch’s authority by blocking efforts to reduce the federal workforce, demanding that terminated employees be rehired, or even forcing the president to spend taxpayer money on wasteful programs that he deems unnecessary.

Such rulings are blatant violations of the separation of powers and represent an unacceptable intrusion into executive functions.

Judicial Overreach: Courts Acting as Legislators and Executives

The role of the judiciary is to interpret laws and rule on matters of constitutionality – not to govern. When courts attempt to dictate how the executive branch should function, they undermine the very structure of our constitutional republic. Recent examples of judicial overreach include:

- **Blocking the Dismissal of Federal Employees:** Courts have issued rulings that prevent the president from reducing the size of the federal workforce, despite the fact that hiring and firing decisions fall exclusively under the president's executive authority.
- **Forcing the Executive to Fund Programs:** Courts have ruled that the president must allocate taxpayer dollars to programs created by unelected bureaucrats, even when the president deems these programs inefficient or wasteful.
- **Mandating Policy Implementation:** Judges have attempted to compel presidents to enforce policies from prior administrations, essentially stripping the executive branch of its discretion to set policy priorities.

These judicial actions represent an erosion of executive authority and a dangerous precedent where courts assume powers they were never meant to have.

The Proper Role of the Courts

The Judiciary exists to interpret laws and ensure they comply with the Constitution. If the executive branch were to violate the constitutional rights of individuals – for example, by attempting to silence political opponents or outlaw religious institutions – then courts would have a clear role in declaring such actions unconstitutional.

However, personnel decisions within the executive branch do not fall into this category. There is no constitutional right to a government job, nor is there a constitutional requirement that the executive branch continue to fund every program established by previous administrations.

The founders of this nation designed a system of government that deliberately separated powers to prevent any one branch from becoming too powerful.

- The judiciary was given the responsibility of checking unconstitutional actions, not of micro-managing the executive branch.
- Courts that attempt to dictate hiring, firing and spending decisions are operating far outside their constitutional mandate.

Why Judicial Overreach Is Dangerous

When judges take it upon themselves to run the executive branch, they create a serious threat to democratic governance. Unlike elected officials, federal judges do not answer to the voters. If the president makes poor decisions regarding hiring and firing, or if he mismanages the budget, he can be held accountable by the electorate in the next election.

However, if unelected judges make these decisions instead, the American people have no recourse to challenge their rulings.

Judicial overreach also weakens the executive branch's ability to function effectively. A president who cannot remove ineffective or insubordinate employees is handicapped in his ability to implement policy. If the courts dictate how the executive branch must allocate its resources, then the executive's ability to set policy priorities is effectively nullified. This is not how the government was designed to function.

Restoring Constitutional Balance

The Constitution is clear: the president alone holds executive power.

While the judiciary plays a crucial role in ensuring that government actions adhere to constitutional principles, it has no authority to run the executive branch or interfere with its operations. The increasing trend of judicial overreach – particularly in matters of federal employment and spending – represents a serious threat to the constitutional separation of powers.

If the United States is to remain a nation governed by laws and democratic accountability, courts must stay within their proper constitutional role. The president, as the head of the executive branch, must be free to make decisions regarding the workforce and budget without judicial interference.

The American people must recognize the dangers of judicial overreach and demand that courts respect the constitutional boundaries that ensure the proper functioning of our government. Only by restoring this balance can we protect the integrity of our democratic system and ensure that power remains where the Constitution intended.

When Mr. Trump was in office the first time, the liberal energy was firmly with Mr. [Bernie] Sanders.

By the time the 2020 Democratic presidential primary race began, several contenders rushed to embrace Mr. Sander’s goals on health care and other issues – even though most of the party’s successful candidates in the 2018 midterm elections adopted more moderate stances. The party’s eventual nominee in 2020, Mr. Biden, took a more moderate tack as well.

There are now signs that outraged constituents have regained the power to steer their elected officials. Anger at Mr. Schumer and Senate Democrats last month prompted futile displays of opposition to Mr. Trump’s cabinet appointments. Democrats hosting town-hall events meant to hold Republicans accountable for the Trump agenda have found themselves facing liberal pushback for not being able to change the country’s course.

Taking the nation in a new direction will require, some progressives said, a sustained effort to demonstrate both popular opposition to Mr. Trump’s agenda and support for a liberal alternative.

Keith Ellison, the Democratic attorney general of Minnesota (whom Mr. Sanders backed in 2017 to become the Democratic National Committee chairman said: “After the murder of George Floyd, you saw a massive outpouring. You saw a lot of people making statements about police accountability, diversity, equity and inclusion. And then when the movement subsides, they’re ready to roll it all back. So, there’s a lesson there. The lesson is you’re going to have to stay in the streets.”
