Prayer updates

Following is an update from **Josh** and **Christy Sharp** about **Hunter Sharp** (their 24-year-old son, who was in a serious motorcycle accident): "We want to thank everybody for the prayers for Hunter. He is getting stronger every day. God is good. Thank y'all."

In the Sept. 20 and Oct. 25 bulletins, we requested prayers for **Gary Woodring** of Bullard, who was diagnosed with a tumor on his pituitary (affecting his balance) and was scheduled for a doctor appointment on Nov. 6. Last Saturday (too late for last week's bulletin), Mr. Woodring gave this update: "The doctors don't choose to remove the tumor at the present time but to just keep an eye on it with further testing down the road. They don't believe the issues with my vision and balance are due to the tumor, but possibly due to my fall. They believe the tumor is benign and not life-threatening. So praise the Almighty and thank you for all of your prayers."

In last week's bulletin, we mentioned that **Dave McLearen** was diagnosed with gout. On Tuesday, he reported that a home-health person went to the McLearen home and set up six weeks of in-home therapy designed to help his balance and core strength.

In last week's bulletin, we mentioned that **Debra Acosta** had a scheduled doctor appointment last Tuesday. She reported: "Apparently, I am diabetic, with my blood-sugar levels dropping at night. At this point we will be treating this with diet change, increased exercise and monitoring blood-sugar levels. Praise God for answered prayer, a diagnosis and a plan of action. Thank you all for your words of encouragement and for your prayers."

"Obey to Be Blessed at the Resurrection—Part 1"

IG SANDY, Texas—At our Bible study on Wednesday night, I began a new series. The title was "Obey to Be Blessed at the Resurrection—Part 1." This series is related to a presentation that I gave on Saturday, Oct. 18. In that presentation, I presented three reasons why we obey God.

Those three reasons were the following.

- To be Blessed Now
- To be Blessed at the Resurrection
- To Glorify and to Honor the Father and the Son

When I covered the concept of being blessed now, I gave two presentations. To cover the concept of being blessed at the resurrection, I expect to give three presentations. This presentation (Part 1) will discuss scriptures involving the words resurrection and being raised.

Foundational scripture

The foundational scripture for this threepart series is Luke 14:14.

■ Luke 14:14—Believers are instructed to do the correct behavior, even when

people cannot repay them—because they will be "repaid at the resurrection of the just."

- Revelation 20:5-6—Blessed and holy is he who has part in the first resurrection.
