Power is best left close to the people. Elections should be run at the state and local levels.

A high priority for the radical Left is a national takeover of our elections. It wants the bureaucrats in DC running our elections. This is what S. 1, or The Corrupt Politicians Act, is all about—another big government power grab.

Following the 2020 election, there is no doubt that many states need to reform their election laws. A national takeover is not the answer. Power is best left close to the people. Elections should be run at the state and local levels.

The Corrupt Politicians Act sets out to turn all the states toward the Pennsylvania election model of chaos and uncertainty. States will be required to count ballots that arrive up until 10 days after Election Day, meaning the election will drag on and on. Meanwhile, my home state of Ohio, which ran smoothly and delivered results on Election Night, will be forced to adopt this flawed election system.

Ohio has also done an excellent job at cleaning voter rolls to reduce the risk of voter fraud. Under this bill, states would no longer have the power to regulate voter registration, and they would be forced to degrade the accuracy of voter rolls by being required to automatically register all individuals from state and federal databases. This would result in many ineligible individuals such as green card holders being registered to vote.

Additionally, Ohio, like many states, has voter ID requirements. The Corrupt Politicians Act bans voter ID laws. Voter ID requirements are rising in popularity and help increase trust in our election system.

If you oppose the legislation, you better be ready to be called a racist and a vote suppressor. This attack could not be further from the truth. Allowing illegal votes to be cast cancels out legal votes. It diminishes the voting rights that African Americans fought hard to secure throughout the 1960s. The Left's rhetoric on this is offensive and irresponsible.

We all want to have free and fair elections where every legal vote is counted. States should learn from the disaster of 2020 and make reforms to increase transparency and election security.

The Corrupt Politicians Act is a massive step backward for election integrity. It is an attempt by the Left to hijack the election process and change the rules in its favor to protect its majority.

We don't need a federal takeover of elections. Power belongs with the people, not the bureaucrats and politicians in Washington, DC.

Radicals are cramming a federal takeover of elections through a key vote on the Corrupt Politicians Act, part of their plan with Joe Biden and Kamala Harris to transform America into a permanent one-party socialist nation.

Tuesday, the Senate Rules Committee voted along party lines to send S. 1—the Senate version of H.R. 1, which is officially named the For the People Act but which is better named the Corrupt Politicians Act—to the Senate floor. Normally a 9-9 tie vote in the Rules Committee would doom a bill, but Senate Majority Leader Chuck Schumer (D-NY) has muscled through a perversion of Senate rules to take to the Senate floor legislation and nominations that should have died in committee.

Also normally, a Senate committee vote sounds so boring that you only hear about it if you stumble onto a news station on your way to finding the baseball game on TV. But this time your children's freedom is at stake, as Senate Democrats move one step closer to eradicating the freedoms that make America the greatest nation on earth.

S. 1 is an 880-page federal takeover of all elections nationwide, abolishing voter ID and other commonsense election integrity safeguards, and mandating month-long mail-in balloting and other measures that could hijack elections in every state for every election going forward. It would ensure that Republicans can never win another nationwide election for president or for congressional control.

As S. 1 goes to the floor, Republicans will filibuster it, which would normally take 60 votes to circumvent. But Schumer is determined to use the “nuclear option” to blow up over a century of Senate rules to abolish the filibuster and force S. 1 through on a 50-50 party-line vote, because the Constitution says that the vice president breaks all tie votes, and Vice President Kamala Harris is chomping at the bit to seize permanent power in America by making the vote 51-50.

All that stands in their way are two Democrat senators who say they will not nuke the filibuster: Sen. Joe Manchin (D-WV) and Sen. Kyrsten Sinema (D-AZ). If either one keeps their word, S. 1 will not pass.

Biden relentlessly calls on the Senate to pass S. 1, even bringing Manchin to the White House before the committee vote, no doubt trying to talk the West Virginian into breaking his promise to his home state. Gone is the Biden of past decades, replaced by an old, tired, radicalized version of Biden who robotically supports the extremist socialist agenda put on his desk for signature by Harris, White House Chief of Staff Ron Klain, Schumer, and House Speaker Nancy Pelosi (D-CA).

It’s key for all Americans to understand how the S. 1 (H.R. 1) Corrupt Politicians Act fits into this power grab to fundamentally transform America into a socialist nation under permanent one-party rule.

Our Constitution’s key to freedom is that it takes government power and breaks it. It breaks power between the federal government and the states. It also breaks federal power between the president, Congress, and the Supreme Court, and sets them against each other. If the power players are busy arm-wrestling with each other, it forces them to leave you free to live your life. That formula has worked for us for more than 200 years.

The common tie in the various pieces of big legislation the Democrats are trying to ram through is that it would undo this formula for liberty. It’s not just S. 1; Democrats are trying to pass H.R. 51 to make D.C. a state to give them two more Democrat senators and an instant 52-50 majority to ram through their radical socialist agenda. They’re trying to pass mass amnesty to turn 11 million illegal aliens into voting citizens who would vote for a permanent expansion of the welfare state, paid for by hardworking Americans. They’re trying to pack the Supreme Court by expanding it from nine justices to 13 so that they have a guaranteed liberal majority to rubber-stamp all their unconstitutional socialism.

Any one of these four bills would give the far-left wing of the Democrat Party—Alexandra Ocasio Cortez (AOC), Ilhan Omar, Rashida Tlaib, Cori Bush, Mondaire Jones—permanent control of the House, Senate, the White House—and even the Supreme Court.

Schumer is doing his part to push through that agenda in the arena of voting. Once he gets S. 1 through the Senate Rules Committee, he will execute a full-court press on Manchin and Sinema to cave on their commitment to their home states and the nation to protect the role the filibuster plays in making the Senate a place where senior statesmen need to build consensus to pass transformational legislation.

On the election integrity front, Republican governors and legislators nationwide continue passing laws to restore decades of election safeguards that have been abandoned in recent years, laws that make it easy to vote, but hard to cheat.

With H.R. 1 and S. 1, Biden, Harris, Pelosi, and Schumer are pushing a key component to seize perpetual power, and fundamentally transform America.

Florida Gov. Ron DeSantis signed an election integrity bill into law Thursday morning [May 6] to make it easier to vote and harder to cheat. Unfortunately, the mainstream media is helping to circulate misinformation about the law, known as SB 90. Here is what you need to separate myth from fact.

Myth: Florida is trying to suppress mail-in voting.

Fact: Florida's reforms simply make the process more uniform by strengthening ID requirements for absentee voting that already apply to in-person voting.

- These reforms would enhance voter ID requirements for mail-in ballot requests.
- Two-thirds (66%) of voters agree that applying voter ID requirements to absentee ballots, as SB 90 does, is a good way to safeguard ballot integrity.
- Research shows that voter ID doesn't actually negatively impact turnout, despite Democrats' false claims of voter suppression.

Myth: Florida is trying to make it harder for seniors or disabled voters to have their absentee votes turned in by others.

Fact: Florida's reforms allow a person to collect immediate family members' ballots and up to two ballots from unrelated persons.

- This is about restricting ballot trafficking and maintaining a secure chain of custody of ballots, which benefits voters.
- The law expands the list of people authorized to handle vote-by-mail ballots to include a voter's grandchild.

- Limiting who handles other voters' ballots ensures that paid political operatives will be prohibited from picking up and potentially mishandling or changing absentee ballots and pressuring or coercing vulnerable voters in their homes.
- Polling shows that 62% of voters are against political operatives and paid organizers having direct access to absentee voters as they vote, and then taking unsupervised possession of their ballots.

Myth: Florida's reforms put new limits on drop boxes to make it harder for voters.

Fact: The reforms ensure sufficient security to protect voters' ballots, while maintaining access to drop boxes.

- Staffing drop boxes ensures the safety of ballots dropped off and provides voters with confidence their vote will be counted correctly.
- Under new legislation, drop box locations will be published 30 days in advance so voters have certainty on when and where to access drop boxes.
- Voters are still able to place a stamp on their vote-by-mail ballot and drop it in any secure mailbox.

Myth: Allowing access to the absentee ballot signature verification process will allow partisan operatives to file frivolous challenges.

Fact: Observation by poll watchers for in-person voting has been allowed for decades, and with the growth of mail-in voting, the same protections should be applied.

- It is important that the mail-in voting process maintains the same important safeguards that in-person voting does.
- The bill ensures party affiliation is not disclosed to election workers during the signature match process.
- Transparency instills confidence in the electoral process and reduces the temptation of election workers to commit fraud.

In the Queen's Speech to both houses of Parliament Tuesday, Queen Elizabeth announced that the government would press ahead with plans to implement an electoral integrity bill similar to measures recently signed into law by U.S. governors that saw Democrats respond with trademark hyperbole.

In her remarks to the House of Lords and the House of Commons, the Queen stated that the government "will strengthen and renew democracy and the constitution" and that "legislation will be introduced to ensure the integrity of elections."

Similar safeguards on election integrity here across the pond in the United States have been laughably blasted by President Biden as worse than Jim Crow, or, Jim Eagle, or whoever.

The Queen's Speech reiterated a commitment to securing U.K.'s elections, a process that's been underway for years and which proponents hope to have in place by 2023. The plans being worked out were explained further in a House of Commons Library briefing released ahead of this year's address by the Queen: "The Government promised measures to protect the integrity of elections. It planned to require voters to show an approved form of photographic ID at a polling station in a UK parliamentary election in Great Britain and local election in England (photo ID is already required in Northern Ireland). It also said voters without appropriate ID would be able to apply, free of charge, for a local electoral identity card."

Test runs of a voter ID requirement conducted by the U.K. government in 2018 and 2019 found, unsurprisingly, "the experience of taking part in the pilot scheme appeared to have had a positive impact on people's perception of the security of the polling station process."

Meanwhile in Northern Ireland where a photo ID requirement already exists for voters, Parliament reports "there has been no evidence that the ID requirements in Northern Ireland have affected turnout and the allegations of 'personation', the crime of pretending to be someone else when you vote, have been eliminated."

But these successful pilot programs and the proven effectiveness of Northern Ireland's photo ID requirement don't matter to American leftists who have pivoted from calling out Georgia and other states' election integrity laws to go after the Queen.

Usual suspects at the American Civil Liberties Union and Southern Poverty Law Center returned to their normal antics that prove the soft bigotry of low expectations remains a favorite cudgel of the supposedly "progressive" Left.

"The real reason these laws are passed is to suppress the vote, and that is in fact what happens," claimed Caren Short of the SPLC in a quote to the *Guardian*, an allegation that is of course not backed up by the U.K.'s pilot programs testing photo ID requirements. She added that "There are certain communities that do not possess the required ID, or the underlying documents required to get the ID, and so it makes it harder for those folks to vote."

A supposed voting rights expert at the ACLU echoed the bigoted claims, saying measures to secure election are "about excluding the people who are least likely to have that ID." Never mind these same people presumably manage to purchase items, board flights, and do any number of things that require an ID already.

Again, through the pilot programs and analysis of Northern Ireland's system, "where voters without access to approved photo ID can apply for a free photographic electoral ID card from their local council" showed that "most voters in Northern Ireland, which had individual registration and voter ID requirements before the rest of the UK, considered [their] voting arrangement to be 'gold standard.'"

Facts of course matter little to those who prefer an unsecured election system, but the U.K.'s work toward full photo ID to vote has already shown what American

leaders who pursue similar protections know to be true: election integrity makes voters more confident in the democratic process, is not a detriment to voter turnout, and greatly reduces opportunities for fraudulent votes to be counted.

What has Joe Biden accomplished in his first 100 days as president? His performance on domestic issues has been underwhelming to say the least. But Biden’s foreign policy blunders are potentially disastrous.

The Biden-Harris administration “open borders” policy is a nightmare on our southern frontier. Hundreds of thousands of undocumented migrants—many of them children—have flooded into Texas, Arizona, New Mexico and California. The imagery of thousands of children crammed into cages, huddled beneath aluminum-foil “survival blankets” will haunt us for years.

Biden’s infrastructure plan embraces the Paris climate accord, shuts down the Keystone XL Pipeline, stops the export of fossil fuels, limits fracking, costs jobs and eliminates U.S. energy independence. These, and a host of other domestic policy issue—revising U.S. history, fair housing, police reform, solving systemic racism and, eventually, reparations—will have enduring, adverse socioeconomic consequences.

But Biden’s blunders in foreign and defense policy are far more likely to have immediate and long-lasting consequences for the American people.

The Biden administration’s mid-March 2021 summit in Anchorage, Alaska, with representatives of the People’s Republic of China, was an unmitigated disaster. The vaunted Biden foreign policy team—Secretary of State Tony Blinken and national security adviser Jake Sullivan—never raised questions about how a virus, originating in the PRC, caused a global pandemic, killing millions. They barely

mentioned the brutal suppression of democracy in Hong Kong, the genocide wrought against Uighur Muslims, Beijing's wholesale theft of intellectual property or the PRCs outright threats to Taiwan, the Philippines, Vietnam and Japan.

Biden's decision to reopen talks with Tehran over the Joint Comprehensive Plan of Action—known as the Iran Nuclear Deal—is widely viewed by Israel and our Arab friends in the Middle East as appeasement for the Ayatollahs. By doing so, Biden has increased the chance of a future nuclear conflict between Iran and Israel, which could quickly engulf the entire planet in much the same way political blunders ignited World War I, and appeasing Fascist Germany, Italy and Japan led to World War II.

The most recent Biden blunder is his mishandling of the withdrawal of American forces from Afghanistan. Not only did he give the enemy the exact date by which American troops would be out of this troubled country, but also he has turned his back on more than 17,000 Afghan interpreters—most of whom risked their lives in combat with U.S. units.

Scores of "terps" have been killed and wounded while serving side-by-side with American soldiers, sailors, airmen and Marines in this long war. More than 500 Afghan citizens who worked as interpreters, translators and logistics facilitators with U.S. forces have been killed in the last three years. Leaving these loyal men and women and their families behind to be tortured and slaughtered by murderous Taliban and al-Qaida thugs is more than a foreign policy blunder; it is a despicable act of moral cowardice.

The "terp problem" is the easiest Biden foreign policy blunder to fix. Sign an executive order directing the Departments of State and Defense to waive provisions of the Special Immigrant Visa program, and put the interpreters—and their families—on U.S. military aircraft to fly them to safety.

Where? How about temporary facilities on an overseas U.S. military base—say on Guam. We've done that before in the aftermath of the Mariel boatlift in 1980 when Jimmy Carter provided shelter and security for more than 125,000 Cuban refugees.

Doing such a rescue now for loyal Afghan "terps" could prevent scenes at our U.S. embassy in Kabul similar to the one in May 1975 in Saigon.

Joe Biden is the luckiest man to ever assume the presidency.

He succeeded an unpopular figure. He was inaugurated just two weeks after the dramatic storming of the U.S. Capitol by extremist Donald Trump supporters seeking to stop the certification of the 2020 election, which was also the beginning of the year after widespread race riots. He inherited covid-19 vac-

Normalcy could be restored by installing a nearly inanimate object as president.

Instead, Biden has served as a facade for the most radical administration in modern American history. And America is already paying the price.

In his first few months in office, Biden rammed through a \$1.9 trillion spending package that completely rewrote the bargain between individuals and the state, shifting the incentive structure for people to go back to work. He simultaneously proposed another \$4 trillion in spending—to go along with the annual \$4 trillion budget. The result: skyrocketing inflation in commodities, along with dramatic labor shortages resulting in an April shortfall of three-quarters of a million new jobs.

Simultaneously, he downplayed the efficacy of a vaccine he insisted was the key to ending the pandemic. His Food and Drug Administration pressed pause on a highly successful vaccine based on six cases of blood clots; his Centers for Disease Control and Prevention rewrote its school reopening guidelines, apparently with input from the teachers unions. He wore a mask publicly despite being vaccinated, despite being outdoors, despite being indoors with others who had been vaccinated—and declared such activity “patriotic.” The result: widespread vaccine hesitancy and a tremendously uneven national reopening, with red states going back to normal and blue states continuing nonsensical shutdowns.

He ramped up the rhetoric with regard to racial polarization, injecting the terms “anti-racist” and “equity” into every element of federal policy, supplanting meritocracy and individual rights with equality of outcome and outright discrimination. The result: undercutting police forces nationally, resulting in a continuing crime wave in America’s biggest cities.

And he abandoned the Trump administration’s Middle East policy, refunding the Palestinians with money that will obviously go to terrorist groups and defy the Taylor Force Act; making concessions to the Iranian terror regime; and pressuring Israel. The result: riots in Jerusalem, chaos on the Temple Mount and an increase in regional Iranian aggression.

We’re only four months into Biden’s presidency. He’s going for broke: He wants his legacy, and if that legacy comes at the cost of the economy, the polis and international stability, so be it. If the conflagration we’ve seen thus far is any indicator, Biden won’t leave a lot standing when he’s done.
