Back in 1992, Yiannis Klouvas converted an old cinema into the Blue Lagoon restaurant, which garnered a strong reputation for live music. There is no music now. The business, like so many others on the Greek island of Rhodes, is struggling due to the pandemic’s restrictions on travel.

“If we see a tourist on the street these days,” he says, “we take a photo to remember them.”

Mr. Klouvas is now banking on the EU Digital covid Certificate, also known as the “green passport,” to save the summer. Starting July 1, all EU member states will accept the certificates as proof of covid-19 vaccination, a recent negative test, or recovery from the disease. The plan got a resounding yes at the European Parliament on June 9. All EU member states, Liechtenstein, and Norway will implement the passport.

But across the Atlantic, the idea faces strong head winds, whether for travel or domestic use. The Biden administration has ruled out introducing vaccination passports, and some states even ban them. Fox News talk show host Tucker Carlson likened the use of them to segregation. “Medical Jim Crow has come to America,” he said.

Prioritizing freedom and fears of government overreach underpin the rejection of vaccine certificates in the U.S., while European societies have grappled more with issues of privacy and fairness. And so as Western countries savor a return to the old, this phase of post-pandemic mobility is being shaped by cultural attitudes—like Europeans’ tendency to make the most of having entirely different cultures within a few hours’ drive—and the initial responses to the pandemic.

“Alabama never closed the border to Mississippi in the way Finland closed the border to Sweden,” points out Anders Herlitz, a researcher at Sweden’s Institute for Futures Studies. “Here in the EU, the vaccine passports are seen as a necessary evil to get rid of other, much more extensive, limitations to people’s freedom, whereas in the U.S., they would not help getting rid of other limitations, but only cause new limitations.”

Jen Kates, director of global health and HIV policy at the Kaiser Family Foundation in Washington, says previous pandemic plans didn’t account for cultural variations and responses.

“One thing we know from how covid has played out globally is that culture matters,” she says. “Politics, culture, all the differences that we know that structure people’s lives have to be taken into account, both for getting back to normal and for preparing for the next pandemic.”

### **Europe’s green passport**

Nine European countries, including Greece and Germany, are already using the EU covid-19 passport. When the Greek government unveiled the passport, Prime Minister Kyriakos Mitsotakis trumpeted the opening of a “fast lane” to facilitate travel. Everyone realizes two years without tourists would be an economic disaster for the Mediterranean nation.

“Greece is very strongly pro-vaccine passport, especially as far as foreigners are concerned,” says Paris Kyriacopolous, chairman of Motodynamics and Lion Rental, which operates Sixt Rent a Car in Greece.

Ipsos polling data suggests the dominant attitude toward covid-19 vaccine passports across Europe is equally positive. When it comes to using them

domestically, citizens are more concerned by questions of fairness than by privacy issues, and pockets of society are ambivalent about or opposed to vaccines. But when it comes to travel, the view is clearly pro.

Even Germany, which had more rigorous ethical debates on the issues and boasts stringent data privacy laws, got behind the idea of digital health certificates. More than 60% of Germans now support implementing them, according to a recent YouGov poll, even though less than half the population has had a first jab.

Malcolm Jorgensen, an academic who is providing administrative assistance at one of Berlin's six vaccination centers, is fully vaccinated as of this week. His vaccination card has allowed him to shop at markets and visit the gym without flashing a coronavirus test result. He says the move from a paper card to a digital passport isn't much of a leap.

"There's already informal digitization," says Dr. Jorgensen. "At the gym I can just show a photograph of my vaccination booklet, rather than the booklet itself. Digitization is inevitable."

In Germany, debates over the passports have had less to do with privacy concerns than with equity of access for people who choose not to or cannot be vaccinated. Analysts note that medical insurance companies already have individuals' health details.

"It's an ethical question," says Olga Stepanova, a data protection attorney with WINHELLER Law. "Each government needs to decide what kinds of access limitations may be imposed to protect others, while not limiting freedoms of non-vaccinated people in an inappropriate way."

### **Concern about privacy**

The freedom debate has been particularly fierce in the U.S. Much like other issues throughout the pandemic, the vaccine certificate has become deeply polarizing.

The divisions fall along partisan lines—just as they did with stay-at-home orders and mask mandates—and so different states have moved toward normalcy in distinct ways. New York was the first to introduce its Excelsior Pass, which allows residents to prove their vaccination status to gain access to certain social venues. But several states, including Florida and Texas, ban such passes outright.

The state of Michigan has been one of the most closely watched during the last year, ever since former President Donald Trump notoriously tweeted "Liberate Michigan" last spring in regard to tough anti-lockdown measures implemented by Democratic Gov. Gretchen Whitmer. This spring, as the state coped with one of the worst spikes of covid-19, a bitter debate over vaccine passports broke out.

This month the Michigan House approved legislation to ban so-called vaccine passports in the state—even though the governor has repeatedly said she has no intention of introducing them. "The threat of government controlling one's daily life through identification of whether one is immunized or not is frightening," said Rep. Sue Allor, who proposed the bill.

Like the rest of the country, the state is divided. The University of Michigan has mandated that students living in dormitories must prove vaccination. Since Michigan is a border state, some Democrats have pushed for passes as a way to travel more easily to Canada and avoid quarantines.

Dave Boucher, a government and politics reporter with the Detroit Free Press, says opposition centers around freedom of choice. It's about "the government 'telling me what I can and can't do,'" he says. "And there's always the slippery slope argument where if the government is endorsing vaccine passports now, then they're going to get vital information about you and track that information and use it in unknown, nefarious ways."

Rich Studley, president and CEO of the Michigan Chamber of Commerce, says the vast majority of his members are committed to a safe reopening and return to normal, but don't see passports as a way to do it.

"There is no groundswell of support that would be in favor of mandatory vaccines and vaccine passports," he says. "If there is one thing businesses have learned over the past year in Michigan, other than how to survive, it is how to operate their business safely to protect employees and customers."

In general, Americans—much like Europeans—are more accepting of passports to travel than they are for domestic use, according to polls. Some analysts believe they are an inevitable part of post-pandemic mobility.

"Digital health certificates are already available in the EU, and my guess is that they will be widely used, even without being adopted by the U.S.," says Chris Dye, a professor of epidemiology at Oxford University in Britain.

As other parts of the world move forward with passes, the U.S. might find itself playing catch-up. "It'll be really interesting to look ahead three to six months and see as other parts of the world are going forward and using these kinds of mechanisms, if there will be a change," says Dr. Kates.

On Monday, Florida Gov. Ron DeSantis signed HB 529 into law, mandating between one and two minutes of silence to start each day in the state's public schools. Said DeSantis, "The idea that you can just push God out of every institution and be successful, I'm sorry, our Founding Fathers did not believe that."

As for the purpose of the moment of silence, he stated at a news briefing, "We think it's something that's important to be able to provide each student the ability, every day, to be able to reflect and to be able to pray as they see fit."

As for the involvement of teachers, the bill is explicit: "A teacher may not make suggestions as to the nature of any reflection that a student may engage in during the moment of silence."

So, the children will be told to remain silent for the designated period of time, during which time (within obvious parameters) they can do what they like. They can pray in whatever form they desire. They can close their eyes and rest. They can think about what's coming the rest of the day. They can imagine whatever they want to imagine.

There are no guidelines and no restrictions, other than the fact that, for at least one minute but not more than two, they cannot talk. Or interact with each other in other ways. Or use their cell phones. Just silence.

To quote the bill more fully, "Legislature finds that in today's hectic society too few persons are able to experience even a moment of quiet reflection before plunging headlong into the activities of daily life. Young persons are particularly affected by the absence of an opportunity for a moment of quiet reflection. The Legislature finds that our youth, and society as a whole, would be well served if students in the public schools were afforded a moment of silence at the beginning of each school day."

As to who can give suggestions to the students as to how they spend the daily moment of silence, the bill presents this radical idea: "Each first-period classroom teacher shall encourage parents or guardians to discuss the moment of silence with their children and to make suggestions as to the best use of this time."

Can you imagine that? The schools asking the parents or guardians to give input into their children's lives while at school? These days, that sounds almost revolutionary. Three cheers for asking for parental influence!

Of course, not everyone is happy with the bill, with one disruptive protester claiming, "You're playing political games with our freedom of speech! You're playing political games!"

But, how, pray tell, does a moment of *silence* impact a student's freedom of speech? And isn't it ironic that, in these days of *compelled speech* in our classrooms, that this protester is upset about compelled silence?

Before the bill was signed into law, some Democratic legislators raised concerns that HB 529 would violate the separation of church and state. Senate Minority Leader Gary Farmer, said, "It would be a good thing if we could all take a moment of silence every day and reflect and meditate a little bit on things that are important to us. However, the framers of our Constitution were very careful to separate church and state."

But not only has Farmer grossly overstated both the letter and the spirit of the framers, who lived in a much more "Christian" world (especially when it came to children's education). Even Wikipedia noted that, "In the 18th, 19th and early 20th centuries, it was common practice for public schools to open with an oral prayer or Bible reading."

Farmer has also mistaken a moment of silence, during which a kid could think about playing video games or asking someone out on a date, for mandated prayer.

Really now, isn't that the whole strategy behind simply having a moment of silence rather than a time of mandatory prayer?

But Farmer was not alone in his concerns. Sen. Lori Berman said, "I understand that this is a moment of silence, but I also want us all to think about what could happen in a moment of silence. Could children take out rosaries and start doing the sign of the cross and (make) other children feel uncomfortable? Could a child take out a prayer rug and start using a prayer rug?"

On the one hand, the bill does state that "students may not interfere with other students' participation" in the moment of silence, so it is clear that they could not try to distract each other. As to what liberties the students should have (from making the sign of the cross to taking out rosary beads to taking out a prayer rug), I'm not sure how the legislators (or school administrators) will address this question. Perhaps the solution will be that no item of any kind can be used during the moment of silence.

Either way, it is unimaginable to me that a student would be disallowed from making the sign of the cross for fear that it would make "other children feel uncomfortable." Seriously? This is now a terrible threat? This is something against which we must be vigilant?

Is this what America has come to? Or should a student not be allowed to make the sign of the cross before engaging in school sports? (Many professional athletes engage in this very public practice to this day.)

Again, this hyper-sensitivity is even more hypocritical when we realize that, on a daily basis, students who practice a conservative religious faith are made to feel uncomfortable by the aggressive, activist curricula and agenda of the school, which is literally shoved down their face. No problem with that! But God forbid a student should make the sign of the cross while uttering a silent prayer to start the day. That would be a real threat to the psychological and emotional wellbeing of other students.

In this light, it will be interesting to watch just how hysterical and irrational the reactions to this bill will be in the coming days. It will also be interesting to see how much of a crisis this period of silence will present to some students for whom two minutes of solitude will feel like an eternity.

Recently, a student of Justice High School in Fairfax, Virginia led the graduation ceremony in the Pledge of Allegiance. In this public school setting, when she got to the part about “one nation under God,” she said, instead, “one nation under Allah.” This was apparently without any permission from school officials.

The idea of “one nation under Allah” is a natural outgrowth of the idea of “multi-culturalism,” but is inconsistent with our history. It is true that in some Muslim-dominant nations, Christians there use the name “Allah” for God. But it’s also true that the Allah of the Qu’ran is different than the God of the Bible. Presumably the student used the opportunity to tweak the noses of those who believe in the Judeo-Christian tradition of America as “one nation under God.”

“One nation under God” allows the Muslim, the Buddhist, the atheist to practice what they wish.

“One nation under Allah” restricts freedom of those who disagree—even fellow Muslims of a slightly different stripe.

The idea of multi-culturalism may sound good to the naïve. While we can learn something from virtually every culture, to say that all cultures are the same is ignorant. They are not.

In places where the worship of Allah is compulsory, there is little room to disagree. Even many Muslims find restrictions under strict Islam troubling. There are many Iranians and Pakistanis and Afghanis lining up to try and live in America. But we don’t have a lot of Americans lining up to go live in Iran or Pakistan or Afghanistan.

Here’s what Rabbi Daniel Lapin once told me in a television interview for D. James Kennedy Ministries video, *What If Jesus Had Never Been Born?*, “The easiest way to answer the question of whether life on planet earth is better because Jesus walked Jerusalem or not is very simple, and that is: Just watch the way people vote with their feet. Watch where the net flow of immigration is in the world today. Is it from Christian countries to non-Christian countries or the other way around? It is so obvious.”

America shines like a beacon *because* America is “one nation under God.”

Although the secularist denies it and gnashes his teeth at the idea that the Christian God had anything to do with the founding of America, the evidence abounds in the actual documents of America's settling and founding eras, e.g., as found in *The Annals of America* (Encyclopedia Britannica, 1976) or the Avalon Project (on-line) of Yale University.

In their own words:

- The Pilgrims came "for the glory of God and the advancement of the Christian faith." (Mayflower Compact, 1620).

- The Puritan founder of Boston, Rev. John Winthrop, said (quoting Jesus), "For we must consider that we shall be like a City upon a hill; the eyes of all people are on us." ("A Model of Christian Charity," 1630).

- The Fundamental Orders of Connecticut (1639), which historians believed was a direct ancestor to *the* Constitution, notes that the purpose of their settlement was for "the liberty and purity of the Gospel of our Lord Jesus." This is why Connecticut is called "the Constitution state."

And on it goes.

The Pilgrims, Puritans, and Quakers who founded British North America fled Mother England and other countries to get away from religious tyranny—in that case tyranny from professing Christians.

James Madison, a key architect of the Constitution, wrote the "Memorial and Remonstrance" (1785). In this document, he notes that as Christians we must have tolerance for those who have not yet been enlightened by the Gospel of Christ.

Said Madison, "Whilst we assert for ourselves a freedom to embrace, to profess, and to observe the religion which we believe to be of divine origin, we cannot deny an equal freedom to those whose minds have not yet yielded to the evidence which has convinced us. If this freedom be abused, it is an offence against God, not against man: To God therefore, not to men, must an account of it be rendered."

And thus, the founders established a nation where there would be no "establishment" of religion—nor would the free exercise of religion be squelched. This was understood for the first 150 years of American jurisprudence as meaning there would be no national church in America. In Britain, they have the Church of England. But there's no Church of America.

But now the secularists have been imposing in effect a religious system of secular humanism. Rabbi Lapin calls them "the secular fundamentalists." They are like the mullahs of Islam, only they seek to impose secular orthodoxy, including sexual libertinism.

And so, an "enlightened" student in America calls this country "one nation under Allah." But that is so far from our history and is totally anathema to freedom. Only as "one nation under God," do people enjoy liberty in America.

1. *Paul Ryan?* Pencil-necked, open borders, Never-Trump *Paul Ryan?* That's the guy who got Freeman so riled up?

2. The obnoxious Freeman is no longer a young career trial lawyer at the DOJ. Now he's a *senior* career trial lawyer at the DOJ.

Among the innovations dreamed up by fanatics like Freeman, Arizona was informed it could not ask for identification from people delivering more than 10 early ballots. Nothing fishy about that!

Arizona's voting laws were subject to federal oversight because of its well-known history as a slave state and avid practitioner of Jim Crow. (I may have to check my notes on that.)

Actually, Arizona was bossed around by liberal activists at the DOJ for 40 years because back in 1972, it didn't have bilingual ballots. Those weren't instituted until 1974. *They may as well have donned white hoods and burned crosses!*

Oddly, Mississippi's election laws were also subject to approval by the DOJ—despite the fact that blacks already voted at far higher rates than whites in that state. By contrast, Massachusetts did not require oversight of its voting laws, although in that fancy liberal state, black people voted at much lower rates than whites.

It's almost as if only red states have their voting laws nitpicked by left-wing lawyers in Washington. I wonder if that would help Democrats win presidential elections?

Ironically, meaning totally predictably, the original 1965 Voting Rights Act was necessary because Democrats were trying to prevent black people from voting. Today, Democrats are using these new "voting rights" bills to ensure that 110% of black people vote, even if they are convicted felons, don't live in the state, didn't actually fill out a ballot or are dead.

It wasn't until 2013 that the Supreme Court mercifully overturned key portions of the 1965 Voting Rights Act. (Citing the overwhelming Senate vote for the wonderfully named Voting Rights Act, Justice Antonin Scalia remarked at oral argument: "This is not the kind of a question you can leave to Congress.")

While it's great that ideologues like Dan Freeman had their wings clipped by the Court, the previous 40 years of their harassment tells you what they *want* to do. The John Lewis voting rights bill will put them back in the saddle!

States will be ordered to keep dead voters on the rolls, give violent felons the right to vote and jettison any voter I.D. requirements. (Interestingly, even after all the media demagoguery, black people still overwhelmingly support voter I.D. laws.)

There's no disincentive to government lawyers pursuing frivolous cases to the end of the Earth. Even if they eventually lose, they don't have to worry about court costs or legal fees. They don't pay 'em. You do.

The "For the People" voting rights bill is the floor of what these petty bureaucrats will require. Those are the bare-minimum "voting rights" that will be imposed on the states by the DOJ. That's the level of absurdity Democrats are willing to vote for in plain sight. What great ideas does Dan Freeman have that even Democrats couldn't endorse on the record?

What *is* the voting "rights" equivalent of the EPA's relentless persecution of homeowners, the Duke lacrosse case or the IRS's abuse of power? Because that's what the John Lewis voting rights bill will deliver.

This week, a video from a San Francisco Walgreens went viral on Twitter. The video depicted a man standing next to his bicycle, loading up a garbage bag with products. The man then rides his bicycle down the aisle, past a security guard, who limply throws out a hand to try to grab the bag; the shoplifter simply brushes past him, then rides out the door.

This sort of thing has become exceedingly common in San Francisco. In late May, Thomas Fuller wrote in The New York Times, "At a board of supervisors hearing last week, representatives from Walgreens said that thefts at its stores in San Francisco were four times the chain's national average, and that it had closed 17 stores, largely because the scale of thefts had made business untenable." Employees at Walgreens had been told to stand aside as shoplifting took place because security officers had been assaulted repeatedly.

All of this is the result of a 2014 California ballot measure that reclassified non-violent theft as a misdemeanor, so long as the thief took less than \$950 worth of material. Thieves quickly hit on a strategy: Hit up different stores for less than \$950 worth of stuff. Then, amid the Black Lives Matter protests and riots of 2020, San Francisco decided to crack down on the police. Mayor London Breed announced that booking photos would no longer be released, lest the prevalence of Black and brown faces lead to stereotyping; she announced a \$120 million cut to the police and sheriff's department over the next two years, in the interest of "prioritizing investments in the African American community"; in the first six months of 2020, 23 officers resigned from the force.

Property crime has skyrocketed. It's not just shoplifting: burglaries increased nearly 50% year-on-year in 2020, and car theft jumped 34%. Meanwhile, the streets are littered with garbage, and have been for years thanks to lax law enforcement. In

2018, a survey of 153 blocks in downtown San Francisco showed trash on every block, 41 blocks “dotted with needles” and 96 blocks with open human feces.

This form of governance has become all too common. Los Angeles, my former hometown, has steadily declined in terms of livability. Suburban areas have been inundated with homeless vagrants, often openly shooting up, while the police have been directed to do nothing; Venice Beach has become an enormous open-air homeless encampment. Seattle has morphed from the Emerald City into a refuge for those living on the street, regardless of the risks to other citizens.

There is a reason why Americans are fleeing America’s major cities. The problem predated covid-19, and it will post-date it, too. Americans like having a Walgreens in their neighborhoods. They enjoy being able to walk down the sidewalk without severely mentally ill homeless people—who should be in institutions where they can receive actual care—urinating on curbs. They should not have to instruct their children to hop over used needles on street corners.

Yet the governance of “compassion” continues. So does the migration away from such foolhardy policy. The top outbound states in America, according to North American Moving Services, were all deep blue: Illinois, New York, California, New Jersey and Maryland. The top inbound states were all red or purple: Idaho, Arizona, South Carolina, Tennessee and North Carolina.

At some point, there will be no more Walgreens in San Francisco. Then we will undoubtedly hear about how this is the product of systemic racism and white privilege; we will hear tell of the brutality of American capitalism. The truth is far simpler: Where Leftist governance reigns, criminality thrives. And where criminality thrives, Americans flee.

Unconditional love is neither biblical nor rational nor moral. Can you name anything good that is or should be given with no moral or ethical conditions?

Take salary, for example: Do you see a problem with continuing to pay employees no matter how they perform? In other words, do you see a problem with unconditional salaries?

The question is rhetorical.

If people believe they will receive the same salary no matter how well or poorly they work, few will work hard. The fact that a worker can be fired is precisely what prevents most people from slacking off.

Furthermore, paying the same salary to the lazy and careless worker as to the hardworking and responsible one is so unfair that it would completely undermine workplace morale.

Now substitute love for salary.

If everyone received the same amount of love no matter how terrible or beautiful their actions, wouldn't that create the same problems as unconditional salaries?

If we gave everyone the same amount of love no matter how they behaved, what would motivate anyone to behave better? And would it be fair? If kind, self-sacrificing, responsible people were to receive no more love than narcissists, murderers and thieves, the world would be a far more unjust place than it already is.

Unconditional love is no more desirable, no more fair and no more goodness-inducing than unconditional salary. Yet, remarkably, unconditional love has become the great human and even divine ideal.

This is a recent development.

Google charts the use of words and terms in English-language books from the beginning of the 19th century until the present. If you look at its chart for the term "unconditional love," you will learn that until the 1970s, the term almost never appeared in English-language books. And then, all of a sudden, it was everywhere.

In other words, when America was religious, no one used the term "unconditional love." Only as America became less religious, its culture more secular, did usage of the term soar. This alone should help dispel the widespread notion that unconditional love is a religious ideal.

It isn't. In a lifetime of teaching Judaism and now writing volume four of a five-volume Bible commentary, I have never come across the concept of unconditional love. In fact, God makes it clear that His love is conditional on obeying Him.

For example, He tells the Israelites: "If you will obey Me faithfully and keep My covenant, you shall be My treasured possession." He said *If*.

The Book of Psalms makes this even clearer: "(God) hates all evildoers. You doom those who speak lies; murderous, deceitful men the LORD abhors" (Psalm 5:6-7). Obviously, God doesn't give unconditional love.

As for Christianity, many Christians assert that unconditional love is the ideal for humans to aspire to. Yet, I could not find a single direct statement about unconditional love—divine or human—in the New Testament. As a Canadian Christian pastor and theologian, George Sinclair, wrote: "The Bible does not teach that God loves unconditionally or that you should love unconditionally."

Why modern Christians so frequently speak of God's unconditional love and of unconditional love as what humans should aspire to is a mystery to me. The very fact that according to Christian theology, only those who believe in Christ are saved from hell should make it clear that salvation is conditional. Some Christians respond that God continues to love the nonbeliever even as he descends to hell—because it is the nonbeliever, *not God*, who has sent himself to hell by rejecting God's love through His offer of salvation. However, that hardly argues against God's conditional love—that love (and the salvation prompted by it) is conditioned on the human being's acceptance of God's terms.

It is true that countless people who have strayed far from a righteous life have been immensely helped by the belief that God loves them—but they must repent to benefit from that love.

Unconditional love is, in the final analysis, a bad secular idea.

Aside from undermining people's reasons for pursuing excellence and undermining group morale—as we saw in the example of unconditional salaries—there are three other reasons it's a bad idea.

■ First, if people are loved no matter how immorally they act, love becomes the one thing in life that is completely divorced from morality. *Unconditional love makes love amoral.*

■ Second, what means more to you—someone who loves you because they love everyone unconditionally or someone who loves you because they consider you special?

■ Third, unconditional love often leads to very unloving behavior. If husbands and wives, for example, know they will receive the same amount of love no matter how they treat their spouse, do you think this is likely to lead to spouses acting better or worse?

But, many people will respond, don't parents have unconditional love for their children?

And isn't that the ideal?

Yes, many parents do love their children unconditionally—because it is instinctive in most people to so love their children. But is this a good message to convey to your children: "No matter how you treat your siblings or even us, your mother and father, not to mention non-family members, we will love you just the same"?

And even if parents' love for their child is unconditional, why should that be a model for how we ought to feel toward every other person on the planet?

Would your children be happy to know that you loved everyone just as much as you love them?

Should you? There would actually be something psychologically and morally wrong with a parent who loved everyone as much as they loved their child.

Yes, babies should receive unconditional love. The rest of us should want to grow up.

As for God, I have never believed I was the recipient of unconditional love from Him, nor have I ever sought it. I seek His approval. That's a better way to live.

The US population was an estimated 329 million on July 1, 2020, growing by 1.2 million in a year, according to newly released estimates from the Census Bureau. This annual growth was a decrease of 22% since 2019. The 0.4% annual growth rate is the lowest since 1918, the year of the Spanish flu pandemic.

The Census Bureau conducts various surveys, estimates, and counts that yield different results. The data comes from the Population Estimates Program, which annually estimates population on July 1. It is based on the 2010 census.

National population growth is calculated by combining natural population change and immigration.

Natural population change is the number of births less the number of deaths. There were 3.7 million births in 2020, a decrease of 0.6% since 2019. The nation recorded 3.1 million deaths, an increase of 8%. (Estimates are based on July 1 populations, and excludes deaths that occurred in the second half of 2020.) As a result, natural population change led to a net increase of 677,000 people, dropping 27% from 2019 population growth and 54% from 2011.

Population growth from net international migration increased from 795,000 in 2011 to more than 1 million in 2016—then fell to a decade-low 477,000 in 2020.

Meanwhile, immigration accounted for an increasing share of total population growth. Immigrants contributed 35% of total population growth in 2011 and increased to a high of 46% growth in 2016. The percentage of immigrants of total population growth declined to 41% in 2020.

The Census data also shows national demographic changes, breaking down states into four regions: Northeast, Midwest, South, and West.

- Northeastern states lost citizens for the second consecutive year. The population decline in the Northeast almost doubled from 82,000 in 2019 to 153,000 in 2020. While the region gained 110,000 people from international migration and 52,000 from natural population growth, 315,000 moved to other regions. The greatest populations drops were in New York, New Jersey, and Connecticut.


- Midwestern states also lost citizens for the first time. The Midwest population dropped by 23,000 people in 2020 after gaining 77,000 in 2019. Illinois had the largest decline: 113,000 people left in 2020, more than the 23,000 people it gained through natural population growth and the 11,000 new immigrants.

- Meanwhile, people have moved to the West and the South. Florida, Texas, and Arizona have the greatest combined domestic migration and immigration gains.

A decade-high eight states and Puerto Rico experienced negative natural growth. West Virginia experienced more deaths than births every year for the entire decade. Maine experienced negative natural growth in all but one year since 2011. New Hampshire, Vermont, and Puerto Rico had negative natural growth starting in 2017. Florida, Pennsylvania, Alabama, and Rhode Island first experienced negative natural growth this past year.

## Texas had 157,000 more births than deaths in 2020.
