When DirecTV (a subsidiary of AT&T) cut a conservative news channel from its lineup, I called the company out for its censorship. Now, my colleagues and I are deeply concerned that the same censorious spirit has infected our financial system.

That's exactly what we're seeing at JPMorgan Chase. The nation's largest bank, Chase serves more than 60 million American households – including many people and businesses in Nebraska where I serve as state treasurer. But far too often, we've seen Chase betray the trust of its customers, shareholders, and fellow citizens by debanking clients in service of narrow ideological agendas.

That's why (with colleagues in 12 states, I am calling Chase to be accountable and transparent, and to treat all customers equally – regardless of their religious or political points of view.

Chase has a disturbing track record of debanking clients for biased or arbitrary reasons. Beyond its well-known vendettas against fossil fuel companies and firearm manufacturers, Chase is also conditioning its services on whether company employees agree with customers' political or religious activities.

In the past two years, Chase has denied payments or canceled accounts associated with people and organizations – such as former ambassador Sam Brownback, the Arkansas Family Council, Defense of Liberty and retired General Michael Flynn, Jr. – for holding mainstream American views.

In fact, a former Chase executive described the bank's practice of "red-dotting" – where Chase employees can flag customers for cancellation based on their perceived reputational or social risk. As we conveyed to Mr. Dimon, practices like "red-dotting" destroy trust between financial institutions and the customers they serve.

The bank's cancellation of the National Committee for Religious Freedom (NCRF), headed by former ambassador Brownback, is a chilling example of anti-religious bias. Without any warning or rationale, Chase suddenly closed NCRF's account last year.

After repeated attempts to get the bank to explain its actions, Chase informed NCRF that it would only consider reinstating the account if the nonprofit first agreed to provide detailed information about its top donors and planned political activities.

Asked why it was pushing for these invasive disclosures, Chase changed its explanation multiple times. Chase initially claimed that it asked NCRF for the disclosures due to concerns about money laundering and funding of terrorist groups. When pressed on this outlandish rationale, the bank cited a completely different set of guidelines – claiming that Sam Brownback was a "Politically Exposed Person." But the relevant guidelines specify that "Politically Exposed Persons" do not "include U.S. public officials."

Chase’s politically charged decision-making was entirely predictable. The bank received a rating of just 15 percent on the 2022 “Viewpoint Diversity Score Business Index” – the first comprehensive benchmark designed to measure corporate respect for free speech and religious freedom.

Among other red flags, the index identified at least one policy that allows Chase to mask political or religious discrimination against clients behind vague terms like “hate” or “intolerance.”

When powerful banks like Chase retain unbridled discretion to cancel accounts for arbitrary or biased reasons, it undermines the freedom of everyday Americans to participate in society and the marketplace without fear of discrimination based on their political or religious views.

Many states, including Nebraska, are invested in Chase and rely on it for financial services. As stewards of public dollars, we want to make sure Chase is focused on generating value for our pensions and state investments – not engaging in narrow political or social agendas that undermine trust in our financial system.

Chase needs to rebuild trust with its shareholders and clients, but that can’t happen without transparency. When it comes to a host of progressive priorities (including climate change and DEI), Chase prides itself on being transparent. The company publicly celebrates its 100 percent score of the far-left Corporate Equality Index, yet it refuses to proactively implement measures to guard against politicized debanking.

That’s why my colleagues and I are demanding that Chase be accountable and transparent with the everyday Americans who rely on its services. Chase can take an important step to restore trust by completing the questionnaire it received in connection with the Viewpoint Diversity Score Business Index, and by implementing recommended best practices to prevent internal political and anti-religious bias.

Freedom of speech doesn’t stop at the teller’s window. It’s time for powerful banks like Chase to show (and not merely tell) when it comes to respecting the freedom of all Americans to bank without fear of religious or political discrimination.

Nurses and other health care workers at MaineGeneral Health (one of Maine’s largest healthcare providers) were unceremoniously fired two years ago if they refused to take the experimental mRNA injections touted as Covid-19 preventatives.

Some of those workers were even slapped with misconduct charges for refusing to comply with the mandate, many were later denied unemployment benefits, and no requests for religious exemptions were honored.

Now, one of the nonprofit hospitals that left some employees jobless and without recourse to Maine’s unemployment insurance benefits is sending text messages to the same employees it cast aside practically begging them to come back to work.

“You were once a proud member of the MaineGeneral team. Would you consider rejoining us? We would be pleased to discuss options with you,” the MaineGeneral Health Recruitment team said in a text message to former registered nurse Terry Poland.

“As you know, nearly 2 years ago MaineGeneral had to comply with a state mandate for Covid-19 vaccination. We lost a number of great employees as a result, including you,” MaineGeneral said.

“MaineGeneral has eliminated the Covid-19 vaccination as an employment condition,” MaineGeneral said.

Poland (who lives in Augusta) had worked as a registered nurse for 33 years. Her career included employment with MaineGeneral, Central Maine Medical Center, Pen Bay Medical Center, and the Aroostook Medical Center.

She couldn’t believe that the hospital would contact her in such a manner after casting her life into chaos for nearly two years.

Poland said: “I was livid. Like, how dare you force me out of a career that I’ve dedicated my whole life to, taken away my livelihood, my ability to earn a good income, and now you think I’m gonna come grovel back to you? I don’t hardly think so. And that’s the attitude of most everybody that I’ve been in contact with since yesterday.”

A source told the Maine Wire that about 15 former MaineGeneral Health employees received similar text messages.

Poland refused to take the experimental Covid-19 shots after Governor Janet Mills Decreed on August 12, 2021 that healthcare workers would be forced to receive the shots by October 1, 2021 – as a condition of working in healthcare.

Poland was never opposed to vaccines generally speaking. Though she previous used a religious exemption to avoid taking an influenza shot, she willingly took the other vaccines required to work in healthcare prior to the Covid-19 pandemic, including immunizations for measles, mumps, rubella and hepatitis-B.

She said she was concerned about the novel nature of the mRNA technology, a form of gene therapy, which prior to Covid-19 had not been used in the standard schedule of immunizations.

Poland said: “I knew enough not to take it. I’ve been a nurse long enough to know I need to question what new products are. I’m not going to be the first one to jump on board of an experiment.”

When she discovered that fetal tissues are commonly used in the development and production of the drugs, that only strengthened her resolve as a Christian not to get the injections.

In previous years, Poland has said she was allowed an exemption from taking the influenza shot so long as she wore a mask during flu season. However, the hospital was unwilling to provide this accommodation for Covid-19.

As a result of her choice, Poland faced not only termination, but also an allegation of misconduct from her former employer.

When she applied for unemployment benefits, she was rejected because of the misconduct allegation.

When she appealed, she was turned away.

The Maine Department of Labor concluded that Poland’s refusal to get the injections was a violation that constituted a “culpable breach of obligations to the employer.”

As a result, Poland had to rely on her savings to get by in the middle of economically disastrous government lockdowns and soaring inflation.

Poland then sought help from the federal Equal Employment Opportunity Commission, claiming that she'd been discriminated against on the basis of her religious beliefs.

MaineGeneral Health, in responding to the commission, argued that allowing Poland religious accommodations would impose an "undue hardship" on the hospital. On that basis, the commission declined to take on her case.

The Maine Human Rights Commission also rejected her discrimination complaint.

In the years since Poland was fired, she estimates she's earned only \$12,000 and \$17,000 as a home healthcare worker, a position that hasn't provided similar benefits to the job she lost. As a registered nurse, Poland was making about \$75,000 per year.

She's still not willing to give MaineGeneral another shot.

Poland is not the only one whose career was derailed by Governor Mills' mandate policy.

Thousands of former healthcare workers in Maine are currently unemployed or working in other fields because they refused to comply with Governor Mills' order that they receive injections.

- Some refused because they were skeptical of all vaccines.
- Some refused because of religious beliefs concerning the ethical problems with vaccine research that uses fetal tissue.
- Others were fearful that the long-term consequences of the experimental products were unknown, unknowable, and potentially harmful.

But in every case, the substantial drop in employment in Maine's healthcare sector because of the mandate has severely exacerbated a workforce shortage that threatens to undermine healthcare quality in the state.

- Governor Mills' mandate was based on the theory that the pharmaceutical products being touted as "vaccines" or "immunizations" would prevent healthcare workers from contracting the virus or transmitting it to patients.
- It's now generally understood that the vaccine never inhibited transmission of the virus.

In 2012, Barack Obama famously made the cover of Newsweek magazine with the heading, “The First Gay President.” That headline, meant in jest, now seems more than a little prescient.

Much publicity has been given in recent weeks to Barack Obama’s very real homosexual fantasies. These were communicated in a letter to girlfriend Alex McNear in 1982, when Obama was in his early twenties. These comments were first included in the paperback version of David Garrow’s 2017 biography (“Rising Star”), and later amplified in Jack Cashill’s 2020 book (Unmasking Obama). But news of Obama’s gay ruminations is only now breaking through to mainstream media.

In one of his letters to girlfriend McNear, Obama wrote: “In regard to homosexuality . . . you see, I make love to men daily, but in the imagination. My mind is androgynous to a great extent and I hope to make it more so until I can think in terms of people, not women as opposed to men.”

Such homosexual fantasies are very unusual for straight men, but there is evidence to suggest that Obama is something other than straight. In fact, Obama had five known major relationships with gay or bisexual men early in his life before he wrote that letter.

1. Indonesian gay nanny “Evie”

Few Americans know that Barack Obama had a legally adopted stepsister named Holiyah Soetoro, called “Lia” (with whom he grew up with in Indonesia). Lia was adopted by Barack’s mother Ann Dunham and her husband Lolo Soetoro and lived with young Barry (later Barack) in their Jakarta home. Although Lia did not speak English, she did give a long interview in her native Indonesian language in 2010. It revealed what could easily be interpreted as shocking information about young Barry’s life as a child.

[The interview made comments that influenced people to draw speculative conclusions about the relationship young Barry and his male gay personal nanny named “Evie” – real name “Turdi.”]

2. Frank Marshall Davis

I covered Frank Marshall Davis extensively in my 2012 file “Dreams From My Real Father.” I made the case that not only did Frank Marshall Davis raise and mentor Obama in Hawaii from age nine, but that Davis was also in fact Obama’s biological father.

Frank Marshall Davis was a member of Communist Party USA and one of the original so-called “Black Bolsheviks” in Chicago.

Davis was bisexual. Marxism (which preached the breaking down of all societal norms) encouraged him to pursue that practice. He later wrote a book called “Sex Rebel Black” – in which he chronicled his sexual escapades with both men and women and revealed his fondness for adolescents of both sexes.

3. Professor Lawrence Goldyn

While at Occidental, Barack became close friends with openly gay assistant professor Lawrence Goldyn. Obama has described Goldyn as “my favorite professor” at college.

4. Sohale Siddiqi

Barack’s college roommate during his senior year at Columbia University was a gay Pakistani man named Sohale Siddiqi.

5. Bill Ayers

Larry Grathwohl, an FBI informant who penetrated the inner circle of the Weather Underground and lived with Ayers in the terror group’s safe house, told me that he witnessed Ayers experimenting with homosexuality as part of the group’s Marxist practice of breaking down norms.
