Abortion was once again the number-one cause of death globally in 2020, with a record 42.7 million unborn babies killed in the womb, according to data provided by Worldometer.

As of December 31, 2020, there were 42.7 million abortions performed in the course of the year, Worldometer revealed, while 8.2 million people died from cancer, 5 million from smoking, and 1.7 million of HIV/AIDS.

By comparison, worldwide deaths from the coronavirus in 2020 totaled 1.8 million, according to Johns Hopkins University.

Worldometer—voted one of the best free reference websites by the American Library Association (ALA)—keeps a running tally through the year of major world statistics, including population, births, deaths, automobiles produced, books published, and CO2 emissions.

It also registers the total number of abortions performed worldwide, based on the latest statistics on abortions published by the World Health Organization (WHO).

Globally, there were more deaths from abortion in 2020 than all deaths from cancer, malaria, HIV/AIDS, smoking, alcohol, and traffic accidents combined, according to Worldometer statistics.

The shocking number of deaths from abortion, in fact, has led certain observers to call abortion “the social justice cause of our time,” since the sheer magnitude of the problem completely overshadows other human rights issues.

The Vatican recently issued a statement explaining that it is “morally acceptable” for a person to receive a covid-19 vaccine that relied on the “cell lines from aborted fetuses” to produce. But the Vatican stressed that vaccination “must be voluntary,” not compulsory.

People who object to vaccines “produced with cell lines” from aborted babies must take other measures to protect themselves from becoming carriers of the virus, said the Congregation for the Doctrine of the Faith, the Vatican office that clarifies and enforces the Church’s moral teachings.

However, some Catholic bishops have stated it is immoral and not acceptable to use such vaccines because the recipient’s “body is benefitting from the ‘fruits’ (although steps removed through a series of chemical processes) of one of mankind’s greatest crimes,” abortion.

In its Dec. 17 “Note on the Morality of Using Some Anti-Covid-19 Vaccines,” the Congregation wrote that it “has received several requests for guidance regarding the use of vaccines against the SARS-CoV-2 virus that causes covid-19, which, in the course of research and production, employed cell lines drawn from tissue obtained from two abortions that occurred in the last century.”

The Vatican office then explains its understanding of evil, such as procured abortion, and the differing degrees of cooperation in evil.

“The fundamental reason for considering the use of these vaccines morally licit is that the kind of cooperation in evil (*passive material cooperation*) in the procured abortion from which these cell lines originate is, on the part of those making use of the resulting vaccines”—the person who receives the vaccination—“remote.”

“[A]ll vaccinations recognized as clinically safe and effective can be used in good conscience with the certain knowledge that the use of such vaccines does not constitute formal cooperation with the abortion from which the cells used in production of the vaccines derive,” said the Congregation.

“It should be emphasized, however, that the morally licit use of these types of vaccines . . . does not in itself constitute a legitimation, even indirect, of

the practice of abortion, and necessarily assumes the opposition to this practice by those who make use of these vaccines,” said the office.

“In fact, the licit use of such vaccines does not and should not in any way imply that there is a moral endorsement of the use of cell lines proceeding from aborted fetuses,” added the office.

The Vatican also said that pharmaceutical companies and government health agencies have an obligation to produce “ethically acceptable vaccines that do not create problems of conscience.”

As for whether people need to take the covid vaccine, the office stated that “vaccination is not, as a rule, a moral obligation and that, therefore, it must be voluntary.” However, the people who, “for reasons of conscience, refuse vaccines produced with cell lines from aborted fetuses, must do their utmost to avoid, by other prophylactic means and appropriate behavior, becoming vehicles for the transmission of the infectious agent.”

The Congregation’s “Note” was signed by Cardinal Luis F. Ladaria, who is the head of the Congregation for the Doctrine of the Faith, and by its

On Dec. 8, prior to the release of the Note, U.S. Bishop Joseph Strickland, head of the diocese of Tyler, Texas, issued a letter to his flock.

“Soon we will face the availability of vaccines which we hope will alleviate the painful consequences of covid-19 and its spread,” he wrote. “Along with other Christian leaders, I have stressed the importance of ensuring that vaccines respect the dignity of human life and do not use the remains of electively aborted children in any part of the process.”

“As your shepherd, I cannot in good conscience receive a vaccine that has been produced using an aborted child,” said the bishop. “There are ethical vaccines in development which are worth waiting for.”

“I urge you to reject any vaccine that uses the remains of aborted children in research, testing, development, or production,” he wrote.

On cardinal, two archbishops, and two bishops (including Strickland) released a report on Dec. 12 explaining why they object to the use of the covid-19 vaccines that were produced using the cell lines of aborted babies.

As published in LifeSiteNews.com, the clergymen state, “In the case of vaccines made from the cell lines of aborted human fetuses, we see a clear contradiction between the Catholic doctrine to categorically, and beyond the shadow of any doubt, reject abortion in all cases as a grave moral evil . . . To argue that such vaccines can be morally licit if there is no alternative is in itself contradictory and cannot be acceptable for Catholics.”

“The theological principle of *material cooperation*,” state the clerics, “can hardly be applied to the case of vaccines made from fetal cell lines, because those who knowingly and voluntarily receive such vaccines enter into a kind of concatenation, albeit very remote, with the process of the abortion industry.”

"The crime of abortion is so monstrous that any kind of concatenation with this crime, even a very remote one, is immoral and cannot be accepted under any circumstances by a Catholic once he has become fully aware of it," they wrote. "One who uses these vaccines must realize that his body is benefitting from the 'fruits' (although steps removed through a series of chemical processes) of one of mankind's greatest crimes."

The document was signed by Tomash Peta, Metropolitan archbishop of the archdiocese of Saint Mary in Astana; Jan Pawel Lenga, archbishop/bishop emeritus of Karaganda; Joseph E. Strickland, bishop of Tyler, Texas; and Athanasius Schneider, auxiliary bishop of the archdiocese of Saint Mary in Astana.

As various vaccines begin to be rolled out across the world, in apparent response to covid-19, questions remain about the development and safety of many of the vaccines.

LifeSiteNews has compiled this short guide to some of the most prominent vaccines being offered and/or developed, sourcing material from our own reports and LifeSite's dedicated page to covid-19 vaccines.

The summary examines the development and testing of the vaccines from many angles: in relation to abortion; concerns about the scientific structure and the health effects of the vaccine; as well as responses from bishops and pro-life activists to the vaccines. Five vaccines connected to abortion, and two seemingly without any connection to abortion, are examined.

Two helpful charts can also be found, detailing which vaccines use cell lines from aborted babies, and at what stage the cell lines are used.

Cardinal Raymond Burke, former Prefect of the Supreme Tribunal of the Apostolic Signatura, has previously spoken out against vaccines using aborted babies: "it must be clear that it is never morally justified to develop a vaccine through the use of the cell lines of aborted fetuses. The thought of the introduction of such a vaccine into one's body is rightly abhorrent."

Aside from any connection to abortion, LifeSiteNews notes the comments of a number of experts who state that there is no need for mass vaccinations in order to end the coronavirus crisis. Dr. Michael Yeadon, who "spent over 30 years leading new [allergy and respiratory] medicines research in some of the world's largest pharmaceutical companies," and retired from Pfizer with "the most senior research position in this field," wrote in October:

There is absolutely no need for vaccines to extinguish the pandemic. I've never heard such nonsense talked about vaccines. You do not vaccinate peo-

ple who aren't at risk from a disease. You also don't set about planning to vaccinate millions of fit and healthy people with a vaccine that hasn't been extensively tested on human subjects.

In an interview published this week Dr. Theresa Deisher (Ph.D. in Molecular and Cellular Physiology from Stamford University) stated "this virus to date has less than a 0.03% fatality rate and most of those people, I believe it's 92% or above, have other health problems; we're making a vaccine at warp speed for a virus that doesn't look like it's going to need a vaccine." In the same interview Deisher confirmed that in her opinion a rational person would be on solid ground to eschew any covid-19 vaccine.

Pfizer vaccine—connected to abortion

Abortion link: The Pfizer vaccine is not developed using cell lines from aborted babies, but, "[o]ne of the confirmatory lab tests on the vaccine did sadly involve an old foetal cell-line." The Children of God for Life organization notes that the Pfizer vaccine is tested using the HEK 293 cell line, which is derived from kidney tissue taken from a healthy baby who was aborted in the Netherlands in the 1970s.

Concerns about the structure of the vaccine: The Pfizer vaccine uses mRNA technology, a technology so novel that it has yet to be approved for use by the Food and Drug Administration (FDA). The method of inserting the mRNA into the patient's cells intact, Lipid Nanoparticles (LNP's), is not certified, as Moderna (which also uses mRNA) have stated that they cannot be sure their LNP's will not have adverse effects.

The vaccine also has to be kept at unprecedentedly cold temperatures, -70°C (-94°F)—nearly twice as cold as the North Pole's average temperature in the winter.

Safety concerns, side effects, and trial results: As mentioned, Pfizer's vaccine uses extremely novel technology, which has never before been approved.

Despite Pfizer's claims of 90% safety, reports swiftly emerged showing that vaccine trial volunteers experienced "severe" side effects. Participants suffered headaches, fevers, and hangover-like symptoms.

A U.K. government warning for the vaccine stated that the vaccine should not be used by pregnant or breast-feeding mothers and children, and added that it was unaware of what effect the vaccine would have on fertility. Women should avoid becoming pregnant for two months after the vaccine, according to the document.

Dr. Michael Yeadon, former Vice President of Pfizer, co-authored a letter to the European Medicine Agency, warning that the vaccine may prevent the safe development of placentas in pregnant women, resulting in "vaccinated women essentially becoming infertile."

Pfizer is also free from indemnity in the U.K. and in the U.S.

Children's Health Defense noted in an article that earlier this year "the U.S. quietly pushed through Federal regulations giving coronavirus vaccine makers full

immunity from liability.” (Vaccine manufacturers in the U.S. already cannot be sued if their products injure or kill people thanks to a little-known law from the 1980s.)

After the first day of Pfizer vaccines being administered in the U.K., two people had allergic reactions, prompting the warning that people with a history of strong allergic reactions should not take it.

The U.S. FDA has warned of many serious side effects from any covid vaccine, including heart attacks, strokes, and anaphylactic shock.

Moderna vaccine—connected to abortion

Abortion link: The Moderna vaccine is also heavily connected to abortion. Children of God for Life compiled research to show that Moderna “extensively” uses the “aborted fetal cell line HEK-293” in the “fundamental design of mRNA technology, their Spike protein and in the research, development, production and testing.” The proteins used in the vaccine itself and the mRNA “were built on technology that extensively used aborted fetal cells, rendering the vaccine absolutely immoral from start to finish.”

Concerns about the structure of the vaccine: The Moderna vaccine uses mRNA technology, a technology so novel that it has yet to be approved for use by the FDA. The method of inserting the mRNA into the patient’s cells intact, Lipid Nanoparticles (LNP’s), is not certified, and Moderna have stated that they cannot be sure their LNP’s will not have adverse effects.

Safety concerns, side effects, and trial results: Concerns remain about the structure of the vaccine, since it uses such novel technology.

Moderna has admitted that the vaccine will cause at least mild or moderate side effects. It also stopped the testing of its highest dose of vaccine, due to the number of reports of severe reactions.

Animal testing was skipped altogether. Twenty percent of people receiving the high dose in trials needed hospitalization; only 45 people were tested, and they were specifically chosen for being exceptionally healthy and fit.

A priest involved in the final phase of testing the vaccine, died unexpectedly in his home some weeks after his second jab, although it is unclear if his death was due to the vaccine.

The U.S. FDA has warned of many serious side effects from any covid vaccine, including heart attacks, strokes, and anaphylactic shock.

Father Robert Altier warned about the dangers of Moderna’s vaccine changing the RNA in one’s body, calling it “heinous” and “evil.” Bishop Strickland also warned people via Twitter against the Moderna vaccine, saying that it is not “morally produced,” urging people to reject it.

Oxford/AstraZeneca—connected to abortion

Abortion link: The Oxford/AstraZeneca vaccine has been developed from the cell lines of an aborted baby, the cell line HEK-293. It is also uses the fetal cell line in design and testing.

Structure of the vaccine: It uses viral vectors, which grow antigens to covid-19 in the persons cells. The viral vectors are made using fetal cell lines from aborted babies to grow these vectors.

Safety concerns, side effects, and trial results: The vaccine saw “adverse effects” in 60% of recipients in its early phase trial.

The vaccine trials were previously put on hold in September for several weeks due to a severe adverse reaction from a volunteer.

A volunteer in the vaccine trials in Brazil died in October: reports are conflicting as to whether he died due to complications from the vaccine.

The U.S. FDA has warned of many serious side effects from any covid vaccine, including heart attacks, strokes, and anaphylactic shock.

Johnson and Johnson/Janssen—connected to abortion

Abortion link: J&J uses the fetal cell line PER.C6 in the design, development, and testing of the vaccine. The PER.C6 fetal cell line was derived from retinal tissue taken from an 18-week-old baby boy who was aborted in the Netherlands in 1985 and later converted into a fetal cell line in 1995. The cell line is owned by Janssen.

Structure of the vaccine: The J&J vaccine uses an adenoviral vector, a “genetically modified virus that leads the body to produce a protein to which the immune system then reacts.”

Safety concerns, side effects, and trial results: Trials for the vaccine were placed on hold after a participant developed a mystery illness. The number of participants in the trial has now been dropped from 60,000 to 40,000.

The company is in phase 3 of trials and aims to file for approval for the vaccine in February.

Children of God for Life notes that there are also considerable health risks contained in the fetal cell line.

As with other vaccines, the U.S. FDA has warned of many serious side effects from any covid vaccine, including heart attacks, strokes, and anaphylactic shock.

Sanofi Pasteur & Translate Bio—connected to abortion

Abortion link: Recent research by the Charlotte Lozier Institute has shown that the mRNA vaccine, made in a partnership with Sanofi and Translate Bio, was tested on aborted fetal cell line HEK-293.

Structure of the vaccine: The vaccine uses mRNA technology, in the style of both Pfizer and Moderna. Moderna warned that they cannot be sure their LNPs will not have adverse effects.

Safety concerns, side effects, and trial results: The joint vaccine has currently finished pre-clinical studies, which are reportedly favorable. Further stages of testing have yet to be conducted.

Sanofi Pasteur & GSK—seemingly free from abortion connection

Abortion link: Unlike the mRNA vaccine developed by Sanofi, it seems that the DNA based vaccine is produced without a link to abortion so far.

Structure of the vaccine: The DNA vaccine is made using DNA of the baculovirus expression platform, with Sanofi cultivating and developing the vaccine using the Sf9 cell line from the fall armyworm.

Safety concerns, side effects and trial results: The vaccine is not yet at phase 3 of its trials and results have not been sufficient, meaning that the vaccine will likely not be ready until late 2021.

A conflict of interest could well exist with Sir Patrick Vallance, chief scientific advisor to the U.K. government. GSK has been contracted by the U.K. to make covid-19 vaccines, but Vallance is the former president of the company and has shares in it worth £600,000.

In a July debate Robert F. Kennedy, Jr., nephew of former U.S. president John F. Kennedy and an American environmental attorney and author, highlighted both Sanofi and GSK as being among several vaccine producers with a record of incurring criminal penalties for their products.

Kennedy noted that four of the leading developers of coronavirus vaccines, Glaxo, Sanofi, Pfizer, Merck, are “convicted serial felon[s].”

“In the past 10 years, just in the last decade, those companies have paid 35 billion dollars in criminal penalties, damages, fines, for lying to doctors, for defrauding science, for falsifying science, for killing hundreds of thousands of Americans knowingly,” Kennedy said during the debate.

“It requires a cognitive dissonance for people who understand the criminal corporate cultures of these four companies to believe that they’re doing this in every other product that they have, but they’re not doing it with vaccines.”

Novavax—connected to abortion

Abortion link: The Novavax vaccine is linked to abortion through some of its testing being connected to HEK 293 cells.

Structure of the vaccine: It is made using an invertebrate cell line Sf9 to produce protein nanoparticle antigens that make its vaccine work.

Safety concerns, side effects and trial results: Unlike many of the other vaccines, Novavax has conducted animal studies, which reportedly demonstrated an effective combatting of covid-19.

The vaccine is currently in phase 3 trials, and results are expected in early this year.

The prospects for drama were hanging thick in the cold Washington air Wednesday morning, as a large crowd gathered to show solidarity with President Trump and those members of the House and Senate who were preparing to object to the acceptance of electoral votes in an election they viewed as illegitimate.

As rare as the circumstances were, an air of predictability had set in. Trump would fire up the crowd, which would then march to the Capitol. Inside, both chambers would hear the objections, which would prevail in neither chamber. The election of Joe Biden would be settled, however controversially, but at least there would

have been a final therapeutic moment for the Republicans with constitutional and procedural concerns, and the millions of Americans who agree with them.

That's the way it was supposed to go.

But as the House and Senate weighed the first protested state, a portion of the approaching crowd went rogue, peeling away from what would have otherwise been an inspiring portrait of Americans gathered at an iconic site to make a stand. From civil rights protests to anti-nuclear rallies to pro-life marches, large crowds have been a familiar sight in Washington whenever there is a grand political point to be made. The point of this day was that laws had been so wantonly disregarded in various states that the result was improperly found.

The merits of that argument, and the landscape for debating it in the House and Senate chambers soon evaporated in a cascade of broken glass and stampeding intruders. An overwhelmed law enforcement contingent was quickly outmaneuvered as elected representatives dove into the seats while insurgents took up positions from the Senate podium to Nancy Pelosi's office chair. A woman climbing through a window was shot and later died.

The waning days of the Trump administration will now be forever stained by the misdeeds of supporters for whom the constitutional challenge was not enough. "This is the people's house!" proclaimed some, as if their indignation entitled them to wander its halls at will.

There are too many catastrophes to address as a result. Foremost, the very image of our Capitol overrun by violent insurgents is something we should have been able to safely say we would never see. A worthy protest process that struggled for validity against hostile opponents was dashed against the rocks, never again to see the light of day. And a political and media culture that had yawned as America's cities burned was gifted with plentiful fuel to ignite a suddenly aggrieved blame game that extended far beyond the offenders, to the entire crowd, to the representatives who challenged the election, to the President himself.

Never let a good riot go to waste, one could say.

To be clear: this was a riot. It was domestic terrorism. And it was met with instant condemnation from conservatives at every level. But as the news coverage dragged toward evening and the crowds dispersed, TV analysis made clear that was not enough. The media narrative was gorged with the charge that Trump's sharp words at the White House were a directive to storm the halls of the Capitol. There would be no rest until segment guests could be badgered into blaming Trump for the actions of his most unhinged supporters.

But scapegoating is not the most pressing matter of this moment. Two moral imperatives are staring us down.

- The essential process toward consequences for those who have defiled the corridors of our democracy.
- And the necessity of addressing the provocation that inflamed them in the first place.

The indefensible behavior of the rioters does not erase the righteous grievance of millions of Americans who have lost faith in an election system cast to the winds of political opportunism. Democrats launched an end run around state legislatures, the only proper setting for changes in election law. The misadventures of governors, state courts and secretaries of state constituted a wholly improper basis for election procedures in enough states to call the electoral total into question.

President Trump is entitled to his anger. His voters are entitled to theirs. Members of the House and Senate are entitled to their constitutionally established avenues of objection.

But no one gets to do what happened Wednesday. And no one should defend it or even attempt to excuse it under some guise of "Hey, this is what you get when people get really mad," which was sadly the thrust of a Trump tweet as evening fell.

As the sun rises on the day after, we are left to weigh many lessons. Some will involve the unpreparedness and actions of a law enforcement contingent that was overcome with shocking ease. Some will involve the political cost to an administration that had much to boast about, whose achievements are at least for now shrouded by mob violence.

But the most important lessons will feature our ability to address our national crises with honesty, goodwill and good faith. After the tear gas smoke clears, we still have an election held in contempt by millions. We have rioters to punish, but we still have a system to fix.

We're beginning to learn more about the individuals who were inside the U.S. Capitol on Wednesday.

A young man named John Sullivan was there. He's from Utah and the founder of "Insurgence USA," which is a group dedicated to "racial justice and police reform." According to numerous news reports, he has a history of organizing leftist protests and identifies with Black Lives Matter.

Over the summer, Sullivan was arrested after organizing a violent riot in Utah that ended with a shooting. One of the host groups was the Salt Lake Antifascist [Antifa] Coalition.

From Deseret News: "One of the organizers of a protest in Provo that resulted in a motorist being shot was arrested on Thursday. John Earle Sullivan, 25, of Sandy, was booked into the Utah County Jail for investigation of rioting, making a threat of violence and criminal mischief. Another group planned a counterprotest at the same time and place. On Facebook, its event page

was originally titled End Police Brutality but was later changed to Marching for Racial Equality. The Facebook pages listed the event's hosts as the groups Insurgence, Solidarity for Justice, Salt Lake Equal Rights Movement and the Salt Lake Antifascist Coalition. 'As a protest organizer John Sullivan is heard and seen as he is promoting protesters to block roadways, keeping motorists from traveling lawfully and freely.' Sullivan was also captured on video threatening to beat a woman in an SUV, according to the affidavit, and then kicking her door, leaving a dent. Sullivan was seen with Jesse Taggart—the man charged with shooting the motorist—throughout the protest, the affidavit states. 'As a protest organizer, John Sullivan is heard talking about seeing the shooting, looking at the gun and seeing smoke coming from it. John did not condemn the attempted murder nor attempt to stop it nor aide in its investigation by police. At the U.S. Capitol, Sullivan was standing next to Trump supporter Ashli Babbitt when she was shot and killed by a police officer. In fact, he filmed it.

On two of his Twitter feeds, you'll find retweets of footage from Black Lives Matter riots. His profile photo advertises a planned anti-Trump rally on January 6. His Instagram page, where additional footage of previous riots and protests was posted, is no longer available. He also retweeted an Antifa page.

Wednesday afternoon, angry, unarmed, mostly peaceful protesters stormed the Capitol. They caused hundreds of dollars in damages to "The People's House," the taxpayer-funded building where elected lawmakers work.

They took pictures seated at Nancy Pelosi's desk. They shoved furniture out of place. They pushed their way past unprepared and overwhelmed law enforcement. They shattered a window or two.

If not for police shooting and killing an unarmed, female 14-year Air Force veteran, the protest staged by Trump supporters would have more in common with a 1950s fraternity panty raid than political riot.

Here, I guess, I should apologize for not joining the rest of the media in feigning outrage and calling for the trespassers to be tried for treason. But I'm neither outraged nor feeling vengeful because of their act of civil disobedience.

I understand it. It was an inevitable repercussion from 2020 and what we've all witnessed the last decade. It was Sir Isaac Newton's third law come to life.

"For every action, there is an equal and opposite reaction."

For four years now, the billionaire and millionaire elites who control academia, the mainstream media, politics, popular culture, and the sports world have framed Trump supporters as racist deplorables worthy of elimination from society.

These same elites spent the past decade elevating Michael Brown, George Floyd, Jacob Blake, Rayshard Brooks, Eric Garner, and other resisting criminal suspects to icon status while simultaneously raising bail money for protesters willing to riot, loot, burn, and vandalize in the name of racial justice.

This blatant hypocrisy will not go unchallenged. You cannot ignore the desires, concerns and feelings of 74 million citizens. You cannot write them off as Nazis and answer all their complaints with allegations of racism or sexism. That's fascism.

The critics say President Trump provoked Wednesday's political "violence." His refusal to concede a corrupt election baited his followers to overrun the Capitol with flags, put Ashli Babbitt in harm's way, and do enough property damage to delay the Electoral College confirmation three or four hours.

Fine. Guilty as charged.

But our president for the next two weeks was not Lee Harvey Oswald, a lone provocateur. He had plenty of collaborators. They work on all the major and cable news and sports networks. They play in the NFL and NBA. They represent both political parties, hold high positions in Hollywood, at Netflix, Google, Facebook, Twitter, and Instagram.

Ashli Babbitt's blood is on the hands of Jack Dorsey and Mark Zuckerberg as much as, if not more than, on President Trump's. That's why Dorsey and Zuckerberg rushed to silence Trump on their respective platforms, Twitter and Facebook.

Political tension and violence are fomented, planned, and monetized on Silicon Valley's social media platforms. Wednesday's "violence" hit the wrong target. The Capitol is where global elites exchange cash for influence and privilege. It's where \$150,000-a-year politicians become multimillionaires building cozy relationships with Big Tech lobbyists and American corporations looking to curry favor with China.

The Capitol is sacred ground for elites. The way you might revere a church edifice is the way millionaires and billionaires revere the Capitol.

The NBA multimillionaires said they played with "heavy hearts" Wednesday night after seeing the Capitol desecrated. They made twisted, illogical analogies between nonviolent civil disobedience and the rioting, looting, and violence that occurred in Minneapolis, Atlanta, Kenosha, and across this country all summer.

"It reminds me of what Dr. Martin Luther King has said, that there's two split different Americas," Boston Celtics star Jaylen Brown told reporters. "In one America, you get killed by sleeping in your car, selling cigarettes or playing in your backyard. And then in another America, you get to storm the Capitol and no tear gas, no massive arrests, none of that."

Brown is right. There are two different American realities. There's the false reality world created by and for elites and their groupies. In this world, progressive elites feign concern for poor black people by championing the cause of a tiny handful of black resisting criminal suspects harmed by white police officers tasked with subduing them. The elites have no interest in the thousands of black men and boys killed annually due to random gang, street, and drug violence. Those black lives do not matter. Progressive elites live inside a social media matrix where they call the Crips and the Bloods to protect them from the police.

The rest of America lives in an alternate universe driven, at least partially, by reality, facts, and common sense. We don't see the norms of Western Civilization as the root of all evil. We have no interest in disrupting the nuclear family. We don't think the storming of the Capitol is analogous to the months of looting, arson, shooting, rioting, and anarchy we watched throughout 2020.

Philadelphia 76ers coach Doc Rivers, a man I greatly respect, lives in a different reality than I do. His interpretation of Wednesday's chaos baffles me.

"No police dogs turned on people, no billy clubs hitting people. People peacefully being escorted out of the Capitol," Rivers told reporters Wednesday. "So it shows you can peacefully disperse a crowd. It basically proves a point about a privileged life in a lot of ways. I will say it, because I don't think a lot of people want to: Can you imagine [Wednesday], if those were all black people storming the Capitol, and what would have happened? That, to me, is a picture worth a thousand words for all of us to see, and probably something for us to reckon with again."

What is he talking about? We've watched buildings burned to the ground this summer. We've seen "protesters" prowling the streets of Atlanta with semi-automatic weapons. We've seen protesters berate and spit on police officers. David Dorn, a 77-year-old, black retired cop, was assassinated. Parts of Portland have been under attack from Antifa and Black Lives Matter for months.

There have been no dogs, no billy clubs.

We don't have to imagine how law enforcement would react to black, lawless protesters. It has aired on CNN, MSNBC, and FOX News all summer. The police have been remarkably restrained.

The media, athletes, and celebrities have treated black protesters as heroes. Politicians have taken knees and worn kente cloth to show allegiance with black protesters. Every national sportscaster and head coach has gone along with the facade that police pose a greater threat to black men than black men. We're inundated with television commercials promoting Black Lives Matter. The NFL has celebrated criminals involved in drive-by shootings. A laundry list of media personalities have taken turns rationalizing every vio-

lent, lawless action taken by Antifa or Black Lives Matter. No one cares that George Floyd stuck a gun in a pregnant black woman's belly or that Jacob Blake sexually assaulted a black woman. The New York Times commissioned a group of black female reporters to rewrite American history to fit the narrative of the critical race theory taught at our academic institutions.

The concerns propagandized by the ministers of black victimhood are a high priority in American society. Sinners are excommunicated from their employment. There is so much money, fame, and adulation from joining the Church of Black Victimization that white people such as Shaun King and Rachel Dolezal have disavowed their natural heritage to identify as black.

A Trump supporter? He or she is an American pariah. A racist. A coon. An idiot. A sellout. Someone to be silenced or ignored.

Trump supporters will not go away quietly or peacefully. It's their country, too. Their concerns are legitimate. The lawmakers they chased to the basement of the Capitol sold out the American working-class man and woman.

They sold out my mom and dad and the way of life that allowed me to rise from poverty to a life of comfort and privilege. My dad was a small businessman in Indianapolis who owned a tavern that catered to hourly, union factory workers. My mother was a factory worker in Indianapolis and Kansas City.

The black people I grew up with, the ones who frequented the Masterpiece Lounge and went on bowling trips with my mom, were not global citizens. They were hardworking high school graduates who wanted their kids to move up the economic and social ladder.

They had a lot in common with Trump supporters. We can't see that common ground now because the mainstream media and social media have us so irrationally polarized that we think skin color explains everything.

Skin color does not explain the Trump phenomenon, the passion of his followers. Trumpism is rooted in a rejection of the elitism, idolatry, and secularism pervasive in modern American culture.

In September 1620—four hundred years ago—102 passengers boarded the Mayflower, fleeing southern England and the elitist society constructed there. They were the original Trumpers, the dregs of European society in search of freedom of religion and expression.

Trumpism is the cry of American citizens uninterested in adopting the cultures and customs of France, China, Italy, Cuba, Venezuela, Canada, or any of the other places global elites romanticize. Trumpism is the cry of the working class who believe the Big Tech billionaires are building an America that cuts them out of the American Dream. Trumpism is the cry of Americans who value authenticity over the fraudulence of political correctness.

The price of ignoring their cries will be war, a civil war.

Democrats and their allies in the media are ready to condemn riots now that the turmoil has shifted to fit their narrative.

On Wednesday, a mob of Trump supporters stormed the U.S. Capitol building. It was an astonishing display of anarchic protest that delayed congressional certification of the Electoral College vote formally handing former Vice President Joe Biden the keys to the White House.

The scenes from the dark day of disaster demonstrations illustrated a deteriorating country, repulsed millions, and traumatized a nation still recovering from the death, despair, and disruption that came to define the dystopian months of 2020. In August, Senator Kamala Harris spoke to former comedian Stephen Colbert about the riots that rocked the country throughout the summer. Harris gleefully said that “they’re not gonna stop,” come the election. “This is a movement, I’m telling you,” she said.

This is the Democrat nominee for VP instigating violent riots that have left multiple Americans dead: “Everyone beware. They’re not gonna stop before election day in November, and they’re not gonna stop after election day . . . They’re not gonna let up and they should not.”

Colbert noted that media just wasn’t covering these riots by the end of August for some reason, and Harris seemed to think this was a problem.

“I know that there are protests still happening in major cities across the United States, I’m just not seeing the reporting on it that I had for the first few weeks,” Colbert said.

Harris nodded, “Right, that’s right,” she said. “But they’re not gonna stop. They’re not gonna stop. This is a movement, I’m telling you. They’re not gonna stop. And everyone beware, because they’re not gonna stop.

“They’re not gonna stop before election day in November, and they’re not gonna stop after election day. And that should be—everyone should take note of that, on both levels.

“They’re not gonna let up,” Harris said with pride, “and they should not. And we should not.”

The August 30 interview came after 30 people were killed in the intensive rioting from May through August, and billions of dollars in property damage was reported.

While mainstream media repeatedly called on President Trump to condemn white supremacy, which he did dozens of times, they allowed Democrat politicians like Harris, Portland Mayor Ted Wheeler, and so many others to not only condone but advocate for violence and destruction in American cities.

Media gave a platform to politicians and activists who championed the protestors. Cadres of medical experts claimed that those who acted out against perceived injustices were justified in breaking covid-inspired lockdown orders, while telling those Americans who would rather just have their normal lives back to stay inside.

As my listeners and readers can hopefully attest, I have been on a lifelong quest to understand human nature and human behavior. I am sad to report that I have learned more in the last few years, particularly in 2020, than in any equivalent period of time.

One of the biggest revelations concerns a question that has always plagued me: How does one explain the "good German," the term used to describe the average, presumably decent German, who did nothing to hurt Jews but also did nothing to help them and did nothing to undermine the Nazi regime? The same question could be asked about the average Frenchman during the Vichy era, the average Russian under Lenin, Joseph Stalin, Leonid Brezhnev and their successors, and the millions of others who did nothing to help their fellow citizens under oppressive dictatorships.

These past few years have taught me not to so quickly judge the quiet German, Russian, etc. Of course, I still judge Germans who helped the Nazis and Germans who in any way hurt Jews. But the Germans who did nothing? Not so fast.

What has changed my thinking has been watching what is happening in America (and Canada and Australia and elsewhere, for that matter).

The ease with which tens of millions of Americans have accepted irrational, unconstitutional and unprecedented police state-type restrictions on their freedoms, including even the freedom to make a living, has been, to understate the case, sobering.

The same holds true for the acceptance by most Americans of the rampant censorship on Twitter and all other major social media platforms. Even physicians and other scientists are deprived of freedom of speech if, for example, they offer scientific support for hydroxychloroquine along with zinc to treat covid-19 in the

early stages. Board-certified physician Dr. Vladimir Zelenko, who has saved hundreds of covid-19 patients from suffering and/or death, has been banned from Twitter for publicizing his lifesaving hydroxychloroquine and zinc protocol.

Half of America, the non-left half, is afraid to speak their minds at virtually every university, movie studio and large corporation—indeed, at virtually every place of work. Professors who say anything that offends the left fear being ostracized if they have tenure and being fired if they do not. People are socially ostracized, publicly shamed and/or fired for differing with Black Lives Matter, as America-hating and white-hating a group as has ever existed. And few Americans speak up. On the contrary, when BLM protestors demand that diners outside of restaurants raise their fists to show their support of BLM, nearly every diner does.

So, then, who are we to condemn the average German who faced the Gestapo if he didn't salute Hitler or the average Russian who faced the NKVD (the secret police and intelligence agency that preceded the KGB) if he didn't demonstrate sufficient enthusiasm for Stalin? Americans face the left's cancel culture, but not left-wing secret police or reeducation camps. (At least not yet—I have little doubt the left would send outspoken conservatives to reeducation camps if they could.)

I have come to understand the average German living under Nazism and the average Russian living under communism for another reason: the power of the media to brainwash.

As a student of totalitarianism since my graduate studies at the Russian Institute of Columbia University's School of International Affairs (as it was then known), I have always believed that only in a dictatorship could a society be brainwashed. I was wrong. I now understand that mass brainwashing can take place in a nominally free society. The incessant left-wing drumbeat of The New York Times, The Washington Post, the Los Angeles Times and almost every other major newspaper, plus The Atlantic, The New Yorker, CNN, ABC, CBS, NBC, PBS, NPR, all of Hollywood and almost every school from kindergarten through graduate school, has brainwashed at least half of America every bit as effectively as the German, Soviet and Chinese communist press did (and in the latter case, still does). That thousands of schools will teach the lie that is the New York Times' "1619 Project" is one of countless examples.

Prior to the lockdowns, I flew almost every week of the year, so I was approached by people who recognized me on a regular basis. Increasingly, I noticed that people would look around to see if anyone was within earshot and then tell me in almost a whisper: "I support Trump" or "I'm a conservative." The last time people looked around and whispered things to me was when I used to visit the Soviet Union.

In Quebec this past weekend, as one can see on a viral video, a family was fined and members arrested because six—yes, six—people gathered to celebrate the new year. A neighbor snitched on them, and the celebrants were duly arrested. The Quebec government lauded the snitches and asked for more public "collaboration."

Snitches are likewise lauded and encouraged in some Democrat-run states and cities in America (Los Angeles Mayor Eric Garcetti in March: "Snitches get rewards") and by left-wing governments in Australia. Plenty of Americans,

Canadians and Australians are only too happy to snitch on people who refuse to lock down their lives.

All this is taking place without concentration camps, without a Gestapo, without a KGB and without Maoist reeducation camps.

That's why I no longer judge the average German as easily as I used to. Apathy in the face of tyranny turns out not to be a German or Russian characteristic. I just never thought it could happen in America.

Where would you rather live, Florida or New York? It's a simple question with a basic, easy answer: Florida. But liberal elites hate the Sunshine State and love the Empire State, so the pictures being painted in the media of the two states are unrecognizable.

Florida has about 2 million more people than New York, 21.5 million to 19.5 million, yet it has no state income tax. New York's tax rate ranges from 4 percent to 8.82 percent, New York City has its own tax rate ranging from 3.078 percent to 3.876 percent. Someone making a good living in New York City is forced to cough up almost 12.7 percent of their income to local governments, in addition to what they have to send the federal government. Why would anyone voluntarily do that?

It's hard to feel badly for them, they elect Democrats, so it's a little like feeling badly for someone complaining of a headache while they bang their head against a wall. They bought the ticket, they have to take the ride.

Still, it's not just taxes, or even crime, it's quality of life and life itself.

New York has been a disaster when it comes to the covid pandemic. Governor Andrew Cuomo has overseen more deaths than most countries, and is directly responsible for most of them. His order that nursing homes had to take in covid positive patients was not only deadly, it was unnecessary.

Meanwhile, down in Florida, Governor Ron DeSantis did not lock down his state, did not order sick seniors into nursing homes, and was demonized by the press. With slightly more than half the deaths of New York, DeSantis is somehow still the problem.

CNN, which slobbers over Cuomo, routinely smears DeSantis, who has no family members on the media's payroll. New York's economy is crippled, New York City will be a ghost town now that companies realize they can be just as productive without the massive expense of renting office space, and there isn't an easy way to make up for that.
