As the world prepares for the departure of an especially tumultuous year in global politics, some of the world’s most influential countries are preparing for elections that may dramatically shift domestic politics and foreign policy, depending on how voters swing.

Presidential elections often result in dramatic changes in the countries holding them, even when allies of the incumbent take over or the incumbent is reelected in countries whose constitutions allow for it. This year, however, a combination of local issues and the ongoing political fallout from the handling of the Chinese coronavirus pandemic have given rise to candidates vowing dramatic changes in the status quo. Below, five countries electing a president in 2022, their first chances to replace their heads of state since the pandemic began.

### **Brazil**

South America’s two most populous countries are facing elections in the coming year and in both, voters will evaluate the record of incumbent conservative presidents. Brazil’s President Jair Bolsonaro won his position in a dramatic election that required him to continue campaigning after being almost

stabbed to death on video during a campaign stop by a socialist, who later told police God had commanded him to kill the candidate. Bolsonaro won the presidency with a campaign vowing to eradicate corruption, uphold Christian values, and eradicate the far-left Workers' Party (PT), whose two presidents had ended their runs in disgrace: one in prison and one impeached.

Many observers at the time attributed Bolsonaro's win partly to the fact that the jailed president, Luiz Inácio Lula da Silva, could not make a bid to return to power thanks to Brazil's "clean slate" law, which keeps politicians off the ballot if they are convicted of corruption crimes. Lula was convicted of using millions in illicit funds to, among other things, purchase a luxury beachfront property. His arrest was part of "Operation Car Wash," a sprawling corruption probe that found Lula's administration had facilitated the use of government contracts for infrastructure projects to loot public coffers. The government would grant a contract to a company—often the disgraced contractor Odebrecht, behind similar corruption schemes throughout the continent—at an inflated price, then the company would kick back to politicians the extra money they did not need to complete the project.

By the end of 2021, much of the anger over the Operation Car Wash scandal had subsided, in part because Judge Sergio Moro, who presided over the investigation, had imprisoned dozens of politicians over the matter. Moro remains a popular figure, but has since accused Bolsonaro of failing to empower him to fight corruption during his short stint as Justice Minister, tarnishing Bolsonaro. What's more, the Supreme Court—packed with Lula appointees—overturned Lula's conviction in March, making the far-leftist an automatic frontrunner in 2022.

Complicating matters is the Chinese coronavirus pandemic. Bolsonaro has steadfastly rejected lockdowns and vaccine mandates, a popular position, but has vacillated on his opposition to questionable Chinese-made vaccines and constitutionally has little power to stop leftist governors from implementing lockdowns in their states. Prior to Lula's restored ability to run, political observers considered the governor of Sao Paulo, Joao Doria, a prime candidate to challenge Bolsonaro. Doria supports vaccine mandates and implemented sweeping lockdowns, making him popular with the international left.

Doria's Brazilian Social Democracy Party (PSDB) has already chosen him as their presidential candidate. It remains to be seen if Lula officially runs, splitting the leftist vote and boosting Bolsonaro. Also possible: a Moro 2022 run, which would attract votes from nearly every part of the political spectrum, but possibly not enough to actually win.

## **Colombia**

Colombia's presidential election will feature as many familiar faces as Brazil's, but no incumbents. Colombian presidents are only allowed one four-year term, meaning conservative, pro-China President Iván Duque will cast a shadow but not directly participate in the race. The two major issues expected to be at the forefront of voters' minds are the Chinese coronavirus pandemic and ongoing left-wing terrorism that worsened after the passage of a "peace deal" with the Revolutionary Armed Forces of Colombia (FARC).

Colombia currently has 11 candidates officially on the ballot. The candidate supported by Duque's Democratic Center, Óscar Iván Zuluaga, is a veteran presidential candidate who lost against Duque's predecessor, Juan Manuel Santos, and has currently failed to gather any steam. Most observers currently consider another presidential election loser, Gustavo Petro, the former mayor of Bogotá who lost to Duque, the frontrunner, given the enthusiasm on the left for his candidacy. A far-left socialist, Petro once belonged to a leftist terrorist guerrilla and supported Venezuelan dictator Hugo Chávez before rebranding himself as an economist.

Another candidate attracting attention—more so than Zuluaga—is Alejandro Gaviria. Perhaps reflecting the fact that Colombia has experienced one of the most severe outbreaks of Chinese coronavirus in the world, Gaviria was once Duque's health secretary and is running as a no-nonsense "centrist" that could save the country from both Petro's socialism and the alleged hardcore conservatism of the Democratic Center. To emphasize the point, Gaviria is representing a coalition called the "Hope Center."

## Philippines

Like Colombia, the Philippines allows presidents to serve only one term. Rather than prompt a wave of fresh faces to compete for the presidency, however, this law has resulted in Rodrigo Duterte's messy fingerprints appearing on nearly every single candidate and Duterte himself threatening to appear as a vice-presidential candidate. Among the first candidates to announce they would run is longtime Duterte supporter and legendary boxing champion Manny Pacquiao. Duterte refused to support Pacquiao despite the latter's backing obviously helping Duterte's race, instead starting a bizarre feud by calling Pacquiao "a s\*\*\*\*" and "too old"; Pacquiao had accused Duterte staffers, but not the president himself, of corruption.

Rumors swirled for months that Davao City Mayor Sara Duterte, the president's daughter, would run for the top office. One of his top staffers, now-Senator Christopher "Bong" Go, also announced a run for president. Go dropped out quickly from the race, however, and the chaos surrounding the Duterte administration drama paved the way for a new frontrunner: Ferdinand Marcos, Jr. The younger Duterte opted not to run for president, but is on Marcos' ticket, attracting the popular president's supporters and establishing a clear lead against the Pacquiao team at press time.

Vice President Leni Robredo, who has often clashed with Rodrigo Duterte, is also in the running, but the spectacle surrounding the other candidates has largely kept the spotlight away from her.

A poll published Sunday by OCTA Research found Marcos and Duterte with 54-percent support and Robredo at a distant second with 14 percent. Pacquiao clocked in at ten percent.

## South Korea

South Koreans have been stuck for five years with a president far to the left of the general public—Moon Jae-in—as a result of a catastrophic collapse in sup-

port for the now-defunct Liberty Korea Party under his predecessor Park Geun-hye. Park was impeached and arrested for allegedly allowing a senior member of a cult to view and edit sensitive national security documents, a bizarre scandal that overshadowed any policy debates in the country at the time.

Moon's Democratic Party has suffered its fair share of scandals, most prominently a string of sexual assault allegations against key members that ended with the former mayor of Seoul, Park Won-soon, dead of an apparent suicide. Prior to his death in April, political observers considered Park a presidential frontrunner.

Liberty Korea has since rebranded itself as the People Power Party and recruited from Moon's administration. Former prosecutor general Yoon Seok-youl won the party's primary after defecting from the administration that hired him in a situation similar to Bolsonaro's relationship with Sergio Moro—Moon vowed to appoint a tough-on-corruption top prosecutor who then publicly complained that he found corruption in an inconvenient place for the president. Comically, opposition members of the party whose presidential primary Yoon just won complained at the time that Yoon would be too loyal to Moon and thus could not be trusted to head the prosecutor's office.

Yoon is running against hand-picked Moon successor Lee Jae-Myung, the former governor of Gyeonggi Province. Lee won an aggressive primary that left him somewhat battered in the polls, hurt additionally by Yoon's campaigning against him, centered on accusations of corruption. Lee has also endured criticism for making comments excusing his nephew, whom he defended in court, for murdering his ex-girlfriend and her mother.

Yoon is currently leading Lee in the polls, but only by about one percentage point in a poll published by the firm Realmeter on Monday—a significant drop from prior polls that could partially be the result of Moon pardoning Park Geun-hye, and thus returning her unpopular name to the headlines.

## France

Current President Emmanuel Macron is facing a tough reelection campaign in France after five years defined by radical Islamic violence (including the beheading of a schoolteacher), street riots, the burning down of much of the Notre Dame Cathedral, and increasingly authoritarian coronavirus policy. Much of the election energy currently is on the right, thanks to writer Eric Zemmour throwing his hat in the ring this month, but Zemmour is attracting the same kind of voters as perennial candidate Marine Le Pen, meaning polls are showing a divided conservative poll and a potential Macron win. Zemmour is also attracting leftist violence: 39 Antifa terrorists were arrested at his first campaign rally and one successfully assaulted Zemmour himself, attempting to put him in a chokehold.

A mid-December poll by Sciences Po political research center CEVIPOF found Macron and centrist Sarkozy alum Valerie Pécresse earning the top two spots, suggesting the more headline-grabbing conservative candidates may not make it to a run-off vote.

Leftists in Congress are unable to move forward on their massive spending bill because of bipartisan opposition. Polling showed President Biden’s Big Government Socialism Bill was wildly unpopular with the American people. That is no surprise when you consider it did not address any of the significant issues facing American families today like sky-high gas prices, rising food costs, spikes in violent crime, and a shortage of products because of a failing supply chain.

So, what’s next for the radical progressives in Congress? That would be pushing another wildly unwanted, unnecessary, unpopular bill.

The Left now wants a complete federal takeover of our local elections. The U.S. Constitution gives state legislatures the right and responsibility to decide how they will conduct elections. After all, what works in Massachusetts, may not work in Montana, Mississippi, or Maine. However, the Left is fixated on trying to convince Americans to believe a more invasive federal government is somehow the answer to everything.

I will pose the question this way: Does it make sense to let the federal government run our state elections?

After all, this is the same incompetent federal government that botched the Afghanistan withdrawal, leaving thousands of Americans stranded. The Left gave this bill a disingenuous name on purpose—so that you may be fooled by what it truly does. It is called the “Freedom to Vote Act,” but when you look at what it actually does and does not do, it really should be called the “Freedom to Cheat Act.”

Here are a few reasons why.

- The Left’s Freedom to Cheat Act would ban the need for voter photo identification to cast a ballot—even though 85 percent of the American people support voter ID.
- The Left’s Freedom to Cheat Act would prohibit states from cleaning their voter rolls before an election—even though 88 percent of the American people support cleaning voter rolls which is key to fair and honest elections. Across America, there are almost 2 million dead people still on the voting rolls.

- The Left's Freedom to Cheat Act would extend the deadline to over 2 weeks after the Election—even though 82 percent of Americans support the commonsense reform that all ballots should be returned to election officials by Election Day.

Stripping away just these three provisions in our states would open our local elections to even more serious problems than we have ever faced.

Eligible and registered Americans should vote one time, their ballot should be counted only once, and that ballot should be protected from any possible tampering. The American people demand simple reforms like these at the state level, and they most certainly deserve it. One illegally cast ballot is one too many.

The Freedom to Cheat Act not only prevents states from implementing safeguards to protect voters, but it would also put federal laws on the books that leave us all exposed to fraud, abuse, and other illegalities.

Voter ID, cleaning the voter rolls, and returning ballots to election officials on Election Day are commonsense reforms that the American people support. Many of these measures are being introduced in state legislatures across the country and would help restore faith, trust, and confidence in our election system. The Freedom to Cheat Act is a federal government takeover of our elections, and the reform-killing measures in it would throw open the doors of our elections to allow even more cheating and more fraud.

As a former Secretary of State in Ohio, I know firsthand that the federal government has no place in local elections. This latest move by the radical Left is something we should all stand up and fight against.

Somehow, the Left wants you to believe it is racist to ask for photo identification to vote, but not discriminatory to ask for photo ID in order to enter restaurants, bars, movie theaters, or gyms in the name of covid-19 safety.

On Saturday, Democratic Mayor Muriel Bowser's vaccine mandate is set to go into effect in Washington, requiring nearly every business and entertainment venue located in the nation's capital to verify that patrons are vaccinated against covid-19 with at least one shot. As part of that mandate for patrons over the age of 18, customers will have to show photo ID as proof their name matches the vaccination card they present for entry. Despite that, the District does not require photo identification for most voters with two exceptions.

As The Daily Wire has previously reported, Bowser announced the new vaccine mandate in late December to supposedly help fight the surging coronavirus cases. Starting January 15, that order will now be enforced. Dozens of establishments such as cafes, nightclubs, hotel common rooms, bowling

alleys, concert halls, and more will now be required to hang a poster in the storefront window notifying "Vaccination Required."

"Attention: Per Mayor's Order 2021-48, Covid-19 Vaccination is REQUIRED to enter this business" the sign reads before noting that customers age 12 and up must show proof of vaccination such as an official completed CDC vaccination card. Those over the age of 18 must also show a photo ID.

According to the D.C. government website, adults can show official identification cards such as a photo a state-issued driver's license or limited purpose driver's license, any other state-issued identification card, passport, DC one card, or a student ID.

In the past Democratic Party leaders and others in the media have suggested that requiring ID to vote is tantamount to enacting "New Jim Crow" laws because they argue black Americans are less likely to have voter ID than their white counterparts.

This past summer, President Joe Biden criticized Georgia for enacting a new voting law that included a voter ID requirement to cast a ballot. Biden called the law, "Jim Crow in the 21st Century."

"Instead of celebrating the rights of all Georgians to vote or winning campaigns on the merits of their ideas, Republicans in the state instead rushed through an un-American law to deny people the right to vote," he added. "This law, like so many others being pursued by Republicans in statehouses across the country is a blatant attack on the Constitution and good conscience."

According to the left-wing American Civil Liberties Union, "Minority voters disproportionately lack ID. Nationally, up to 25% of African-American citizens of voting age lack government-issued photo ID, compared to only 8% of whites"

Despite that, Democratic politicians seem to have no problem requiring photo ID to essentially participate in daily life.

Question: Is our ruling class *trying* to make us to think they're a bunch of pederasts? Our media could not be less interested in Jeffrey Epstein's child molestation ring and, with the sole exception of the Palm Beach Police Department, every arm of government has bent over backward to bury the case.

(Who says our media and government can't work together?)

The jury's courageous delivery last week of five "guilty" verdicts against Epstein's pimp, Ghislaine Maxwell, was a sort of reverse jury nullification. The U.S. attorney's office—the *prosecution*—did everything it could to get an acquittal, but the jurors defied them.

As for media coverage, did you even know that the FBI found Epstein's cache of sex tapes labeled "(name of underage girl) + (name of VIP)"—*and then lost them?*

Immediately after Epstein's arrest at Teterboro Airport in July 2019, the FBI executed a search warrant on his New York mansion. Following a daylong search, agents discovered a hidden safe in the closet of a fifth-floor dressing room, used a saw to break into it, and found an enormous collection of photos of naked girls, and CDs of the girls apparently having sex with influential men.

Then, the agents left—abandoning the photos and CDs, with Epstein's employees free to wander about the place. As Kelly Maguire, FBI special agent in charge of the search, explained during Maxwell's trial, they only had a warrant to *search* the house, but not to *remove* evidence—evidence at the heart of the entire sex trafficking scheme.

It didn't occur to Maguire to leave a single agent behind to guard the CDs? How about the intern who just gets coffee?

You'll never guess what happened next.

The CDs and photographs disappeared. By the time the FBI returned with a new warrant—four days later—to remove the CDs and photos, they were gone. Later, after a few phone calls, Epstein's lawyer, Richard Kahn, "returned" the cache in two suitcases. *I had no idea they were important! I was just tidying up!*

Were the videos tampered with? Were all of the photos returned? Who knows?

This was testified to by Special Agent Maguire. *That's the last time I trust the lawyer of a pedophile! Boy, is my face red! Darn it! . . . Oh well, what are you going to do?*

(Before moving on, let's take a moment to honor the historic appointment of Kelly Maguire as FBI special agent. Another glass ceiling shattered!)

How could any search warrant for Epstein's residence fail to specify videos?

The reason the tapes are kind of important is that it was perfectly clear—certainly by 2019—that Epstein had no legitimate source of income to fund his Caligula lifestyle, and further, that he was farming out underage girls for sex to the rich and powerful—with hidden cameras running everywhere. It sure looked like his underage sex ring was a blackmail/kompromat operation.

As further evidence that there is ABSOLUTELY NO COVER-UP: The New York Times has never breathed a single word about the CDs lost in the FBI's botched search. Nor has The Washington Post. Nor the Chicago Tribune. Nor the Los Angeles Times.

Wait—I'll make this easier. Here's a list of all the major U.S. newspapers that *did* report on Maguire's breathtaking revelation.

- The Miami Herald
- The New York Post

The end.

Oddly, media in the rest of the world seemed to find Maguire's testimony about the vanishing CDs somewhat more newsworthy. The story of the missing tapes was covered—repeatedly—in The Daily Telegraph (London), The Independent (United Kingdom), The Daily Mail (Ireland), Economic News (Russia) and the Daily Mail (U.K.), among others.

The totally not-a-cover-up gets weirder and weirder.

Epstein had vast wealth, and we still don't know where it came from. Normally, the IRS is extremely curious about unexplained flows of riches. Did the IRS decide in this case, *Well, he may be a committed and energetic pedophile, but as far as we know, he's a conscientious taxpayer!*

Last week, we reviewed our ruling class's strange lack of interest in Jeffrey Epstein's child molestation ring, in which so many of them played a part. The media cover-up is second only to the government cover-up, with prosecutors delivering loss after loss in cases they've been forced to bring (by the police and the public) against the child molester.

This week, we'll look at the government's long record of zealously trying NOT to unravel the case.

Barry Krischer was the first prosecutor to let Epstein off for child molestation. The local police presented then-Palm Beach state attorney Krischer with bales of evidence. They had affidavits from dozens of witnesses: girls abused by the pederast, the women who recruited them, the butler who cleaned up sex toys after the "massages," as well as records of Epstein's molestation appointments, one delayed because of a victim's "soccer practice."

Pretty much everything we know today about Epstein's sex ring was unearthed by the Palm Beach Police back in 2005 and handed to Krischer on a silver platter.

Five underage girls had given police sworn statements that Epstein had sexually abused them, backed by 17 other witnesses, but when Krischer brought the case to the grand jury, weirdly, he allowed only one of the girls to testify—and then attacked her on the stand! (Epstein's attorneys had helpfully



provided Krischer's office with the girl's posts on MySpace, where she talked about *boys and drinking*, the little harlot.)

According to an extensive review by The Palm Beach Post, most of Krischer's 2,800-page investigative file on the case consists of *dirt against the teens*—and against the police—given to him by Epstein's lawyers. (*Thanks, Epstein attorneys! Do we owe you anything?*)

The grand jurors, who'd been meticulously kept in the dark by Krischer, ended up voting only for a single charge of "solicitation of prostitution" against Epstein in 2006. He pleaded guilty and was sentenced to five years' probation. No jail time, no record as a sex offender—no criminal record whatsoever.

According to Nexis, only one newspaper, The Palm Beach Post, reported at the time—or ever—that Palm Beach prosecutor Krischer gave Epstein *probation* for his years of child abuse.

Epstein's friends claimed he was the victim of a crusade by Palm Beach Police Chief Michael Reiter, whom they called a "born-again nutcase." Apparently, anyone who thinks prison is appropriate for the mastermind of a massive child sex ring has gotta be "born-again." (How does he feel about teenage girls talking about boys and drinking?) In fact, there's no evidence that Reiter is even a Christian—other than the fact that he's never won an award from the ADL.

(In 2018, the Anti-Defamation League gave a "Jurisprudence Award" to . . . Barry Krischer! The award praised him for "exemplifying the principles upon which the Anti-Defamation League was founded." *Hey, Jonathan Greenblatt, was Harvey Weinstein out of town?*)

At that point, the enraged Palm Beach chief of police took his evidence to a completely separate law enforcement agency—the federal government, even though these were mostly state crimes. U.S. attorney Alex Acosta proceeded to make a deal with Epstein—with Krischer essentially operating as Epstein's defense counsel—resulting in a plea only slightly tougher than Krischer's pat on the head.

According to journalist Vicky Ward, Acosta later defended this sweetheart deal to the Trump transition team, explaining: "I was told Epstein 'belonged to intelligence' and to leave it alone."

Most recently, the U.S. attorney's office for the Southern District of New York brought a gentle prosecution against Epstein's pimp and fellow child molester, Ghislaine Maxwell. Federal prosecutors called a mere four girls who claimed to have been recruited and/or abused by Maxwell. They could have put dozens of her victims on the stand.

Most notably, the Southern District did not call the star witness, Virginia Giuffre, who has openly named the rich and powerful men she says these creeps forced her to have sex with, including Prince Andrew, former Harvard professor Alan Dershowitz, former New Mexico governor and presidential candidate Bill Richardson, former Senate Majority Leader George Mitchell, French model scout Jean-Luc Brunel, and the hedge fund billionaire Glenn Dubin, among others.

Immediately after the Southern District accidentally won five guilty verdicts against Maxwell, the prosecutors quietly revealed that, weeks earlier, they'd dismissed all charges against the prison guards who failed to check on Epstein for more than eight hours the night he allegedly committed suicide—despite an explicit directive that they check on him every 30 minutes.

Not to brag, but on July 25, 2019, I wrote: "Dear Bureau of Prisons: Please get Jeffrey Epstein to a super Max prison pronto, or the people who want him dead will make sure we never know the truth. ACT NOW!"

On Aug. 10, 2019, Epstein was found dead in his cell.

The feds not only did not move Epstein to a super-maximum security prison as some observers recommended, but they also did the following.

- The day before Epstein died, he was taken off suicide watch.
- Against orders, his cellmate transferred elsewhere, leaving Epstein completely alone in his cell.
- All the cameras on Epstein's floor were mysteriously broken.
- Even the footage of his earlier suicide attempt had been mistakenly erased and the backup footage destroyed "as a result of technical errors," according to assistant U.S. attorneys Jason Swergold and Maurene Comey.

How many times can they use the "we're completely incompetent" defense? (Hey, does anybody know if this case implicates rich people?)

Maxwell's brother soon announced to the press—and to anyone else who might be interested!—that his sister was no snitch. She wouldn't rat out any of Epstein's fellow child molesters in exchange for a lighter sentence.

Maxwell is facing up to 65 years in prison, and her brother has just admitted she can name names. *Hello? SDNY? Any thoughts about applying some pressure?*

Unfortunately, these are the same prosecutors who just did everything in their power to blow the case against her. My prediction of their next conversation with Maxwell: *This is our last offer: 30 hours of community service—and we're not kidding! OK, 20 hours. Damn—you're one tough negotiator.*

Most strange, the ink wasn't dry on the guilty verdicts before one of the jurors ran to the press and announced that he'd lied on his juror questionnaire. Although he'd denied ever having been sexually molested, he had been! Not only that, but—hoo boy—did his experience with sex abuse sway the jurors during deliberations!

The defense immediately moved for a mistrial and the chatty juror moved to a villa in the south of France he's just inherited from an unknown relative. OK, the second part isn't true (that I know of), but are you kidding me??
