Iran will soon exceed an enriched uranium limit under its nuclear deal, after remaining signatories to the pact fell short of Tehran's demands to be shielded from U.S. sanctions, the semi-official Fars news agency cited an "informed source" as saying.

Iran's envoy to a meeting of the remaining signatories to the 2015 nuclear accord said on Friday that European countries had offered too little at last-ditch talks to persuade Tehran to back off from its plans to breach limits imposed by the deal.

"As the commission meeting in Vienna could not satisfy Iran's just demands . . . Iran is determined to cut its commitments to the deal and the 300 kg enriched uranium limit will be soon breached," the unnamed source said, according to Fars.

Iran's president warned that Tehran will increase its enrichment of uranium to "any amount that we want" beginning on Sunday, putting further pressure on European nations to save its faltering nuclear deal and offer a way around intense U.S. sanctions.

President Hassan Rouhani's threat, combined with Iran surpassing the stockpile limits of the 2015 atomic accord, could narrow the estimated one-year window it would need to produce enough material for a nuclear weapon, something Iran denies it wants but the deal sought to prevent.

But as tensions rise a year after President Donald Trump unilaterally withdrew America from the deal, it looks unlikely that Europe can offer Iran a way to sell its oil on the global market despite U.S. sanctions.

Israel will be destroyed in half an hour if the United States attacks Iran, a senior Iranian parliamentarian said on Monday, according to the semi-official Mehr news agency.

Weeks of tensions culminated last month in U.S. President Donald Trump's last-minute decision to call off planned strikes on Iran after Tehran downed a U.S. drone. Washington also accused Iran of being behind attacks on ships in the Gulf, which Tehran denies.

"If the U.S. attacks us, only half an hour will remain of Israel's lifespan," Mojtaba Zolnour, the chairman of the Iranian parliament's National Security and Foreign Policy commission said on Monday, according to Mehr.

Kenneth Adelman, a former assistant to Secretary of Defense Donald Rumsfeld and a prominent figure in the U.S. foreign policy community, famously predicted in 2002 that a war to oust Iraqi leader Saddam Hussein would be a "cakewalk."

President Donald Trump apparently learned nothing from Adelman's hubris and rosy optimism. Although he aborted a planned airstrike on Iran at the last minute, Trump later warned Iranian leaders that the military option was

still very much on the table. He added that if the United States used force against Iran, Washington would not put boots on the ground but would wage the conflict entirely with America's vast air and naval power.

There was no doubt in his mind about the outcome. He asserted that such a war "wouldn't last very long," and that it would mean the "obliteration" of Iran.

But history is littered with examples of wars that political leaders and the general public erroneously believed would be quick and easy.

- When Abraham Lincoln opted to confront the secession of the Southern states with force, his initial troop request was merely for 90-day enlistments. People in Washington, DC, were so confident that the Union army would crush the upstart rebels at the impending battle of Manassas that hundreds drove out in carriages to view the likely battlefield. They treated it like a spectator event, in some cases complete with picnic baskets. Four years later, more than 500,000 American soldiers were dead.

- Leaders and populations in the major European capitals in 1914 exuded optimism that the new war would be over in a matter of months—with their side winning a glorious victory, of course. Once again, the situation did not turn out as planned. The projected quick and relatively bloodless conflict became a prolonged, horrific slaughter consuming millions of young lives, toppling established political systems in Germany, Austria-Hungary, and Russia, and ushering in the plagues of fascism and communism.

A common thread in the various blunders was the assumption that the initial phase of a conflict would be utterly decisive.

That was Adelman's error. Washington's military encounter with Saddam's forces was fairly close to being a cakewalk. The decrepit Iraqi army was no match for the U.S.-led invaders. When Saddam fell from power, President George W. Bush flew to a U.S. aircraft carrier that displayed a huge (later infamous) "Mission Accomplished" banner.

However, the initial military victory proved to be just the beginning of a giant headache for the United States. Within months, an insurgency arose against the U.S. occupation force, and political instability bordering on civil war plagued Iraq, paving the way for the rise of ISIS. At last count, more than 4,400 American troops have perished pursuing the Iraq mission, and the United States has spent well over a trillion dollars. Not exactly a cakewalk.

That is what makes President Trump's cavalier attitude about a war with Iran so worrisome. He implicitly assumes that the United States has control over the twin processes of retaliation and escalation. U.S. officials made that same faulty assumption in Iraq—and decades earlier in Vietnam. But even adversaries that are inferior in terms of conventional military capabilities may have numerous options to wage asymmetric warfare. And that strategy can become a war of attrition that inflicts serious damage on the militarily superior United States.

Iran may be especially effective if it adopts that course. Indeed, just in the narrow military sense, Iranian capabilities are far from trivial. Retired Admiral James Stavridis notes that Iran has “exceptionally strong asymmetric warfare capability” in several areas. “Cyber [attacks], swarm small-boat tactics, diesel submarines, special forces and surface-to-surface cruise missiles are all high-level assets,” Stavridis stated. “They are also very experienced at employing them in the demanding environment of the Middle East.”

Beyond utilizing its direct military capabilities, Tehran might well call upon its network of Shia political and military allies in the Middle East to create havoc for the United States. Iran maintains very close ties with Hezbollah in Lebanon and several Shia militias in Iraq.

The residual U.S. force deployed in the latter country could be especially vulnerable to harassment and lethal attacks. And one should not ignore or discount the potential role of the angry, oppressed Shia majority in Bahrain. If their seething discontent at the Sunni-controlled regime that Washington backs explodes into outright conflict, the Trump administration could find it increasingly difficult to continue basing the U.S. Fifth Fleet in Bahrain.

Going to war against Iran would be no minor matter, and President Trump is irresponsible to act in such a flippant manner. Attacking Iran could trigger a prolonged, costly nightmare in both treasure and blood. Rep. Tulsi Gabbard (D-HI), a Democratic presidential candidate, likely is prophetic that a war against Iran would make the Iraq War look like a cakewalk.

Tehran certainly has a multitude of ways to retaliate for U.S. aggression and to escalate the bilateral confrontation. U.S. leaders would be wise not to venture farther down that perilous path.

The Mexican government on Wednesday began a “permanent deployment” of federal forces along the Suchiate River on the border with Guatemala to prevent the entry of migrants, a senior officer said.

General Vicente Antonio Hernandez told reporters that in addition to the Suchiate River deployment, members of the country’s National Guard were also deployed at 61 migrant crossings in the southern state of Chiapas.

The general added that since May, 20,400 migrants had been “rescued” from organized crime and 30 human traffickers arrested.

“We would be very irresponsible if we continue to let them go on,” he said, recalling the case of a Salvadoran migrant who drowned with his toddler daughter while trying to cross the Rio Grande to reach the United States.

Trump threatened in May to impose tariffs on all Mexican goods if the country did not do more to slow the flow of Central American migrants crossing the US-Mexican border.

After a week of tense negotiations, the two sides announced a deal on June 7 under which Mexico agreed to send thousands of National Guardsmen to secure its borders and expand its policy of taking back asylum-seekers while the US processes their claims.

The migration deal appears to be delivering Trump's desired result so far: the number of migrants taken into custody at the southern US border is expected to drop by 25 percent for June, the acting head of the Department of Homeland Security, Kevin McAleenan, said Friday.

Trump tweeted his thanks to Mexico on Wednesday, saying that it is "doing a far better job than the Democrats on the Border."

An article titled “It’s Not Your Imagination: Americans Are Shooting Off More Fireworks Than Ever” was posted at oregonlive.com on July 4, 2019. Following are excerpts of the article.

In the eyes of many Americans, the Fourth of July is a day for parades, barbecues and, of course, fireworks.

The tradition got its start at the beginning of our nation’s history after the Founding Fathers met in Philadelphia to write and sign the Declaration of Independence.

A day after the Continental Congress adopted the declaration on July 4, 1776, John Adams—soon the second U.S. president—penned a letter to his wife Abigail, declaring that Independence Day “ought to be solemnized with pomp and parade, with shews, games, sports, guns, bells, bonfires and illuminations from one end of this continent to the other from this time forward forever more.”

One year later, Philadelphia celebrated the anniversary with fireworks—or “illuminations,” to Adams—plus a parade commemorating Independence Day.

So with that in mind, here are four fascinating sets of facts about fireworks.

- Firework use is growing

Americans shoot off almost 1 pound of fireworks each year for every adult.

And this figure has grown rapidly in recent years, from half a pound per adult in 2000. In 1976, the United States' bicentennial, the figure was just one-sixth of a pound annually.

A reason for the big increase is the steady reduction in state prohibitions against individuals using fireworks.

Today only Massachusetts completely prohibits individuals from owning and using any type of fireworks. The other states all allow usage in some form.

The most recent states to allow fireworks are New Jersey, Delaware and Iowa, whose new law legalizes fireworks around the 4th of July and New Year's Eve only.

Fireworks are also illegal in many urban areas, like New York City.

Because states are now permitting individuals to purchase and possess fireworks, there has been a large shift from professional to amateur use.

Back in 2000, roughly one-third of all fireworks were set off during professional displays, the kind that light the skies of cities around the world on holidays like New Year's Eve and national celebrations.

By 2017, professional displays made up less than 10 percent.

■ Fireworks prices have fallen

Just because more regular Americans have been shooting off fireworks doesn't mean prices have surged. The vast majority of the fireworks shot off in the United States are manufactured overseas, mainly in China.

Each shipment of fireworks brought into the U.S. includes a detailed invoice that shows the price the importer paid. These invoices show fireworks prices, after adjusting for inflation, are cheaper today than in the mid-1990s.

In 1996 it cost about \$1.37 in today's terms to import 1 pound of fireworks.

By 2017 the price had fallen to just \$1.13 a pound. That means pound-for-pound fireworks are less than half the price of the hot dogs many people are grilling this 4th.

■ Accidents and injuries

Fireworks are dangerous—hence the reason so many states had banned them previously.

And as we've exploded more bottle rockets, firecrackers and Roman candles, fireworks-related injuries have increased as well, though they are still far below the rates we saw back in the mid-1980s when cities and states began banning their usage.

Back in 1986, fireworks injured about 6.6 out of every 100,000 people. Since 1986, injuries have steadily fallen as government regulations made them safer. In 2008, the rate was down to 2.3 people.

But as states have relaxed restrictions, the injuries have started increasing again. The latest figures for 2017 show a rate of 4 people per 100,000.

In addition, there's also a big gender divide in who suffers the most injuries. Men experienced about 70 percent of fireworks-related injuries for the one-month period from June 18 to July 18, 2017.

Beyond such statistics, however low, every year there are horrible stories of both children and adults being maimed and killed. So it's always important to exercise caution when lighting what amounts to a low-yield missile.

■ Fireworks now must meet higher standards

One reason that injury rates have fallen in the first place is because of the federal government's Consumer Product Safety Commission.

This organization regulates fireworks under the Federal Hazardous Substances Act. It banned the sale of the most dangerous fireworks, such as M-80s and cherry bombs, in the 1960s.

Today, it is working to lower injury rates again by requiring manufacturers to adhere to higher standards. For example, faulty fuses have caused many injuries, such as when some burned rapidly and ignite a rocket too quickly, preventing the holder from moving away in time. Other fuses actually take too long to ignite, leading people to investigate whether it needs to be relit just as the firework explodes in their face. So the commission now requires all fuses to ignite fireworks three to nine seconds after being lit.

The commission also now requires fireworks to have bases that are wider and support more weight so they do not tip over after being ignited. This prevents fireworks from firing off horizontally, becoming missiles that bounce along the ground and potentially hit spectators.

It also now bans hazardous materials like lead from the powder inside fireworks. This ensures people downwind from the explosions are not poisoned by breathing the smoke.

The consensus view on the right is that Hillary Clinton was a primary reason for Donald Trump's success in 2016. But not all conservatives agree about why that was.

For devotees of the Trump-as-savior narrative, Clinton—and all the allegedly nefarious forces at her beck and call—was a uniquely formidable opponent. Defeating her required a different kind of Republican, one who'd be willing to fight as dirty and as tough as the Democrats.

■ This was a “Flight 93 election,” and Trump was the hero we needed to storm the cockpit.

■ Others on the right see it differently. It wasn’t so much that Trump was the one person who could beat Clinton, but that she was the one candidate he could beat.

In other words, it was only thanks to the fact that she was so unpopular that Trump had a chance. Trump-reluctant Republicans and independents could be persuaded that he was better than Clinton—when presented with a binary choice.

The latter seems vastly more plausible for the simple reason that Trump didn’t have to convince those voters that Clinton was unlikable and a little scary; he simply had to exploit their pre-existing opinion of her. Indeed, Trump’s continued obsession with bashing Clinton points to how central she is to his identity.

This has consequences for 2020 because the White House’s entire strategy boils down to making Trump’s opponent more unlikable than he is. If Trump wasn’t responsible for Hillary’s unfavorable numbers in the first place, it remains to be seen whether he can Hillaryize another Democrat.

It may not be all that hard, though, because the Democrats are doing everything they can to keep the Flight 93 panic alive on the right. They’re doing this by running so far to the left that many Trump-skeptical Republicans feel as if they have no choice but to vote for him again. (I hear this from my fellow conservatives every day.)

Democratic candidates have openly praised socialism, the Green New Deal, the abolition of private insurance, voting rights for incarcerated felons, federal funding of abortion late into pregnancy, confiscatory “wealth taxes,” and even the right to sex-change operations paid for by taxpayers.

And here is where I think Clinton’s true historical significance isn’t being recognized. Again, conservatives (including yours truly) invested a lot of time and energy in shaping public perceptions of Clinton.

But the blame—or credit—doesn’t just go to the right. Clinton herself did much to help the effort. She was never the natural politician her husband was. She lacked his gift for reading the electorate and speaking to voters’ concerns. She collected all of her husband’s baggage without any of her husband’s skill at deflecting criticism. She wasn’t very likable.

This was a huge advantage for Bernie Sanders in 2016. He came way closer to beating Clinton in the primaries than most people thought he would by tapping into the passion of the base and the frustrations of other Democrats who didn’t relish a Clinton dynasty and disliked both Hillary personally and the corrupt practices of the establishment she represented.

She ran on the implied claim that it was simply her “turn” to be president—a poisonous framing in a populist moment (just ask Jeb Bush). In retrospect, not being Hillary was almost as big a boon for Sanders as it was for Trump.

If the Clinton machine had not scared away more talented and resourceful politicians from running in 2016, it's possible that someone other than Sanders would have captured the passion of the party, just as Obama did when he toppled Hillary as the inevitable nominee in 2008.

But that didn't happen, and as a result, the Democratic party got the message that Sanders-style socialist populism was the key to success, just as the GOP has concluded that Trump-style nationalist populism is the future of the right.

Sanders' frustration at no longer being the undisputed voice of the base is palpable. "They said our ideas are crazy and wild and extreme," he recently complained. "And now it turns out all of the other candidates are saying what we said four years ago."

He's right.

Of course, there are larger historical forces at work here, but it sure looks like Hillary Clinton's candidacy was an inflection point, because it galvanized not only the GOP's turn toward nationalism but the Democrats' turn toward socialism.

She'll never be president, but she's made history nonetheless.

There is a significant and growing probability that Texas will become the most consequential swing state in presidential and senatorial elections to come.

A campaign in the Lone Star State could cost President Trump the White House next year, even if Texas voters will ultimately choose him.

A powerful combination of demographic forces are propelling Texas from one of the reddest states in the union into a swing state. Democrats will likely make an outside play in Texas ahead of 2020, along with a full run for its projected 41 electoral votes. Texas also stands to gain three seats in Congress after the next census, making it a crucial state for both parties.

Texas demographics today are strikingly similar to those of California in 1990, before Democrats began their seven to nothing streak of Golden State victories in presidential races.

Like California in 1990, the Texas population currently hovers around 29 million and is changing rapidly in light of heavy immigration from Mexico.

The second generation children of Mexican immigrants have played a major role in keeping California out of Republican reach. This same transformation is taking root in Texas.

Immigration has already had a very tangible impact on Texas politics. While illegal immigrants cannot vote, their children born in the United States are

indeed citizens and make up a significant share of the new generation of voters in the southern state.

There are around 35 percent of Texans under the age of 18 who are the children of immigrants, a figure that has nearly doubled in the last 30 years. This carries weight.

Young Texas voters overwhelmingly turned out for Beto O'Rourke over incumbent Ted Cruz in the Senate race last year.

O'Rourke beat Cruz with 18 year olds to 24 year olds by a margin of 68 percent to 32 percent and with 25 year olds to 29 year olds by a margin of 73 percent to 26 percent.

O'Rourke also outperformed the traditional edge Democrats already have among Texas Latino voters by a wide margin of 64 percent to 35 percent.

With these second generation Mexican Americans strongly supporting Democrats at the polls, Texas changing to a purple state could not happen at a more inconvenient time for Trump.

His margin in the state in 2016 was the smallest for a Republican nominee since the poor showing of Bob Dole in Texas in 1996.

Considering the immense and enduring new wave of left leaning voters that O'Rourke attracted, there is a real chance that Texas will be close enough in 2020 that Republicans cannot take it for granted.

Over the next year, Trump and his surrogates will be forced to spend more time campaigning in Texas, which will diminish time spent on the ground in other crucial swing states.

Ultimately, this could be a death knell for the campaign.

A major reason Trump won in 2016 was due to his critical time investment in states like Michigan, Wisconsin, and Pennsylvania.

He spent around 50 percent more time in these battleground states than Hillary Clinton did.

A diversion of time and money campaigning in Texas over the next 15 months could deal a fatal blow to high hopes for a second term.

Any diversion of the large but finite campaign resources to shore up a traditional red state like Texas will cut into the ability of Trump to win key swing states.

Moreover, Texas is not just any state. As the second largest in the nation, by both population and land area, it is an expensive state in which to run a full campaign. Just ask O'Rourke and Cruz. The two combined spent nearly \$125 million on their 2018 Senate campaigns, with O'Rourke outpacing Cruz by over 50 percent. Furthermore, outside donations and spending did not just impact the midterm Senate race, with donors also sending millions of dollars into suddenly competitive House races.

Republicans took note of the sheer volume of Texas votes that Democrats attracted in the last cycle. A Republican affiliated group, Engage Texas, is spending \$25 million to register and turn out red voters. Considering the Trump campaign spent \$325 million for 2016, the implications of such a drain of resources are clear well before the general election race begins.

In many ways, the resources used to keep Texas red next year are balanced by the fates in Michigan, Wisconsin, and Pennsylvania. Several campaign stops or a late ad buy could mean the difference in the race. Trump could see his electoral chances go to hell, if Democrats spend more time and money in Texas.

In those countries, women encounter all kinds of liberty restrictions plus in at least 30 countries on the African continent, the Middle East and Southeast Asia, female genital mutilation is practiced. You might ask Joe Biden what part of the "white man's culture" needs to be changed.

For as the heavens are higher than the earth, so are My ways higher than your ways, and My thoughts than your thoughts. For as the rain comes down, and the snow from heaven, and do not return there, but water the earth, and make it bring forth and bud, that it may give seed to the sower and bread to the eater, so shall My word be that goes forth from My mouth; it shall not return to Me void, but it shall accomplish what I please, and it shall prosper in the thing for which I sent it."
