Defense industry giant Raytheon unveiled its newest weapon, the Peregrine air-to-air missile, Monday.

The weapon, designed for use on fourth- and fifth-generation fighter aircraft—anything from an F-16 to an F-35—is about 150 pounds and 6 feet long, making "the most efficient use of the real estate on a fighter aircraft," according to Mark Noyes, business development executive at Raytheon.

"Peregrine will allow U.S. and allied fighter pilots to carry more missiles into battle to maintain air dominance," Thomas Bussing, the vice president of Raytheon Advanced Missile Systems, said in a statement.

The new missile will combat a number of airborne threats, including other missiles, unmanned aerial vehicles (UAVs, or drones) and other aircraft, while saving space. The AMRAAM missile, for example, is 335 pounds and 12 feet long.

"With its advanced sensor, guidance and propulsion systems packed into a much smaller airframe, this new weapon represents a significant leap forward in air-to-air missile development," Bussing said.

The missile's guidance and sensor systems allow it to "detect and track moving or stationary targets at any time of day and in challenging weather conditions," according to the release.

The Peregrine combines "the autonomy of AMRAAM [Advanced Medium-Range Air-to-Air Missile]" with the maneuverability of the 9X Sidewinder missile, Noyes told Insider. The three weapons together, he said, provide warfighters with "just an incredibly potent and catastrophic capability against the enemy."

The Peregrine incorporates already available materials, military off-the-shelf components, and additive manufacturing processes, making it a low-cost option for militaries facing increased air threats, particularly missiles and UAVs.

Noyes praised the Peregrine's ability to "autonomously track and destroy a target," saying, "The ability of this new seeker is just incredible for all weather, day and night."

The Peregrine's small size, combined with its high-performance propulsion system, allows airfighters to fire more rounds, faster, as well—enabling it to "overwhelm the enemy with affordable mass."

As Defense News points out, the Peregrine announcement dovetails with a Raytheon executive's comments about the proliferation of counter-drone technology, indicating that the company's focus on defeating drones won't stop any time soon.

France will soon start distributing radioactivity-blocking iodine pills to an additional 2.2 million people living near the country’s 19 nuclear power plants, to be taken in case of accidental radiation leaks, regulators said Tuesday.

The ASN nuclear safety authority had announced in June an extension of the safety radius to 20 kilometres (12 miles) of each plant, up from 10 kilometres set in 2016, when some 375,000 households were prescribed the pills.

The watchdog said Tuesday that affected residents will receive a letter in the coming days with a voucher to collect stable iodine tablets from pharmacies, as well as information on what to do in case of a nuclear accident.

“If radioactive iodine is released into the environment, taking stable iodine is one of the most effective ways of protecting the thyroid,” the ASN said in a statement.

The thyroid, which produces hormones regulating the body’s metabolism, is particularly at risk from cancer caused by exposure to radioactive iodine released in nuclear accidents.

France gets the bulk of its electricity from nuclear generators. It is the world’s most nuclear-dependent country, though it has pledged to cut its reliance on nuclear power, largely by shutting down its oldest reactors.

In 2014, flooding at its oldest plant, in Fessenheim near the German and Swiss borders, forced an emergency reactor shutdown. Anti-nuclear activists have long called for the shuttering of Fessenheim, which has been in operation since 1977.

The first new-generation nuclear power plant in the country’s north, originally set to go online in 2012, has been hit by huge cost overruns and manufacturing problems, and is not expected to be ready until 2022.

Also targeted in the expanded campaign will be schools, businesses and shops within the enlarged radius, the ASN said.

Not long ago I went to Disneyland with a friend and his young family who were visiting from out-of-town. His two boys, aged 6 and 9, were thrilled in the way only a 6 and 9 year-old who are about to enter the happiest place on Earth can be. They buzzed with the knowledge that Mickey and Minnie and Pirates and a Haunted Mansion were only minutes away.

And that's when it hit me.

As we stood at the entrance waiting to shell out more than \$100 each for our tickets it occurred to me that "Democratic Socialists" think of America in exactly the same way my friends' kids think about Disneyland.

The country's growing ranks of Marx's admirers are more than willing to enjoy the wondrous benefits, products, and near-infinite spectrum of services that have been created, paid for, and maintained by a complex system they do not understand and cannot appreciate.

For example, my friend's children have no concept of cost. And why would they, they're kids!

From their perspective, they get to see Donald Duck and Goofy and scream their little hearts out as they zip through Space Mountain because Dad puts a card into a little box, punches a few buttons, and when he's finished a person in the kiosk lets them into the park.

The hours of work their Dad performed to earn the money that paid for the tickets is beyond them. The money spent on lunch and snacks and parking and a custom-built light saber means nothing to them. Ideas about work and value are as foreign and meaningless to the kids as Euclidean algebra.

It is likewise impossible for them to conceive of what is required for the park to function.

- The minute planning, operational expertise, and engineering prowess that goes into providing the same world-class experience to the estimated 44,000 people who visit the park each day is absolutely staggering.

- The technical witchcraft involved in programming life-like animatronic characters.
- The traffic flow engineering that moves thousands of cars in and out of the park.
- The supply chain specialists who ensure the Jungle Cruise tour guides have the right kinds of blanks in their revolvers.
- The everyday details involved in making the park work are breathtaking and innumerable.
- What's more, each of those details has to occur at precisely the right time, in the proper sequence, day-in and day-out, every day.

The millions and millions of details that make the park work cannot be legislated to completion. Nor can anyone simply decree that these things occur regardless of whether the person is an elected official, Chairman of Disney's corporate board, or King Canute.

Perhaps most importantly, the children don't appreciate the investment—and risk—involved in producing everything they see around them.

For example, there's no way for them to know that Disney invested \$1 billion on the park's newest Star Wars-themed attraction. That's real money Disney earned and invested to grow its business at a time when attendance at the company's domestic theme parks was down.

Which brings us back to where we began.

Substitute "Democratic Socialist" in place of my friend's kids and replace "Disneyland" with "guaranteed government job," "Green New Deal," or "American healthcare."

Scary, isn't it?

Take healthcare, for example. Does anyone who hears Uncle Bernie describe his plan to take our system down to the proverbial studs and then recreate it according to his ideas of fairness and equity get the impression he has anything more than a superficial understanding of the system?

Or is it more believable that the Uncle Bernie and the Democratic Socialists, like my friend's kids at Disneyland, only see the miraculous advances in healthcare without any apparent appreciation for the dizzyingly complex, difficult, and risk-laden system that makes it all possible?

Or, to paraphrase the old saying, it's easy for a former Brooklyn bartender to perform an appendectomy in Iowa from her posh congressional desk in Washington, D.C.

The same could be said for any of the other industries or sectors of the economy Democratic Socialists aspire to control.

One need look no further than California's housing market to see the perverse and counter-productive effects when Democratic politicians attempt to legislate the free market into conformance with their ideological will.

And there is arguably only a quantitative difference between a child's failure to appreciate the cost to their parents for a day at Disneyland and the Democratic Socialists' trillion-dollar plans for the Green New Deal or wiping out student loan debt.

For the kids and the Democratic Socialists, cost has nothing to do with the price of eggs. (Or maybe it does, and that's why Democratic Party apologists are positing new/ancient economic theories to support their grandiose spending plans.)

A stage full of Democratic presidential hopefuls have repeatedly displayed no apparent concern for the seismic waves their proposed expenditures would have on the broader national, and international, economy.

Instead, they persist in childish view that the bounty we enjoy as Americans is foreordained and that it will somehow continue on its current trajectory forever. They also think this bounty will continue regardless of what they do.

It won't.

The American system is both a fragile, dynamic, and complicated thing, and it is become distressingly clear that the line-up of Democratic Socialists who aspire to lead us have no better understanding of it than my friend's kids do when they visit Disneyland.

The main difference of course being that if Democratic Socialists win the next election, nobody will mistake America for the happiest place on Earth.

Socialism will cure the ills of society, or so the story goes.

Medicare for all, free education and cancellation of student debt, job guarantees, and even a universal basic income . . . all these entitlements and more are advocated by proponents of socialism in America today.

These breathless promises bring to mind old high school pep rallies where a candidate for student body president promises free lunches, less homework, and a winning football team. It sounds good in theory, but there is a cost involved.

To pay it, individuals like Bernie Sanders and Alexandria Ocasio-Cortez recommend progressive tax rates of up to 54% and 70%, respectively.

This is justified, proponents say, by the increasing income inequality in the United States. The argument tends to be that the rich are obtaining an ever-increasing slice of the pie and, therefore, the poor are consequentially getting poorer.

There are numerous problems with these tax plans.

First, they do not offer a solution for our growing deficit, let alone the proposed entitlements. Ocasio-Cortez's tax plan would raise only an additional \$72 billion each year, according to Bloomberg's Noah Smith. As Smith notes, "Wealthy people have eye-popping incomes, but there really aren't that many of them."

When you consider that Ocasio-Cortez's Green New Deal could cost anywhere between \$51.1 trillion and \$92.9 trillion over a nine-year period, it's clear our deficit would be going in the wrong direction. And indeed, it already is.

Our national debt is now more than \$22 trillion. It is projected to balloon to \$28.7 trillion by 2029. Just 20 years ago, it was under \$6 trillion. Continuing to pile entitlements upon entitlements will not solve our problem, it will worsen it.

I wrote recently about Sweden and its Nordic neighbors, and the generous government entitlement programs they offer. So how do these countries pay for these programs?

Simple . . . everyone pays high taxes.

As set forth in a 2015 article by the Tax Foundation, these countries raise a significantly higher percentage of their GDP than the United States, even though their marginal tax rate is close to (or in some cases lower than) that of the United States. Again, this is because their tax rates are fairly flat.

The Tax Foundation provides this example:

"Sweden's top marginal tax rate of 56.9 percent applies to all income over 1.5 times the average income in Sweden. Norway's top marginal tax rate of 39 percent applies to all income over 1.6 times the average Norwegian income.

"Compare this to The United States. The top marginal tax rate of 46.8 percent (state average and federal combined rates) kicks in at 8.5 times the average U.S. income (around \$400,000). Comparatively, few taxpayers in the United States face the top marginal rate."

You can probably imagine why Bernie Sanders and AOC would shy away from telling the electorate that everyone would need to pay higher taxes in order to fund their ambitious entitlements. After all, a "free" lunch doesn't sound so good if you have to pay for it.

Aside from the mathematical difficulties, there is a philosophical issue to consider.

Do those with the most wealth have an obligation to fund entitlements for all and help "redistribute" that wealth?

Politicians like Bernie Sanders and Ocasio-Cortez answer in the affirmative, arguing that a small percentage of individuals should pay a significantly greater share of taxes. Bernie Sanders has decried the fact that "the top 1 percent" possess 40 percent of the nation's total wealth, and suggests that they therefore owe a duty to "pay their fair share."

What Bernie often fails to acknowledge, as noted by Lee Edwards, is that the top 1 percent already pay nearly 40 percent of the individual income taxes.

We also should consider a more fundamental issue—should we focus on “redistributing” the existing wealth of this nation—that is, re-slice the pie we have—or should we focus on baking a bigger pie?

Data demonstrates that our economy is dynamic, not static. In other words, free markets allow the entire pie to grow.

How else can we explain the reality, noted by Canadian psychologist Jordan Peterson, that between 2000 and 2012, “the rate of absolute poverty in the world fell by 50 percent”?

Kay Cole James, the president of the Heritage Foundation, adds that “over the last 25 years, the spread of policies that promote economic freedom has cut the global poverty rate by two thirds.”

Peterson adds, “the poor in the world are getting rich at a rate that is absolutely unparalleled in all of human history.”

Accordingly, what it means to be poor in 2019 is very different than what it meant to be poor in 1919.

In other words, the rich are getting richer . . . but so is everyone else.

But the outcomes are unfair, some say. It’s true that our economic system allows for unequal outcome.

But our founders did not endorse equal outcomes in this life, only equal opportunity.

And while some have levied legitimate criticisms in regard to America’s historical fulfillment of its promise of equal opportunity, its elimination is not the solution.

Rather, the continued promotion of equal opportunity must be our goal, for that is, as Winston Churchill said, “the strong and willing horse” that pulls America along.

The U.S. Department of Justice has recently sued the Baltimore County government alleging that its written test for police officer recruits was unfairly biased against black applicants.

It turns out that black applicants failed the written test at a rate much greater than white applicants. That results in fewer blacks being trained and hired as police officers.

John A. Olszewski Jr., Baltimore County Executive said: “A law enforcement agency should look like the community it serves. As I have said repeatedly since taking office, I am committed to increasing diversity in the county’s Police Department.”

Baltimore City uses *Municipal Police Selection Test*. You can examine some sample questions at its website. I'd like to know which of the questions are either unrelated to police work or racist.

Many jurisdictions use *The National Police Officer Selection Test*. You can examine some of the sample questions at its website. Again, I'd like to know which of the questions are unrelated to police work or are racially biased questions.

In addition, it has been found that MPST and POST are successful predictors of law enforcement training success and job performance.

Black performance on police exams is simply the tip of the iceberg of a truly tragic cruelty. That cruelty stands front and center when one examines the education that most blacks in Baltimore receive.

Several years ago, Project Baltimore began an investigation of Baltimore's school system. What they found was an utter disgrace.

- In 19 of Baltimore's high schools, out of 3,804 students, only 14 of them, or less than 1%, were proficient in math.
- In 13 of Baltimore's 39 high schools, not a single student scored proficient in math.
- In five Baltimore City high schools, not a single student scored proficient in math or reading.
- Despite these academic deficiencies, about 70% of the students graduate and are conferred a high school diploma.
- A high school diploma attests that the holder can read, write and compute at a 12th-grade level. Obviously, the diplomas conferred on students who have not mastered reading, writing and computing are fraudulent.

When a person who cannot read, write and compute very well takes a written employment exam, including that to become a police officer, he is going to encounter difficulties.

His difficulties are not caused by any racially discriminatory aspect of the test.

His difficulties are a result of not having acquired what he should have acquired by the time he finished high school.

But that is not how such a person sees it. He sees that he has a high school diploma just as a white applicant has a high school diploma. To him, any difference in treatment and outcomes must be the result of racial discrimination.

Thus, the U.S. Department of Justice sued, claiming that the written test for police officer recruits was unfairly biased against black applicants.

The conclusion that Baltimore County's written test for police officer recruits was unfairly biased against black applicants is tragic. It allows Baltimore public schools to continue to produce fraudulent education.

You say: "Hold it, Williams! You can't blame everything on schools." You're right.

One cannot blame schools and teachers for students who are hostile to the education process.

One cannot blame schools and teachers for a rotten home environment or derelict parents.

But there is one thing entirely within the control of educators. That's their power to issue diplomas. When they confer high school diplomas on youngsters who cannot read, write and compute at or near a 12th-grade level, they are engaging in fraudulent conduct.

Dr. Thomas Sowell's research in "Education: Assumptions Versus History" documents academic excellence at Baltimore's Frederick Douglass High School and others. This academic excellence occurred during an era when blacks were much poorer and faced gross racial discrimination.

It's worthwhile reading for black people to learn the capabilities of other blacks facing so many challenging circumstances.

I'm wondering when the black community will demand an end to an educational environment that condemns so many youngsters to mediocrity.

For a while, we thought MSNBC had temporarily usurped CNN as the font of fake news—although both networks had tied for the most negative coverage (93 percent of all their news reports) of President Trump's first 100 days in office.

A cynic would argue that CNN had deliberately given Trump undue coverage during the Republican primary on the theory that he would be the weakest Republican in the general election and would therefore be the weakest challenger to Hillary Clinton.

CNN president Jeffrey Zucker at one point had bragged that in the primaries, Trump made CNN money.

Only later, after Trump's nomination, did Zucker regret giving so much air-time to Trump and his boisterous rallies.
