A notorious bill moving through Congress—H.R. 1—contains a swarm of bad ideas. But little noticed is a provision that makes Election Day obsolete. We’ve lost so many unifying cultural events that bring Americans together, it is no surprise that H.R.1 not only would start the election weeks earlier but also prolong the election well after Election Day.

H.R. 1/S. 1 cancels Election Day in requiring that states provide at least 10 days after Election Day for mail ballots to roll in for normal counting. Even worse, states can add even more time if they so choose. Georgia can add two business days. Pennsylvania could heap two more weeks. The extensions beyond the federal minimum do not have to be uniform under the proposed bills.

Believe it or not, communities, as well as families across America still gather together on Election Night to watch the returns and applaud or cry over the outcome. Before we all hunkered down because of COVID, watch parties roared on bigger—and sometimes more fun—than Super Bowl gatherings.

There’s a certain unifying magic to Election Day. Americans have a shared experience. Democrats stand next to Republicans in line to vote. The public business of voting is experienced and witnessed almost hundreds of millions of times over in a short time.

But H.R. 1/S.1, the “Corrupt Politicians Act,” threatens to cancel it to the ever-expanding graveyard of quintessential Americana.

Although they do not attract as much attention as the anti-voter ID or universal automatic voter registration elements, the bill provisions extending mail ballot receipt deadlines for 10 days after the election.

This is not just about nostalgia. When you elongate the voting process over weeks and months, you make it harder to monitor the process. Imbalances in manpower between candidates and parties are amplified. It becomes impossible to adequately observe the election, unlike Election Day when volunteers armed with clipboards monitor and report problems. Few campaigns or candidates have the manpower to be at early voting sites for 40 days and then monitor mail ballot processing for an additional 10.

Some relished in watching Pennsylvania look like a victory for President Donald Trump on election night, knowing that the mail ballots would flip the score over the many days to follow. Who needs clarity when there is an election to win?

Certainty brings stability. Uncertainty breeds doubt. We saw that in 2020, and H.R.1’s elongation of the election would only make doubt flourish.

H.R.1 would nullify established state election laws and deadlines governing mail ballots. A majority of states including Arizona, Florida, Georgia, Michi-

gan, and New Hampshire require that absentee ballots be received by Election Day in order for them to be regularly counted. Even the universal vote-by-mail paragons of Oregon and Colorado fall into this category.

There is another consequence to consider. When you cancel Election Day and replace it with Election Months, state and local governments are forced to spend more. Elections become even more expensive.

The problems with H.R. 1/S. 1 continue to reveal themselves. It was no accident that Speaker Nancy Pelosi rushed the bill through the House without hearings. Americans cannot fall asleep on this one. H.R.1 accelerates the march away from Election Day, the Electoral College, and even republicanism itself. This is the red line moment for the American voter.

The open secrets in politics today are that: progressives lie; they accuse those who tell the truth to be liars; and they declare the truth to be a lie whenever it suits their agenda.

The problem this poses for America is, as Joseph Goebbels put it, “...a lie told a thousand times becomes the truth.” And that is exactly what the progressive left is counting on as they work to dismantle our constitutional republic and replace it with a socialist regime.

Take covid for instance.

Let’s start with the truth. A virus with an average survival rate of 99% for those under 70 who are actually infected is *not* a deadly pandemic! Nor is there any scientific evidence that exists to establish that masks, lockdowns or social distancing effectively stop the transmission of any virus, much less covid.

Which should cause anyone with a moral compass to ask, why?

Was it justified by their perceived need to use the pandemic panic to manipulate an upcoming election in order to achieve outcomes like resetting in their favor the ideological balance on the Supreme Court?

It would certainly allow them to preserve the legal protections they all care so much about, like the LGBTQ agenda and the unfettered and federally funded availability of abortions. Last year's push by the proponents of such causes for mail-in ballots based on the public's fears of a false pandemic they had creatively hyped—i.e. magnified by their lies—strongly suggests such a conclusion is not beyond the pale. Regardless, however, at the end of the day, even conservatives must admit that the progressives' midnight election steal—predicated on, and enabled by their pandemic of lies about covid—was a well-coordinated and successful propaganda-based coup d'état that even would have left guys like Goebbels envious.

As would the next batch of progressive *big lies* that followed the election: i.e. that it was not stolen; and that anyone who says differently is a liar, if not a domestic terrorist.

By the constant repetition of such lies, we are being commanded by the left to obey and deny that which we all saw with our own eyes. But even more shocking was our present government's shameless subordination of those lies. Witness the refusal of our F.B.I, Department of Justice and Supreme Court to even look at any of that evidence. Their inaction not only reinforced the lies of the left—and thus, their agenda—but alarmingly, also revealed the magnitude of the systemic corruption that progressives have already successfully caused to metastasize within the various institutions and branches of our government. The very government that these insurgents are: presently controlling; pretending to lead; and, all the while, openly seeking to dismantle and replace with what many of them fondly call, *democratic socialism*.

All of which is what has brought patriotic Americans today to a unique place in our nation's history. That point where they can no longer afford to ignore that the facts confronting us bear witness to the following uncomfortable truths:

- We have a systemically corrupt government that is now controlled by a corrupt few who have already demonstrated their willingness to fraudulently steal an election;
- Given these circumstances, if the integrity and legitimacy of our most recent election cannot be restored now, there is no reason for anybody to even pretend that future elections tomorrow will be any different; and,
- Thus, *if we continue to allow such progressive lies about the legitimacy of our last election to stand unchallenged, we will have conceded to their push to replace our constitutional republic with their socialist regime . . . in which we will be made nothing more than their indentured servants.*

Which is exactly what has resulted in so many Americans today asking the same two questions:

- What can be done to effectively challenge such lies; and
- Where do we start?

For answers, perhaps it would be useful to look to our nation's founders.

When confronted with similarly adverse circumstances causing them to feel it was time for them to take a defiant stand to remove the shackles of an unjust government, the Second Continental Congress certainly gave us a great example of how to get the ball rolling: i.e. it started with their thoughtful drafting, signing and delivering a Declaration of Independence.

A modernized—i.e. digitized—*Declaration* drafted by a select group of legal scholars committed to the preservation of our constitutional republic who have been carefully vetted by a committee that would include the likes of Sidney Powell, L. Lin Wood, Lt. Gen. Michael Flynn, Jay Sekulow and David Clements.

A *Declaration* that would enable patriotic Americans of all stripes to affirm by their digital signatures their unity of purpose to not only declare, but to demand, such things as:

- That science that has been neither politicized nor weaponized be exposed to the light of day to refute any lies about covid that have been wrongfully used to unconstitutionally deprive the people of this nation of their God-given rights to life, liberty and the pursuit of happiness;

“You have to look long and hard in history to find a Republican that voted for a Jim Crow law,” Republican Kentucky Senator Rand Paul says.

Republicans should be calling out Democrats for making the absurd claim that the GOP supports Jim Crow laws when, in fact, history shows that the Democrats have always been the enacting the racist, voter-suppression laws, Sen. Paul said Tuesday during a virtual event hosted by the Heritage Foundation.

“We should throw it right back in their face,” Sen. Paul said:

“For Democrats to stand up and claim ‘Jim Crow’ should be called out on the face of it as ridiculous, and we should throw it right back in their face. Not only is this not Jim Crow, the Democrat Party is the party of Jim Crow.”

Paul said that, in his experience in his home state of Kentucky, “These despicable laws were passed entirely by Democrats” over unanimous Republican opposition: “You have to look long and hard in history to find a Republican that voted for a Jim Crow law. In my state, when they passed Jim Crow laws at the turn of the last century, 1900, 1905, these despicable laws were passed entirely by Democrats. Every Republican voted no. Unfortunately, we only had a handful of Republicans in Kentucky at the time.”

As Heritage’s “Daily Signal” reports, Sen. Paul attributes his strong support for election integrity laws, which Democrats’ label ‘Jim Crow,’ to his father’s troublesome experience with voter irregularities back in 1976: “Sen. Rand Paul, R-Ky., recalls an early and disappointing political experience in 1976, when he was 13 and his father lost a U.S. House seat in Texas by just 200 votes of about 200,000 cast. The loss, he says, led to his long-term interest in maintaining election integrity throughout the country.”

“We found precincts, and this is in 1976, where the entire precinct was 100% for the opponent and zero for us,” the senator recalled. “They had a 100% turnout.”

George Floyd might be alive had former President Barack Obama not, for eight years, consistently play the anti-cop race card.

Despite receiving more white votes than 2004 Democratic candidate John Kerry, Obama said: “The legacy of slavery, Jim Crow, discrimination in almost every institution of our lives—you know, that casts a long shadow, and that’s still part of our DNA that’s passed on. We’re not cured of it . . . Racism—we are not cured of it.”

Obama’s own presidential victory demonstrates that America is not “systemically racist.” In 2007, Gallup found that fewer Americans (5%) said they would not vote for a Black person than said they would not vote for a woman

(11%), referring to his nomination rival Hillary Clinton. The same Gallup poll found that 24% and 42% of Americans, respectively, would not vote for a Mormon, referring to Mitt Romney, or for a person who would be 72 years old when he became president, referring to Sen. John McCain.

Early in Obama's first term, an incident in Cambridge, Massachusetts, gave him a golden opportunity to defuse the lie that the police engage in "systemic racism" against Blacks. The Cambridge police briefly arrested Harvard professor Henry Louis Gates, a Black friend of Obama's, in his home. Gates, back from a trip, couldn't open his front door and reportedly asked his driver to help. A neighbor, observing two people she did not recognize trying to force open the front door of Gates' home, called 911. The cops arrived and politely asked Gates to exit the home so the police could determine ownership. Instead, Gates mouthed off and was briefly arrested.

Obama said, "The Cambridge police acted stupidly." But the Cambridge Police Superior Officers Association and the Cambridge police commissioner insisted the officer simply followed protocol. Obama's statement infuriated officers all across the country and set up a template for the Obama administration: Cops systemically engage in unlawful anti-Black racial profiling.

Suppose Obama had not insultingly denounced the Cambridge police. Suppose, instead, Obama had said: "I've just spoken to my friend, professor Gates. I reminded him that he is a role model and that his behavior with the Cambridge police officer, who was merely doing his job, was unacceptable. We need to understand as Americans that officers typically have a difficult job. Yes, there are bad cops, but for the most part, they're trying to do their best, and contrary to popular perception, the police, in recent years, have killed more unarmed whites than Blacks. It is a lie, not supported by the evidence, that cops are killing Blacks just because they're Black. This is not your grandfathers' America. It is our job as civilians to be respectful, polite and by all means comply. Comply; you won't die."

Suppose Obama encouraged Blacks to comply with the police and that if one feels mistreated, to get a name or badge number and sort it out later. Eric Garner died after an encounter where New York City cops arrested him for selling cigarettes. Had he not resisted, he would likely still be alive. Jacob Blake was shot several times by the Kenosha, Wisconsin, police when they suspected him of reaching for a knife. Had Blake complied, he would not be in a wheelchair today. Would that have encouraged Black suspects like George Floyd to respond differently to an encounter with the police?

Obama knows the statistics and studies. He knows there is no evidence of anti-Black "systemic racism" on the part of the police. But the political Obama knows that Black anger and resentment translate into Black votes. How many routine police encounters with Blacks escalate into something far more serious because young Blacks believe the "systemic racism" lie pushed by Black Lives Matter and their sympathizers?

Polls rate Obama as one of the most admired people in America, particularly among Black Americans. Out of office, he maintains respect, power, stature and influence. As president, he could have saved lives by putting truth over politics. He chose not to. As a former president, he still can.

Mr. Obama, tell the truth. Save lives. It's not too late.

For black victims of violent crime, a Department of Justice report for 2018 shows that 70.3% of their offenders were black and 10.6% of their offenders were white. In other words, the overwhelming majority of violent crimes against blacks are committed by other blacks.

The same report showed that blacks comprise the largest percentage (27.5%) of violent criminal offenders against Asian-Americans. On the flip side, less than 0.1% of Asians are involved in violent crimes against blacks.

The report, *Criminal Victimization, 2018*, was released in September 2019. The latest update, *Criminal Victimization, 2019*, released in September 2020, does not break down the violent crime offenders and victims as was done in the 2018 report. (See Table 14 in *Criminal Victimization, 2018*.)

As the data in Table 14 of the 2018 report show, whites in 2018 were the victims in 3,581,360 violent incidents. In those incidents, 62.1% of the offenders were white, 15.3% were black, 10.2% were Hispanic, and 2.2% were Asian.

For blacks, they were victims in 563,940 violent incidents in 2018. In those incidents, 10.6% of their offenders were white, 70.3% were black, 7.9% were Hispanic, and 0.1% were Asian.

For Hispanics, they were victims in 734,410 violent incidents and for their offenders, 28.2% were white, 15.3% were black, 45.4% were other Hispanics; and only 0.6% were Asian.

For Asians, they were victims in 182,230 violent incidents in 2018. Among their offenders, 24.1% were white, 27.5% were black, 7.0% were Hispanic, and 24.1% were Asian.

For Asians, the largest percentage of their offenders were black.

For Hispanics, the largest percentage of their offenders were other Hispanics.

For blacks, the majority of their offenders were black.

And for whites, the majority of their offenders were white.

Among the violent incidents analyzed by the Justice Department, the crimes included rape, sexual assault, robbery, violent crime involving a weapon, domestic violence, and stranger violence. Homicides were not included because the DOJ interviewed the victims to gather its data.

According to the U.S. Census Bureau, whites make up 76.3% of the population; blacks comprise 13.4%; Hispanics, 18.5%; and Asians, 5.9%. The total population, as of 2019, was 328,239,523.

The Black Lives Matter (BLM) organization expressed its displeasure Tuesday with President Joe Biden for "sending more military equipment" to local police than former President Donald Trump.

"Our communities are being terrorized at a greater rate than they had been under Trump," the organization tweeted.

"Biden is currently sending more military equipment to our neighborhoods than Trump did. You read that right," they claimed.

BLM also noted Biden's first 100 days are quickly approaching, a deadline the organization has set for ending "transfers" of military equipment to local communities.

"Biden's first 100 days are up in 10 days. By then we need him to which transfers military equipment into the hands of police across the country—including school & campus police," they tweeted.

Their website cites the 1033 Program, a Law Enforcement Support Office, which grants shifts of "surplus military-grade equipment to local law enforcement agencies across the country." They also contend, "over \$7 billion has been given to law enforcement agencies" since the Clinton administration.

The organization points to the "military" apparently seen on the "streets ahead of the Chauvin verdict" as an example of "state-sanctioned violence against Black people," their website reads.

BLM has not gone without criticisms, despite its charity tax status.

Indeed, the families of Breonna Taylor and Michael Brown, "two of the iconic victims in the Black Lives Matter movement," are challenging where the organization's funds are utilized.

Taylor's family has called the Kentucky Black Lives Matter division a "fraud."

"Those concerns are now being amplified by other figures within the movement, after Khan-Cullors defended her real estate purchases last week as part of her effort to support her family, and claimed her wealth was not due to the organization itself," Breitbart News' Joel B. Pollak reported.

In a joint speech delivered from the White House Tuesday evening, President Joe Biden and Vice President Kamala Harris responded to the guilty verdict reached in the trial of former Minneapolis police officer Derek Chauvin.

Speaking first, Vice President Harris remarked that "Today we feel a sigh of relief," adding that "a measure of justice isn't the same as equal justice," before stating "we still must reform the system."

And Vice President Harris knows the system. The former San Francisco district attorney and California attorney general had her record within the system laid bare by then-Rep. Tulsi Gabbard during a 2020 Democratic primary debate.

Failing to mention her own work on behalf of the system, Harris invoked her work on the George Floyd Justice in Policing Act, alongside Senator Cory Booker (D-NJ) and Representative Karen Bass (D-CA).

"America has a long history of systemic racism," stated Harris. "Black Americans and black men, in particular, have been treated throughout the course of our history as less than human."

Criminal justice reform is, of course, a relatively new pastime for the Vice President.

Not so long ago, the *New York Times* called out her less than stellar track record on the topic: "Time after time, when progressives urged her to embrace criminal justice reforms as a district attorney and then the state's attorney general, Ms. Harris opposed them or stayed silent. Most troubling, Ms. Harris fought tooth and nail to uphold wrongful convictions that had been secured through official misconduct that included evidence tampering, false testimony and the suppression of crucial information by prosecutors."

"It is a problem for every American," said Harris of systemic racism, to which she was—until recently—at least a front-row witness. "It is keeping us from fulfilling the promise of liberty and justice for all, and it is holding our nation back from realizing our full potential."

Sort of like the full potential she watched the system hold back from those whose wrongful convictions she fought to uphold.

President Biden echoed Harris' and the Left's claims, saying that the murder of George Floyd "ripped the blinders off for the whole world to see the systemic racism" that "is a stain on our nation's soul."

For those keeping score at home, President Biden was previously Vice President Biden—for eight years—and Senator Biden—for more than 35 years—before that. What did more than four decades of Biden leadership in America do to reform the stain of systemic racism he says our nation is marred by?

The 1994 Violent Crime Control and Law Enforcement Act, called the “1994 Biden Crime Bill” by none other than our current President, is perhaps his most notable contribution to America’s criminal justice system. The Biden Crime Bill—which he would later claim he “got stuck” authoring when political winds changed and he needed to distance himself from the eponymous legislation—mandated life sentences for violent felons who had more than two prior convictions, allocated piles of cash to build billions of dollars worth of prisons, and made being in a gang a crime.

Already working to revise history, Biden declared that “the murder of George Floyd launched a summer of protests.” Yes, there were some peaceful, lawful protests. But there were also violent riots. Innocent police officers were killed. Major cities saw their most violent days in half a century. The looting and violence were committed under the same banner Biden and Harris waved from a White House podium Tuesday night, but as Larry Elder outlined in detail here at the outset of last year’s unrest, “Recent studies not only find no ‘systemic’ abuse of black suspects by the cops, but if anything, cops are more hesitant, more reluctant, to use deadly force against a black suspect than against a white suspect.”

Near the end of his remarks in one of a few passages that rang true, President Biden paid lip service to the police officers he moments earlier accused of being infected by systemic racism, saying “most men and women who wear the badge serve their communities honorably, but those few who fail to meet that standard must be held accountable.”

Never letting a crisis go to waste, Biden launched into a call to action, saying the Chauvin verdict is “not enough.” This requires “acknowledging and confronting head-on systemic racism and the racial disparities that exist in policing and in our criminal justice system more broadly,” according to the President who contributed significantly to the criminal justice system that exists in America today.

“Only then,” explained Biden in calling for America to go along with his administration’s legislative agenda, “will full justice and full equality be delivered to all Americans.”

In *Why the Jews?* my book on anti-Semitism, there is a chapter on anti-Americanism. My co-author, Rabbi Joseph Telushkin, and I long ago understood that many of the reasons for Jew-hatred and America-hatred were the same.

Among them are envy of success—material, of course, but even more importantly, success in terms of influence. Another is the religious foundation of both peoples: Both America and the Jews are rooted in a belief in God, a belief they are a Chosen People and belief in the Bible, especially the Old Testament, as the book from which they derive their values.

America-haters and Jew-haters resent the enormous influence both nations have had on the world, have contempt for their belief in being Chosen, and dismiss the Bible as irrelevant and even malevolent.

In the premodern age, Christian anti-Semitism was primarily animated by the charge of deicide—the charge that the Jews killed Christ, a charge that does not have a parallel in anti-Americanism. But beginning in the 20th century, the reasons for the two hatreds converged.

In his recent biography of Adolf Hitler, Brendan Simms, a professor of the history of international relations at Cambridge University, identified Hitler's hatred of America and especially of capitalism as central to Hitler's worldview: "Hitler's principal preoccupation throughout his career was Anglo-America and global capitalism . . . Hitler wanted to establish what he considered racial unity in Germany by overcoming the capitalist order and working for the construction of a new classless society."

In other words, another commonality of America-hatred and modern Jew-hatred has been hatred of capitalism. The Nazis hated America and the Jews, both of whom they identified with capitalism. And the left (not the liberal, who traditionally loved America, but who has become the primary enabler of the left) hates America, which it regards as the paragon of capitalism. By becoming the most successful country in history, America, the quintessential capitalist country, remains a living rebuke to everything the left stands for. If America can be brought down, every left-wing egalitarian dream can be realized.

The question for the America-hater, just as for the Jew-hater, has been: How do we destroy them? What has always rendered anti-Semitism unique among ethnic and religious hatreds was its goal of extermination. No other ethnic bigotry is exterminationist. Regarding America, the left does not seek to exterminate Americans; the idea is ludicrous since most of those on the left who loathe America are themselves American. What the left does very much seek is to destroy America as we have known it—the capitalist and Judeo-Christian enclave of personal freedom.

The Jews created something world-changing by introducing into the world the Hebrew Bible, a universal and judging God, the Ten Commandments, the rejection of the heart as the guide to behavior, the emphasis on justice (not "social justice"), and the doctrine of Jewish Chosenness. They were forever hated for this. So, too, is America hated for placing the Bible at the center of its value system, its belief in being a "Second" Chosen People, its freedoms, and its capitalism. America is not hated for its slavery. If it were, given the ubiquity of slavery throughout world history, every country and ethnic group on the earth would be hated. America is hated for its values and its success.

The fact is that, just as did the ancient Jews, the Americans made something unique: the American experiment in freedom. And it succeeded beyond even its founders' dreams. With all its faults, America did become a shining "city on a hill"—the famous phrase first articulated in 1630 by John Winthrop echoing Jesus in the Sermon on the Mount and repeated throughout American history. For example, President Ronald Reagan, in his 1989 Farewell Address, said, "I've spoken of the shining city all my political life."

And who created this unique place of liberty, opportunity, and unequaled, widespread affluence? More than any other group, it was the WASP, the White Anglo-Saxon Protestant. I say this as neither Anglo-Saxon nor Protestant. Catholics, Jews, nonbelievers, and members of every faith, ethnicity, and race (blacks, in particular) made major contributions; but it was the WASP, more than any other group, who made America. And for that reason, America-hatred is WASP-hatred and, more broadly, white-hatred.

The idea that whites' unique achievements—in making America, in music, art, literature, and the sciences—means that white people are intrinsically superior is absurd. Hitler was also white, as was Joseph Stalin, as are most American mass-murderers. Those facts are no more a commentary on whites than Johann Sebastian Bach or Leonardo da Vinci being white is a commentary on whites.

Whites made the country and the greatest civilization—not because they were white, but because of the values they held. Hatred of the white is ultimately hatred of those values.

Given what the WASP has achieved in the West and in America, it takes extraordinary levels of dishonesty and ingratitude to be anti-white. But neither truth nor gratitude is a left-wing value.

She was promised that an unnamed entity would “put money behind” her Instagram videos or photo posts if she boosted the covid vaccine.

Becker rejected the offers, but many others have accepted the bribery. Sometimes, the quid pro quos mean cash. In other cases, the rewards mean VIP treatment. In Florida, Miami’s Jackson Health System threw vaccine parties for social media influencers who agreed to write positive posts or produce videos about getting the Pfizer vaccine. While there was “no payment made to any influencer,” the Internet stars and their “plus ones” moved to the head of the vaccine appointment line. “Each influencer will be allowed to bring one spouse, partner, or relative who meets Florida’s eligibility requirement” to the party, health officials informed a select group of social media stars.

Joe Smyser, the head of a nonprofit called “Public Good Projects,” told Politico his outfit pays “microinfluencers” to post about getting the covid vaccine and compensates them “anywhere between tens to hundreds of dollars.” The Oklahoma City-County Health Department has paid 35 young social media stars undisclosed sums to post government-approved covid vaccine content and convince their peers that they need the shots to return to “normal” life.

This pay-for-play racket stirs fear, incentivizes herd thinking, stigmatizes independence, fabricates narratives, and facilitates subjugation of our young. The most important thing parents can do to keep their children free and healthy is to block their exposure to the Astroturfed covid agitprop campaign altogether. The governors of a dozen U.S. states have sent a letter to President Biden urging him to pass a ban on the sale of internal combustion engine vehicles by 2035. In the letter, seen by Reuters, the governors said that a "clear regulatory path" is required "to ensure that all new passenger cars and light-duty trucks sold are zero-emission no later than 2035 with significant milestones along the way to monitor progress."

California Governor Gavin Newsom last September issued an executive order directing the state's government to draw up guidelines for such a ban, which was followed by the passage of a bill in Washington last week that would do the same by 2030.

Biden's recently proposed infrastructure plan includes \$174 billion earmarked toward electric car purchase incentives and the expansion of the U.S. charging network, but prior to his election, his campaign said he did not support California's all-out ban on gas and diesel-powered vehicles.

The U.S. Environmental Protection Agency is currently in the process of writing new tailpipe emissions rules, which would overturn more lenient regulations put in place by the Trump administration.

Tesla is the only all-electric mass-market automaker that sells cars in the U.S. today. General Motors is aiming to transition to a zero-emissions lineup in all major markets by 2035, but GM North America President Steve Carlisle told Automotive News "we're all-in, but we need other people to join us. In some cases, people want electric vehicles, but in a lot of cases, they're going to demand an ICE engine. We should always be driven by what our customers want."

Other automakers, including Ford, Toyota and Volkswagen have not put a date on when they expect to become all-electric, and plan to continue to offer hybrids and plug-in hybrids alongside zero-emissions models for the foreseeable future.
