If America is systemically racist, why have millions of blacks from Africa and the Caribbean come to this country over the past 50 years? Why would they and many millions more want to move from all-black societies to a white-dominated, racist one?

This is a question every black and white leftist should be asked. After all, no Jews moved to Germany in the 1930s. And why didn't any? After all, many Jews were suffering terrible persecution and poverty in Russia and in Eastern Europe. Why didn't any of them move to Germany after 1933?

We all know the answer: Because Germany was systemically antisemitic.

Even leftists know that answer.

So, one can only conclude that, in the view of America's leftists, non-German Jews of the 1930s had the wisdom not to move to Germany, but present-day non-American blacks have no wisdom. In the view of America's leftists, then, the millions of blacks who have moved here and the many millions who want to move here must be fools.

How else could leftists regard blacks who willingly move to America? Any black person who decides to leave a black country for America—a place the left claims was founded by racists to perpetuate racism, built and sustained by racism, to this day composed largely of whites, every one of whom is racist and many of whom are white supremacists, and therefore remains systemically racist—must be either be a fool, an ignoramus or both.

If so-called black "leaders" and other blacks on the left and white progressives believe what they say about America, why aren't they doing everything they can to dissuade blacks in Africa and the Caribbean from coming to America? Why aren't they regularly visiting African and Caribbean countries to warn Africans away from the black-hating country they are thinking of emigrating to?

To this question there is only one possible answer: They do not believe what they say about America.

Whether leftists believe their lies is a question I have pondered for years. And I have concluded that in general, they do. Most leftists believe that Russia colluded with the Trump campaign; that men menstruate and give birth; that Shakespeare and Beethoven are revered not because they are great but because they are white; that global warming is an "existential" threat; that the events of Jan. 6 were an "insurrection"; that voter IDs are a form of voter suppression; and that people who had covid-19 need to be vaccinated.

But with regard to their believing America is systemically racist and so persecutes blacks—LeBron James tweets that, like all blacks, "We're literally hunted EVERY-



DAY/EVERYTIME we step foot outside the comfort of our homes!” and Oprah Winfrey likens present-day America to “the days of Jim Crow when black men would be lynched and dragged through the town as an example for other people to see”—their not making any attempt to dissuade blacks from coming to America makes no sense. It only makes sense if they don’t believe what they say about America.

Truth has never been a left-wing value. Truth is a liberal value and it is a conservative value. But it has never been a left-wing value. Truth is nothing more than whatever the left says it is at any given moment. That is why Lenin, the father of modern leftism, named the Soviet Communist Party newspaper “Pravda,” the Russian word for “truth”—truth was what the Soviet Communist Party said it was. For Lenin, then, as for Rep. Adam Schiff, The New York Times, Yale University, and CNN today, truth is what they say it is.

Their pravda is that America is a systemically racist country. Their pravda is that all whites are racist. Their pravda is that Donald Trump is a white supremacist and that everyone who voted for any Republican is a racist.

- Yet, there is a reality that Schiff and these others cannot deny: Vast numbers of blacks yearn to come to America.

- They do so because they have not been influenced by the pravda of Schiff and his fellow Democrats, The New York Times and the rest of the left-wing media, or by Yale and the rest of America’s left-wing universities.

- They do so because they have been influenced not by pravda, but by actual truth: America is the least racist multi-ethnic, multi-racial country in world history, and any black who seeks to improve his life and that of his family has a better chance of doing so in America than anywhere else.

- In fact, within one generation of emigrating to America, Africans from sub-Saharan African countries attain higher levels of educational attainment than the U.S. population as a whole and are more likely to have earned a degree in a science, technology, engineering, and math (Pew Research).

That’s why it is not Africans who are foolish for wanting to come to America; it is America’s left for thinking they are fools.

Wokeness may be the most absurd, harebrained concept foisted on the American public in our lifetimes. Consider just a few of the actions taken and claims made by proponents of this inane philosophy. Graduate students at Oxford University recently voted to remove a photograph of Queen Elizabeth from a campus common area. The movement was led by an American exchange student, the privileged son of a wealthy Washington, D.C., attorney. This should surprise no one since many proponents of wokeness are white, pampered, mansion-dwelling dilettantes.

These thoroughly indoctrinated students claimed they were protesting Britain's colonial history. One wonders if they even know their country's history. ### **Ignoring American facts**

In the United States, woke advocates propose, among other things, the government confiscate all wealth and property and redistribute it according to race. Their critical race theory posits white people in America have used and continue to use laws, policies, regulations and societal mores to oppress people of color while ensuring a superior position in society for white people.

- America elected a Black president, Barack Obama, and a mixed-race vice president, Kamala Harris.
- America passed a broad and sweeping Civil Rights Act almost 60 years ago.
- America amended its Constitution to ensure the rights of its Black citizens (13th, 14th and 15th Amendments).
- America now has the most racially and ethnically diverse Congress in its history.
- America maintains scores of government offices dedicated to ensuring equal treatment of minorities in housing, education and the workplace.

### **Calling whiteness a mental illness**

Those of us who thought the woke crowd reached the zenith of absurdity with its claims of systemic racism were wrong. We should have known better. An even more off-the-wall claim was recently made in an article published in the Journal of the American Psychoanalytic Association.

The article claims "whiteness" is a "malignant, parasitic-like condition" causing those afflicted with it to have "voracious, insatiable, and perverse appetites." This supposed malady causes those who have it to target nonwhite people for nefarious purposes. In other words, whiteness is a mental illness.

While it is tempting to simply ignore this article as just another example of the senseless drivel passing for scholarship these days, we should note the Journal of the APA supposedly accepts only peer-reviewed articles. This means the article in question had to be reviewed and approved by a panel of the author's professional peers. Therefore, the author is not some lone voice crying in the wilderness; others in his profession apparently agree with him. If so, this raises some interesting questions.

Is the article the result of actual research or biased supposition?



Does the article represent true science, or is it pseudo-science masquerading as scholarship?

Did the author's peers really agree with him, or has the APA been so afflicted with wokeness they were afraid to disagree?

Interestingly but not surprisingly, the article claims whiteness can be treated but not cured. In other words, being white makes you the perfect patient for psychoanalysis professionals. They can treat and bill you forever without any expectation of curing you. A convenient diagnosis, is it not? If whiteness is indeed a treatable but incurable malady, business is looking up for the psychoanalysis industry. But this article makes one wonder if it's the psychoanalyst rather than the patient who should be on the couch.

As a candidate, Joe Biden's number one promise was to "unite" America. Yet in his first months as president, his number one priority has been to divide our country by race and gender at every turn.

There is no clearer example than the Biden administration's new effort aimed at indoctrinating America's schoolchildren with some of the most toxic and anti-American theories ever conceived. It is vital for Americans to understand what this initiative would do, what drives it and, most importantly, how we can stop it.

For decades, the America-blaming left has been relentlessly pushing a vision of America that casts our history, culture, traditions, and founding documents in the most negative possible light. Yet in recent years, this deeply unnatural effort has progressed from telling children that their *history* is evil to telling Americans that *they* are evil.

In classrooms across the nation, students are being subjected to a new curriculum designed to brainwash them with the ridiculous left-wing dogma known as "critical race theory." The key fact about this twisted doctrine is that it is completely antithetical to everything that normal Americans of any color would wish to teach their children.

Instead of helping young people discover that America is the greatest, most tolerant, and most generous nation in history, it teaches them that America is systemically evil and that the hearts of our people are full of hatred and malice. Far from advancing the beautiful dream of the Rev. Martin Luther King Jr.—that our children should "not be judged by the color of their skin, but by the content of their character"—the left's vile new theory preaches that judging people by the color of their skin is actually a good idea.

Teaching even one child these divisive messages would verge on psychological abuse. Indoctrinating generations of children with these extreme ideas is not just immoral—it is a program for national suicide. Yet that is exactly what the Biden administration endorsed recently in a rule published in the Federal Register aimed at inflicting a critical race theory-inspired curriculum on American schoolchildren.

The rule explicitly cites the New York Times' discredited "1619 Project" as a motivation. The Times has described the goal of its endeavor as the "re-education" of the American people, and the project even includes a lesson plan that encourages students to practice "erasing" parts of the Declaration of Independence. The Biden rule also directly cites a left-wing activist and leading proponent of critical race theory whose textbook states, "The only remedy to past discrimination is present discrimination. The only remedy to present discrimination is future discrimination."

This is what the Biden administration wants to teach America's children.

The Department of Education rule stems from an executive order Biden signed on his first day in office. Biden's order abolished the President's Advisory 1776 Commission I created to honor America's founding principles, and reversed an executive action I took to stop these depraved theories from being imposed upon federal employees in workforce training sessions.

Thankfully, most Americans oppose this insanity. The left has only gotten away with it until this point because not enough parents have been paying attention and speaking up. But that is quickly changing. From Loudoun County, Va., to Cupertino, Calif., parents are beginning to make their voices heard against the left-wing cultural revolution. What they need now is a plan to actually stop it.

Here are the reforms that every concerned parent in America should be demanding.

- First, every state legislature should pass a ban on taxpayer dollars going to any school district or workplace that teaches critical race theory, which inherently violates existing anti-discrimination laws. Inspired by my executive order last year, Florida, Texas, North Carolina, Oklahoma and other states have already taken steps to pass such laws. It needs to happen everywhere—and Congress should seek to institute a federal ban through legislation as well.

- Second, each state should create its own 1776 Commission to examine the public school curriculum and ensure that students are receiving a patriotic, pro-American education—not being taught that the United States is an evil nation.

- Third, parents have a right to know exactly what is being taught to their children. Last year, many parents had the chance to routinely listen in on classes for the first time because of remote learning. As students return to the classroom, states need to pass laws requiring that all lesson plans have to be made available to parents—every handout, article, and reading should be posted on an online portal that allows parents to see what their kids are being taught. Furthermore, in many places, there are rules preventing students from recording what teachers say in class. States and school boards should establish a "Right to Record."

- Fourth, parents need to organize locally—in every school district in America—to eliminate "Action Civics" and other versions of the effort to contort traditional civics education into a vehicle for political indoctrination. The left's

new argument is that our “divisions” stem from a lack of “civics education”—a problem they intend to “fix” with lots of new taxpayer money and a redefinition of “civics” in schools, just as they are trying to redefine the meaning of “infrastructure.” Right now, Congress is working on a \$1 billion bill known as the Civics Secures Democracy Act. No Republican should trust the Biden administration with a billion dollars to spend on such programs. Even worse, the legislation threatens to establish a de facto national curriculum for history and civics, effectively bribing states into adopting the left’s anti-American curriculum. It is Common Core all over again—but much more extreme. And like Common Core, parents must unite to stop this new federal power grab.

■ Fifth, any parent who objects to the material being taught to their child in public school should get an automatic voucher, empowering them to pick another school of their choice. The government has no right to brainwash students with controversial ideologies against their parents’ will.

■ Sixth, states need to take back control of their schools of education and credentialing bodies to ensure they are not churning out radicalized teachers. To be clear, the overwhelming majority of our nation’s teachers are some of the most selfless and wonderful people there are—but regrettably, many have graduated from extremely biased education schools and may not even be aware of the degree to which leftist ideology has permeated their curriculum. States should set up alternative credentialing bodies that can certify great teachers who know how to instill a sense of love for America. School districts can then make it a priority to hire teachers with these certifications, especially for English, history, and social studies roles. States could even set up their own versions of Teach for America to get passionate and patriotic young people into the classroom.

■ Finally, states need to break the tenure monopoly in public K-12 schools. There is a silent epidemic in this country claiming the lives and property of untold numbers of innocent elderly and disabled Americans. It has nothing to do with exotic viruses. In fact, it's a homegrown phenomenon involving corrupt elected officials, judges and lawyers.

The deadly disease running rampant in our court system is probate and guardianship abuse.

This week, the granddaughter of the late iconic singer and songwriter Nina Simone blew the whistle on Vice President Kamala Harris' alleged role in a scheme where the entertainer's estate "was taken away from us" after she died in France in 2003. The battle stretched out over 15 years and was reportedly helmed by Harris while she served as California's attorney general between 2011-2017. In a two-part series of shocking tweets, ReAnna Simone Kelly laid out her family's claims about how Harris "threatened my mother Lisa Simone with jail time before the case was under-way if my mom didn't resign as the Administrator and Trustee of the estate."

Simone Kelly alleged that Harris, who had no legal jurisdiction over Simone's estate overseas, "put out stories about funds being misappropriated which of course, turned out to be totally false as the money she was talking about was used to pay attorneys, accountants and to protect and run the estate." Eventually, the granddaughter recounted, "the law firm that we initially sued for wrongfully filing the estate in the US probate system, in the end, wound up settling with us for a few million dollars."

Simone Kelly wants answers and is urging people in power (that includes you, fellow journalists!) to "ask Kamala Harris why she came for my family ... Ask her why she separated my family ... Ask her why we as her family no longer own the rights to anything. Ask her why she bullied my mother in court and my mom almost killed herself from the depression."

If this all sounds bewildering and unimaginable, you haven't been paying attention. Across the country, judges, prosecutors and other legal cronies have been entangled in nightmare cases involving elderly and disabled citizens who've been stripped of their homes, physically and mentally abused, defrauded and often left to die, according to their families.

"All across America," California nurse and activist Patricia Lacy told me, "vulnerable elders are being placed under fraudulent guardian and conservatorships in an effort to obtain a senior's life savings, property and removal of all their civil rights. They are not even allowed to hire their own attorney but are given a court-appointed attorney, who works in partnership with the opposing party. The guardians, who are supposed to be serving the best interest of the senior, instead use the elder's money to fight against their advanced directives or wishes. The result is usually the elders losing their homes and being placed in lockdown facilities. If a family member complains, the guardianship playbook calls for a court hearing to claim that the family member is 'interfering' and they are then isolated from their loved one."

Lacy is a member of the National Association to Stop Guardianship Abuse. Her beloved father, Stan Zurko, died at the age of 102 last year after a horrific strug-

gle with a public guardian who separated him from family, hid legal documents from him, and withheld medication and living expenses. Lacy sought help from local and county officials in Ventura County, California, who turned a deaf ear and blind eye. Zurko died in May 2020, barred from moving in with his daughter, and gave up “out of despair that no one would hear him or help him,” Lacy said. “He lost his will to live with so many people in court physically, emotionally and financially harming him, until he just gave up and took his last breath.”

The family’s plight is still not over. Zurko’s assets have been liquidated by the conservators, and Lacy is saddled with \$250,000 in legal bills. The allegation that Harris threatened Nina Simone’s family in the battle over her estate will be very familiar to other families who have faced similar intimidation by the Probate Predator Mafia.

“Many family members have been put in jail under false pretenses just to shut them up. My funds are depleted from paying all the expenses and attorneys’ fees. I have all the documents and validation of the abuse to my father, but I can’t hire an attorney with no funds,” Lacy told me. “This is exactly what these predators do—deplete the family of all funds so they will not be sued.”

The system is rigged. Vulnerable victims have little recourse against a cabal of ruthless thieves and grifters in black robes and three-piece suits. The good news is that families are fighting back and opening eyes. The bad news is that too many establishment journalists are more interested in serving as sycophants to elites than defending the helpless. I’ve asked Kamala Harris’ office for comment on the Probate Predator epidemic. How many others will stand up?

In explaining the difference between an asset and an expense, my intermediate accounting professor used the following example. He asked, when you go into a grocery store and buy beer, what is the beer you receive? An asset or an expense? They answer, it’s an asset. After you drink it, it is an expense.

So what does this example have to do with the Biden administration’s plan to invest in the nation’s infrastructure? Plenty. With a little further information, it is the basis for understanding what Congress and the president’s administration can’t seem to understand—government does not make investments. In fact, with very few exceptions, government departments do not record depreciation of anything owned. This is because governmental accounting does not follow Generally Accepted Accounting Principles (GAAP). From the ways in which they handle budgets, you might say, Congress doesn’t even apply simple mathematics.

Governmental accounting follows rules and regulations as defined and proposed by The Governmental Accounting Standards Board (GASB). Our federal government is not very good at following even those standards. Congress



seems to invent rules whenever it wants to—for example, using the Social Security fund as an asset instead of what it is—a liability. You could call it insanity because it is. That’s a subject for another article.

Some time ago, I read the tax proposal of the Ways and Means Committee during the Obama administration. The Republicans had control of the House and the Senate in the 114th Congress, which ended in 2017. The committee’s website stated that it welcomed input from taxpayers. I sent a proposal that recommended a reinstatement of the Investment Tax Credit, first proposed by President Kennedy. It was passed into law with the Revenue Act of 1962. I suggested a few modifications to encourage increased investment in the United States economy. I received a response only from a staffer at my congresswoman’s office and nothing from anyone else. The response was just thank you. Not much else like “we read your proposal.”

There was one major concern I had about the bill as proposed by the Republicans: the unlimited amount of the Section 179 deduction for personal property used in a trade or business. This is another example of Congress making up its own accounting rules that are clear violations of sound accounting practice. While it can be argued that tax accounting is not intended to follow GAAP, extreme deviations from sound finance and accounting practices are what cause major problems in business. Think about Enron and World Com among other recent accounting scandals. The Investment Tax Credit would make for a better tax proposal than raising the ceilings on section 179.

The difference between what the Biden administration and the Democrat-led Congress are proposing, with their so-called “infrastructure bill,” and what the Republicans did with the tax law under President Trump is the difference between an expense and an asset.

In accounting, expenses and assets are both debits. The difference is, the expenses are a debit on the income statement, and assets are a debit on the balance sheet. In other words, one is an investment, and one is an expense. With the Republican bill, the economy of the United States is invested in by the taxpayers; corporations, partnerships, and small businesses. The Democrats’ bill is paid for with government handouts—an expense.

The theory the Democrats are holding to is Keynesian economics, which does work in certain economic situations—like during World War Two. The mechanisms used are investment in infrastructure, unemployment benefits, and education. Even Keynes knew, however, that his theory does not apply universally. For one thing, one of its side-effects is an increase in inflation. We are seeing that already, and we haven’t yet had the spending that is being proposed. The current inflation rate is the highest since 1992.

Keynesian theory has as a premise the idea of stimulating the economy by “priming the pump,” similar to starting a gasoline-powered engine. You add a little to the carburetor to start the engine. If you add too much fuel, the carburetor gets flooded and stalls the engine. The same thing will happen to the economy when it’s flooded with too many dollars: it stalls.



Allowing the private sector to invest in the economy creates assets. With the spending proposed by the Democrats, all that investment will be expensed. Very little will be tangible assets that will continue to supply the economic growth needed to maintain a growing economy. It is the difference between buying a brewery and buying cases of beer. This doesn't even consider the fact that there will be an astronomical amount of debt. Nancy Pelosi apparently is concerned about that only when there is a Republican administration.

With estimates that as much as 95% of Biden's infrastructure bill is going to anything but infrastructure, the money spent on that 95% will end up in the same place as that beer in your refrigerator—after it's been fully expensed. That is not a way to stimulate our current economy. Investment is best when it comes from the private sector.

The KFF Covid-19 Vaccine Monitor is an ongoing research project tracking the public's attitudes and experiences with covid-19 vaccinations. Using a combination of surveys and qualitative research, this project tracks the dynamic nature of public opinion as vaccine development and distribution unfold, including vaccine confidence and acceptance, information needs, trusted messengers and messages, as well as the public's experiences with vaccination.

### **Key Findings**

■ With eligibility for covid-19 vaccination now open to all adults in the U.S., the latest KFF Covid-19 Vaccine Monitor shows that while the pace of vaccine uptake has continued rapidly over the past month, enthusiasm may be reaching a plateau. The share of adults who say they've gotten at least one dose of a vaccine or intend to do so as soon as possible inched up from 61% in March to 64% in April, while the share who want to "wait and see" before getting vaccinated—a group that had been steadily decreasing in size since over several months—remained about the same in April (15%) compared to March (17%). Among Republicans, a group that has been slower to embrace the vaccine, over half now say they've gotten at least one dose or will do so as soon as they can. The share of Republicans who say they will "definitely not" get vaccinated decreased from 29% in March to 20% in April but remains substantially larger than the share among Democrats or independents.

■ In the wake of news about blood clots possibly linked to the Johnson & Johnson covid-19 vaccine and the subsequent pause in the use of this vaccine, less than half the public expresses confidence in the safety of the Johnson & Johnson vaccine, and concerns about potential side effects have increased

among those not yet vaccinated, especially women. Hispanic women are particularly likely to say that the news of these blood clots caused them to rethink their vaccination decision. Despite this, the trajectory of vaccine uptake and enthusiasm does not appear to have slowed disproportionately among women over the past month. Two-thirds (66%) of women say they've been vaccinated or will do so as soon as possible, compared to 63% of men.

- Among those who are open to getting vaccinated but have not yet tried to get an appointment, reasons range from safety concerns to logistical barriers to questions about eligibility, and vary widely by vaccination intention. Those who say they want the vaccine as soon as possible mainly cite logistical concerns and information needs; those in the wait and see group mainly express safety concerns or a lack of research, and those who say they'll get the vaccine only if required mainly say they don't feel they want or need the vaccine. By contrast, when those who say they will "definitely not" get vaccinated are asked if there is anything that might change their mind, the answer is a resounding "no."

- While side effects and safety top the list of concerns for those who haven't gotten vaccinated for covid-19, we continue to find that lack of information and access are barriers for some individuals, particularly people of color. For example, Black and Hispanic adults are more likely than White adults to be concerned about having to miss work due to side effects, having to pay out-of-pocket for the covid-19 vaccine (even though it is free), or not being able to get the vaccine from a place they trust. In addition, 45% of Hispanic adults say they don't have enough information about when they can get vaccinated and a similar share are not sure whether they are currently eligible to receive the vaccine in their state (even though eligibility is now open to all U.S. residents).

- About half of young adults ages 18-29 say they've already gotten at least one dose of a covid-19 vaccine or will do so as soon as possible, but about a quarter say they still want to "wait and see" how the vaccine is working, higher than any other age group. Peer networks may play a role in encouraging vaccine uptake among young adults; those who say at least half of their close friends are vaccinated are much more enthusiastic about getting vaccinated themselves compared to those who say just a few or none of their friends have gotten a shot. In addition, young adults may be more receptive than older adults to vaccination requirements in order to travel or attend large gatherings.

- As the U.S. awaits authorization of a covid-19 vaccine for use in children under age 16, three in ten parents of children ages 12-15 say they will get their child vaccinated as soon as a vaccine is available, one quarter say they will wait a while to see how the vaccine is working, 18% plan to get their child vaccinated if their school requires it, and nearly a quarter say they will definitely not get their child vaccinated. Perhaps unsurprisingly, parents' intentions for vaccinating their kids largely line up with their own intentions for getting the covid-19 vaccine themselves.

### **Confidence and Concerns Following Johnson & Johnson Vaccine Safety Review**

- Majority of U.S. public is confident that covid-19 vaccines are safe, but far fewer express confidence in Johnson & Johnson vaccine.
