Last Wednesday, Glenn Beck, in an impassioned plea to his faithful radio audience, sounded the trumpet for a call to action to save the persecuted Christians in Afghanistan. Working in tandem with the Nazarene fund, Mr. Beck requested his listeners to donate "to the point of hurting" to acquire the planes needed to shuttle Christians out of the chaos of the current Islamic takeover by the Taliban.

Starting with a generous \$100,000, in three short days, Mr. Beck had raised over \$22 million for the Christian organization. Today, they reached the \$30 million mark.

With the donations, Mr. Beck and the Nazarene fund have purchased 20 airliners. But, unfortunately, the movement has been slowed down due to red tape by Joe Biden's U.S. State Department. The Nazarene Fund leapt through all the government's necessary hoops such as; acquiring the personal information and passports for all the Christian refugees, gaining the assent of host countries to accept the Christians (ironically, not including America), providing paperwork in English, Arabic, and other languages for processing, and a slew of other bureaucratic details that hamper the speed of such missions.

■ Despite following all of the U.S. State Department's requests, Glenn Beck explains that "most of the 20 airlines are sitting on the tarmac waiting for the U.S. State Department clearance". They are refusing to allow Afghani Christians to cross the border to another country without their approval.

■ Ironically, the U.S. State Department is flying unvetted Afghani Muslims to America while stopping Christian Afghans from fleeing to other countries willing to give them refuge.

Because of the State Department, the area surrounding the airport has been in chaos. Christian refugees and those Afghani supporters of our American military are not allowed through the airport gate. As a result, flights were grounded for nearly three days. People awaiting a rescue evacuation are now going for nearly a week without food, without water, and without the ability to charge their cell phones, which act as a vital lifeline between them and their families and friends.

Thankfully, on Monday and Tuesday night, the State Department finally approved the Nazarene Fund's first two flights out of Afghanistan. About 1200 Christian refugees were loaded onto the two planes and flown to safety. However, many of the passengers suffering from dehydration needed to wait an additional six hours for IVs and medical supplies before takeoff.

The critical deadline set by the Taliban to remove all Americans from the country is August 31st. On Monday, CIA director William Burns met with Senior Taliban leader Abdul Ghani Baradar in Kabul. Despite their meeting, the Taliban did not extend the timeline for American evacuations was not extended. Baradar was imprisoned for 8 years in a Pakistan prison for his connection with terrorist attacks but was released in 2018.

After the Aug. 31st deadline, the Taliban vows to institute Sharia throughout the country. That means Islamic apostates who converted to Christianity, of which there are over 15,000, will most likely be slaughtered. Women will be required to wear full burkas, covering everything, including a mesh for the eyes, and not allowed outside without a male relative as a guardian. And Americans stranded will be used as bargaining chips to free more terrorists. Already, there are reports of the Taliban going door-to-door in hunt of Christians.

John Weaver, author of the book, *Inside Afghanistan*, says like 'sheep among wolves,' Afghan Christians are under threat of death, and many have already fled their home towns for other cities. The Taliban are looking for people who have left Islam and who are now following Jesus," Weaver explained. "So, it is a desperate time for our brothers and sisters, and we need to stand in prayer with them and advocate for their situation.

The Nazarene Fund now has the capability to fly hundreds of passengers out of Afghanistan every 30 minutes. But due to Biden's anti-Christian and anti-American State Department, that has not been happening.

This week, as President Joe Biden attempted desperately to distract from his ongoing surrender in Afghanistan and the attendant chaos in its wake, the White House turned its eyes once again to the issue of covid-19.

On Monday, Biden pressed private industry to mandate vaccination, stating, "Do what I did last month; require your employees to get vaccinated or face strict requirements." Meanwhile, the ubiquitous Dr. Anthony Fauci told CNN's Anderson Cooper, "I respect people's freedom, but when you're talking about a public health crisis . . . the time has come, enough is enough. We've just got to get people vaccinated."

Meanwhile, the Biden administration also pressed private sector vaccine mandates. Fauci announced on MSNBC that everyone should mask, vaccinated or unvaccinated: "Instead of worrying what kind of mask, just wear a mask. Wear a surgical mask, a cloth mask . . . we need to wear masks." Biden went further, extending his push for masks to small children: "You have the tools to keep your child safer . . . make sure that your child is masked when they leave home."

Put aside the fact that the data support none of these policy prescriptions: There is little evidence that vaccine mandates will push the unvaccinated into overcoming their hesitancy; vaccine mandates are likely to press the unvaccinated into common spaces in which they are *more likely* to transmit the virus to other unvaccinated people, who are in far more danger than the vaccinated; the delta variant, according to former Obama adviser Dr. Michael Osterholm, makes a mockery of cloth masks; according to the University of Waterloo, surgical masks are essentially ineffective against delta; there is literally *zero* data demonstrating that masking children in schools has been effective in reducing transmission of the coronavirus; and children are at exorbitantly low risk from the virus, given that according to the Centers for Disease Control and Prevention, just 361 Americans under age 18 have died of covid-19 during the entirety of the pandemic.

Instead, focus on a simple fact: our pandemic is now officially endless.

At the beginning of the pandemic, we were told to accept lockdown measures in order to prevent our hospitals from being overwhelmed—to flatten the curve. We did so. Then we were told to mask up to prevent transmission of the virus while we developed a vaccine. We did so. Then we were told to wait to unmask and gather in large numbers until after every adult had the opportunity to be vaccinated. We did so.

Now, every adult in America—every person over age 12—has had the ability to get vaccinated. Well over 75% of all Americans aged over 65 have been double-vaccinated. A majority of people in the United States have been double-vaccinated. And yet we are still told that mask mandates are necessary—presumably to prevent those who have already had the opportunity to be vaccinated from contracting covid-19, since the vaccinated are at extremely low risk of hospitalization and death even if a breakthrough infection occurs.

How can this be justified?

On simple logical grounds, it can't. The government has now done all it can to provide protection to those who want it; those who demand government restrictions have provided no metric for success by which proposed restrictions end and we all go back to normal life. Is it deaths? Obviously not: Hawaii has an indoor mask mandate for everyone, despite a seven-day rolling average of two deaths

per day and a population of 1.4 million. Is it hospitalizations? No: Australia is in a state of complete lockdown, despite a grand total of 119 people in the ICU in a country of 25 million people and with baseline ICU bed capacity of at least 2,378. Is it infections? We have no standard by which infectivity level is low enough to go back to normal: Schoolkids are being told to mask despite no evidence that children are at serious risk or are a main vector of transmission.

Which means that zero covid-19 has become the goal.

And that's not a goal; that's a pipe dream.

But that pipe dream means we are stuck in pandemic mindset permanently. There is literally no goal post. Which means that Americans have a choice: either we can choose to live under restrictions forever to prevent a minute risk of post-vaccination hospitalization and death, or we can go back to normal. If we choose to give up our freedom for the chimera that government can end risk entirely, we deserve none of the freedoms we supposedly cherish.

Anecdotes tell us what the data can't: Vaccinated people appear to be getting the coronavirus at a surprisingly high rate. But exactly how often isn't clear, nor is it certain how likely they are to spread the virus to others.

Though it is evident vaccination still provides powerful protection against the virus, there's growing concern that vaccinated people may be more vulnerable to serious illness than previously thought.

There's a dearth of scientific studies with concrete answers, leaving public policy makers and corporate executives to formulate plans based on fragmented information. While some are renewing mask mandates or delaying office reopenings, others cite the lack of clarity to justify staying the course. It can all feel like a mess.

“We have to be humble about what we do know and what we don’t know,” said Tom Frieden, a former director of the Centers for Disease Control and Prevention and the head of the nonprofit Resolve to Save Lives. “There are a few things we can say definitively. One is that this is a hard question to address.”

Absent clear public health messaging, vaccinated people are left confused about how to protect themselves. Just how vulnerable they are is a key variable not just for public health officials trying to figure out, say, when booster shots might be needed, but also to inform decisions about whether to roll back reopenings amid a new wave of the virus. On a smaller scale, the unknowns have left music lovers unsure if it’s OK to see a concert and prompted a fresh round of hang-wringing among parents pondering what school is going to look like.

In lieu of answers, what has emerged is a host of case studies providing somewhat different pictures of breakthrough infections. Variables including when the surveys were conducted, whether the delta variant was present, how much of the population was vaccinated and even what the weather was like at the time make it hard to compare results and suss out patterns. It’s difficult to know which data might ultimately carry more heft.

“It’s quite clear that we have more breakthroughs now,” said Monica Gandhi, an infectious disease expert at the University of California, San Francisco. “We all know someone who has had one. But we don’t have great clinical data.”

One of the best known outbreaks among vaccinated people occurred in the small beach town of Provincetown, Massachusetts, as thousands of vaccinated and unvaccinated alike gathered on dance floors and at house parties over the Fourth of July weekend to celebrate the holiday—and what seemed like a turning point in the pandemic. About three-fourths of the 469 infections were among vaccinated people.

Authors of a CDC case study said this might mean that they were just as likely to transmit Covid-19 as the unvaccinated. Even so, they cautioned, as more people are vaccinated, it’s natural that they would also account for a larger share of Covid-19 infections and this one study was not sufficient to draw any conclusions. The incident prompted the CDC to reverse a recommendation it had issued just a few weeks earlier and once again urge the vaccinated to mask up in certain settings.

Still, the particular details of that cluster of cases may have made that outbreak especially bad, according to Gandhi.

“The rate of mild symptomatic outbreaks in this population was higher because of a lot of indoor activity (including intimacy), rain that weekend, not much outside time and mixture of people with different vaccination status,” she said in an email.

A newly released, far larger CDC case study of infections in New York state, meanwhile, found that the number of breakthrough infections has steadily ticked up since May, accounting for almost 4% of cases by mid-July. Those researchers cautioned that factors such as easing public health restrictions and the rise of the highly contagious delta variant might impact the results.

Yet another CDC case study, in Colorado, found that the breakthrough infection rate in one county, Mesa, was significantly higher than the rest of the state, at 7% versus about 5%. The report suggested it was perhaps because the delta variant was circulating more widely there, but also noted the ages of patients in Mesa and the lower vaccination rate may have played a role.

Research out of Israel seems to back the idea that protection from severe disease wanes in the months after inoculation, and more recently, that breakthrough cases may eventually lead to an uptick in hospitalizations. The information is preliminary and severe breakthrough cases are still rare, but it bolsters the case that some people will need booster shots in coming months.

Case studies and data from some states in the U.S. have similarly shown an increase in breakthrough cases over time. But with the delta variant also on the rise, it's difficult to tell whether waning immunity to any type of coronavirus infection is to blame, or if the vaccinations are particularly ineffective against the delta variant. It could be both, of course. Changing behavior among vaccinated people could be a factor, too, as they return to social gatherings and travel and dining indoors.

All that said, some facts are well established at this point. Vaccinated people infected with the virus are much less likely to need to go to the hospital, much less likely to need intubation and much less likely to die from the illness. There's no doubt that vaccines provide significant protection. But a large proportion of the nation—almost 30% of U.S. adults—have not been vaccinated, a fact that has conspired with the highly contagious delta variant to push the country into a new wave of outbreaks.

"The big picture here is that the vaccines are working and the reason for the spike in the U.S. is we have too little vaccine uptake," Frieden said.

To a certain extent, breakthrough cases of any virus are expected. In clinical trials, no Covid vaccine was 100% effective—even the best vaccines never are. The more the virus is in circulation, the greater the risk of breakthrough cases. It's also common for some aspects of viral immunity to naturally wane over time.

For the time being, there are simply more questions than answers. Are breakthrough infections ticking up because of the delta variant, waning immunity or a return to normal life? Are vaccinated people more vulnerable to severe illness than previously thought? Just how common are breakthrough infections? It's anyone's guess.

"It is generally the case that we have to make public health decisions based on imperfect data," Frieden said. "But there is just a lot we don't know."

Yet the media maintains a blackout on the topic. By comparison, when it became known that an estimated 50 people died after receiving the swine flu shot in 1976, that vaccination campaign was immediately shut down.

- The covid vaccine does not prevent transmission.

As stated in the documentation upon which the U.S. Food and Drug Administration granted EUA status to covid vaccines, and as the Centers for Disease Control and Prevention recently acknowledged to CNN's Wolf Blitzer, covid vaccines do not stop transmission of the virus, one of the chief goals of any vaccine. Shaming the unvaccinated for new covid cases is baseless and dangerously divisive.

- Children are at extremely low risk of death or hospitalization from covid and there is no justification for recommending this vaccine to kids.

The covid survival rate across all age groups is 98.23%. In children it is even higher, at 99.985%.

These statistics call into question the need for widespread covid vaccination of any age group, but especially children who are at such minimal risk from covid.

- Covid vaccines are not helping society reach herd immunity.

It's becoming increasingly apparent that the vaccinated are spreading the virus just as easily as the unvaccinated.

And while the vaccinated are still getting covid, they will become sentenced to a lifetime of booster shots that will continue to cause injuries and deaths like those already reported to VAERS.

Yet the media perpetuates the falsehood that more boosters are the way out of the epidemic—especially now that it's becoming apparent that the original covid vaccines are failing.

■ The origins of covid-19 remain shrouded in secrecy by the media.

Even though Congress has launched an investigation, the media is still providing guidance on the epidemic and covid vaccines based on Dr. Anthony Fauci's recommendations.

As Fauci may well be responsible for funding this dangerous science at the Wuhan Lab, and his vaccine conflicts of interests have come into question, Fauci's ability to lead the response to the epidemic has been compromised beyond repair.

"Human rights guaranteed by the U.S. Constitution and Bill of Rights are being decimated," said Kennedy. "Mandates are morally and spiritually wrong for America and the world. No human should ever be forced or coerced by their employer, school or government to have a medical procedure, including vaccines, against their will."

Kennedy added: "Where is the outcry against this travesty from our leaders and the media? It's time for the media and the public to break free from the Pharma-backed vaccine paradigm and instead embrace the liberty upon which this country was founded."

In an earlier article, I summarized the good news about the covid-19 pandemic. Now, I will attempt to review the Bad and Ugly news about the pandemic.

The mainstream media, some public health authorities, and the pharmaceutical industry have engaged in a massive disinformation campaign. This campaign has focused on using fear to get everyone to take an experimental vaccine as the only way to get out of the pandemic. On Sunday, Biden urged America's employers to make vaccination a condition of employment and expressed a hope that all Americans would be vaccinated.

Why? What is the agenda if vaccinating everyone is not medically necessary? (It is not!)

The Bad

1. The covid-19 death count has been artificially elevated to maximize fear. California's fifth-most populous county revised its covid-19 death count down by 22% after reviewing the cases for the last 18 months. Washington and Minnesota previously also lowered their counts. It is likely that overcounting happened across our country.

2. The PCR test for covid-19 is flawed in many ways and led to overcounting cases. Two weeks ago, the CDC and FDA quietly said they would abandon the PCR test for covid-19 in December 2021, acknowledging it did not work.

They also alluded to the fact that the PCR test could not distinguish between covid and the flu. Did the flu go away last year? No, many cases were counted as covid-19.

The CDC and FDA also now admit that they did not have any physical samples of the covid-19 virus so they used common cold Coronaviruses and human cells to make a less accurate test. Covid-19 testing has been inaccurate and ramped up cases for fear.

3. The new mRNA vaccines are far from safe. While the VAERS reporting system now has over 10,000 deaths (EU 20,000 deaths) after the vaccine, a whistleblower with the CDC says the actual count is closer to 50,000 and not being reported. Adverse reactions, including anaphylaxis, blood clots, neurologic injury, and spontaneous abortion have approached 650,000 patients in the USA. After only eight months of vaccination, longer-term side effects remain unknown. Instead of a push to vaccinate everyone, the vaccination program should be stopped.

4. The mRNA vaccine is not safe in pregnant women. An article in the New England Medical Journal showed a rate of spontaneous abortion of 12% which is close to what is normally expected and the conclusion was the vaccine was safe to give. However, the study was skewed to include mostly women in the third trimester (84%). The remaining women in the 1st and 2nd trimesters had a 75% spontaneous abortion rate (96 out of 127). (See the footnotes to Table 4 in the article). The CDC also tried to hide this. Pregnant women should not take the experimental vaccine.

5. The most prestigious medical journals have been part of the disinformation. The Lancet, the top medical journal in Europe, had to retract a study saying Hydroxychloroquine was not working on covid-19 when it was proved that there was no data for the study. This did not happen by accident.

The Lancet also published a statement signed by several scientists saying the covid-19 virus could not have possibly come from the Wuhan lab. With evidence mounting now that this is exactly what happened the Lancet cannot admit it was wrong. Faith in our medical leaders is waning.

6. Antibody Dependent Enhancement ("ADE") may be happening. One initial concern about making a Coronavirus vaccine was ADE. Now reports are beginning to come in from countries that are heavily vaccinated, such as Israel, that vaccinated people are getting sick and may have more serious illnesses than those not vaccinated. If the death rate of the vaccinated is higher than the unvaccinated this would be very scary.

7. The mRNA vaccines are not 95% effective as touted. Efficacy is likely closer to 40-70% but more data is needed. Reports coming in from Israel and states like Massachusetts show high numbers of vaccinated people (over 50%) in the hospital with covid-19. Those that chose vaccination now looking at endless booster injections (the same vaccine that did not work very well the first time?) every six months (see #3 and #6).

The Ugly

All evidence seems to be pointing to the covid-19 virus being engineered in the Wuhan virology lab and released there. Despite his denials, Dr. Fauci and

our government have been involved in gain of function research for Corona-viruses for a long time.

The response of our government, some health authorities, and the media seems aimed more at social change and control than it is aimed at public health and ending the covid-19 pandemic. It is not about public health and ending the pandemic when you consider the following.

- Faulty PCR testing has been used to inflate cases and maximize fear.

- Death counts from covid-19 were inflated to maximize fear.
