Australian Christian leaders have released an open letter to the Prime Minister entitled *The Ezekiel Declaration*. The letter puts forth a series of principles that makes the case for Christian opposition to the implementation of vaccine passports and other restrictions in Australia.

So far, the letter has been signed by 2,825 church leaders, including more than a dozen Catholic priests and other Catholic leaders, and 18,498 church members and attendees.

### **Against vaccine passports**

The letter is written with the intent of calling to mind the issues that surround the implementation of vaccine passports as they restrict the freedom of conscience of many Christians. The letter states: "We do write, however, to you regarding a matter of significant concern. Namely, the proposed introduction of 'vaccine passports' into Australian society. For many Christian leaders and Christians, this is an untenable proposal that would inflict terrible consequences on our nation."

The declaration puts forth five points that they believe makes mandated vaccinations unacceptable.

- The first point states that there is a risk of creating “an unethical two-tiered society.”
- The second point speaks of burden that many have already faced as a result of lockdown restrictions.
- The third point stressed that “conscience should never be coerced,” and that “the conscience is one of the innermost expressions that animates an individual, and that allows them to worship God as well as obey a legitimate governing authority.”
- The fourth point states that “making vaccination the basis of participating in normal life would make no logical sense in terms of protecting others.”

The letter cites a study from the Centers for Disease Control Prevention (CDC) as evidence: “A CDC study shows 74% of people infected in Massachusetts Covid outbreak were fully vaccinated, especially noting that four of those who were vaccinated were admitted to hospital.” They add, “As it is evident that vaccines do not prevent infection, to restrict a person’s access to society based on a medical choice is questionable.”

- The final point speaks to the concern of the authors that they could be expected to refuse entry into their churches of people who have not been vaccinated.

They say, “as Christian leaders find it untenable that we would be expected to refuse entry into our churches to a subgroup of society based on their medical choice.” They stress that it is their conviction that they have an “obligation to proclaim the Gospel to all men,” and that “to refuse people access to this message would betray our Savior and everything He calls us to uphold.”

### **Against lockdowns and restrictions**

The Australian Christian Lobby [ACL] is also pressuring the government to lift the lockdowns and halt any further mandates or restrictions. In a call to Australians to ask their leaders to “fully restore freedoms,” the ACL highlights a number of issues that they say are indicative of the state of Australia.

- 3,345 suicidal people called LifeLine in a single day recently.
- We are not living—or even leaving the house—for fear of dying.
- Compassion is dead, with wedding plans put on hold and callous disregard for those mourning and separated from loved ones.
- Countless small businesses are finished, each representing people’s livelihoods.
- We are giving up total authoritarian power to state governments.
- Our children simply won’t be able to pay back the debt.

The ACL adds that “Freedom and livelihoods must be restored. We cannot live in fear anymore!”



An article by Paul Elias Alexander Ph.D. titled “The Covid-19 Injection Is Not a Vaccine; Here’s Why” was posted at [lifesitenews.com](https://lifesitenews.com) on Sept. 1, 2021. Following is the article.

For something to be a vaccine, several criteria must be met.

- The injection must provide the recipient antibody immunity to a pathogen (virus or bacterium).
- The antibodies produced post-injection must be shown to confer protection from that virus or bacterium.
- The injection must demonstrate it reduces hospitalizations or deaths from the pathogen.
- The injection must demonstrate it reduces severe symptoms of the pathogen.
- The injection must demonstrate it stops the recipient from carrying the pathogen.
- The injection must show it stops transmission of the pathogen from the injection recipient to others.

Let us examine these criteria further to discuss if they have been met in the case of the coronavirus “vaccine.”

- We have found now that the injection does not confer antibody immunity to the covid-19 virus (SARS-CoV-2); it promotes antibodies to the “synthetic spike protein” that your cells have built. That spike protein is not specific to the SARS-CoV-2 virus.
- The antibodies produced have to give you protection from the pathogen (SARS-CoV-2 virus); this has not been shown in any study to do this. The vaccine developers have stated openly that they do not know if the injection will give protection.
- The injection was not studied to show that it reduces hospitalizations or deaths; the studies conducted did not assess this.
- The injection was not studied to show that it reduces severe symptoms.
- The injection was not studied to show that it stops recipients from carrying the pathogen.
- The injection was not studied to show that it stops transmission from one person to others.

The conclusion, therefore, is no. This injection for covid-19 is not a vaccine; it is best described as a gene-delivery platform.

The studies conducted by the injection developers were not set up to show any of the above six mentioned criterion; these injections for covid-19 do not prevent transmission and were not designed to do this. We were told that the injection developers are measuring to see if the injection “attenuates” symptoms.

We even have clear evidence from the U.S. Centers for Disease Control and Prevention (CDC), which reported on an outbreak of SARS-CoV-2 infections, including covid-19 vaccine breakthrough infections, associated with large public gatherings in Barnstable County, Massachusetts, in July 2021: “469 covid-19 cases were identified among Massachusetts residents who had traveled to the town during July 3–17; 346 (74%) occurred in fully vaccinated

*persons*. Testing identified the Delta variant in 90% of specimens from 133 patients. Cycle threshold values were similar among specimens from patients who were fully vaccinated and those who were not” (emphasis added).

Gazit’s Israeli study (reported on Aug. 25, 2021) may be the nail in the coffin for it shows that “natural immunity confers longer lasting and stronger protection against infection, symptomatic disease and hospitalization caused by the Delta variant of SARS-CoV-2, compared to the BNT162b2 two-dose vaccine-induced immunity.”

The findings suggest that natural infection contributes to far greater immunity than the injection.

Adding to this, an August 10, 2021 LANCET journal publication by Chau et al. looking at transmission of SARS-CoV-2 Delta variant among vaccinated health-care workers in Vietnam, further ransacks the COVID-19 injection landscape and throws it into turmoil in terms of disastrous findings. Sixty-nine healthcare workers who tested positive for SARS-CoV-2. 62 participated in the clinical study. Researchers reported “23 complete-genome sequences were obtained. They all belonged to the Delta variant, and were phylogenetically distinct from the contemporary Delta variant sequences obtained from community transmission cases, suggestive of ongoing transmission between the workers. Viral loads of breakthrough Delta variant infection cases were 251 times higher than those of cases infected with old strains detected between March-April 2020.”

The British Public Health System, Public Health England (PHE), in its latest iteration of the spread and analysis of the “Delta variant” (report 21), throws this injection into more disarray by showing that approximately 60% of the deaths post-Delta variant infection occurred in double-vaccinated persons.

We even have reports now that those who received the third booster shot in Israel have become infected. The injections are not working and some even argue haven’t worked since their inception.

And Gibraltar and Iceland have had 90% of their populations injected, yet have experienced explosive rises in covid-19 infections.

These findings raise very urgent and serious questions for the injection developers and clearly show that the injections have failed.

The authorities involved in the covid-19 injection development even stated that it “may reduce symptoms”; there is no mention that it will stop you from dying from the infection or stop severe symptoms. It was never meant to protect you.

When the media and lead public health officials make these statements, they are being duplicitous and deceitful. The studies post-injection roll-out, that appear to suggest that the shot reduces (stops) transmission are sub-optimal and potentially misleading.

I argue that the RT-PCR test was likely manipulated and adjusted to reduce the cycle count thresholds (Ct) to provide a negative test as needed to show that the injection is working; the Ct can be adjusted during an emergency to an elevated threshold to drive infection counts (most likely false-positive, 90-100%) to “show” that the pandemic is worsening, and then it can be reduced and look like infections are down.

We have no evidence that any of the six criteria that make a vaccine are met. This is not a vaccine and has not been proven to be one, and no amount of wishing or hoping the covid-19 injection is a vaccine can make it one.

Moreover, these injections were sub-optimally studied, particularly when it comes to safety.

We do not have proper duration data to show the safety; we have not "excluded harms" with these injection studies. We have no safety profiles.

Our children must never be injected with these, as we do not know what will happen medium- and long-term. These injections are not needed given our children's near-statistical zero risk of infection, of transmitting the virus, and severe outcome if infected.

You must understand, mRNA technology has never been successfully utilized to show its capacity to reduce the incidence of infectious diseases in human beings, ever! We have no history of this. We do not know what takes place after the lipid nano-particles (LNP) and messenger RNA (mRNA) enter the cells/body. We do not know if the mRNA is "turned off" and spike protein is no longer produced. We do not know where the spike protein goes after being produced and for how long.

The appropriate reproductive toxicity studies, the teratogenicity studies, the pharmacodynamic studies, and the pharmacokinetic studies were not done. The spike protein on the viral ball is the portion of the virus that causes the devastating trauma and illness from severe covid-19. This spike protein is what kills you and devastates your vasculature, ravaging the endothelial layer of the vasculature. End-stage severe covid-19 illness is a blood clotting vascular illness. You do not die when your lungs fail in end-stage covid-19 because there is virus in the lungs. No, you die because of the millions of micro-thrombi (blood clots). The spike protein that our cells produce post injection (though not exactly like the authentic spike protein on the viral ball), is pathogenic and toxic.

It is deadly.

So why would we inject something that causes severe illness (damages our vasculature) if infected, now as part of an effort to inoculate/inject to prevent the severe illness?

This makes absolutely no sense.

Why did the "vaccine" developers use the spike as the target for the immune response when it confers a very narrow "spike-specific" immunity with a very immature immunity library?

A vaccine was never needed for this emergency, and the injections that were produced have now shown themselves to be failing with double-injected persons becoming infected with the Delta variant, with severe adverse effects and even death. This injection program must be stopped so that we can understand why these harms and deaths have accrued.

Any injection program must only be targeted to the highest-risk persons where the risk-benefit calculation skews the decision toward the injection; this injection is completely contra-indicated for children and essentially for all persons under 70 years of age who are not at risk.

Ideally, the injection program must be stopped entirely given what we are seeing.

Shhhhh. The information I'm about to share with you is dangerous and subversive. You cannot publish it on social media platforms without risking scary labels and permanent suspensions. You and anyone you discuss this topic with will be called anti-science "kooks," "conspiracy theorists" or "quacks."

So be it. I've been called every pejorative name in the globalist elites' over-worn handbook of ad hominem attacks over the past 30 years. Who cares?

The airwaves have been littered the past month with disparaging reports about ivermectin, which the U.S. Food and Drug Administration warns should not be used to treat or prevent covid-19. "You are not a horse. You are not a cow. Seriously, y'all. Stop it," the official FDA Twitter account snidely admonished last week.

Well, you are not a sheep either. So don't be cowed by Big Pharma and their bought-off Swamp bureaucrats. Seriously, y'all. These are the performative actors who've flipped and flopped on masks, rushed experimental jabs to market, brazenly denied deadly adverse events and advocated mix-and-match booster shots as part of the most notorious junk science experiment in human history.

First things first: The government and corporate media's repeated description of ivermectin in headline after headline as a "horse de-wormer" is pure propaganda. Yes, it is used as an anti-parasitic for animals. But ivermectin has been used to treat humans for parasitic infections for more than three decades. As Wisconsin critical care specialist Dr. Pierre Kory and his colleagues affiliated with the Memphis VA Medical Center-University of Tennessee, University of Texas Health Science Center, Hackensack School of Medicine and Eastern Virginia Medical School noted in a recent literature review published in the peer-reviewed medical journal the American Journal of Therapeutics:

"Originally introduced as a veterinary drug, (ivermectin) soon made historic impacts in human health, improving the nutrition, general health, and well-being of billions of people worldwide ever since it was first used to treat onchocerciasis (river blindness) in humans in 1988. It proved ideal in many ways, given that it was highly effective, broad-spectrum, safe, well tolerated, and could be easily administered. Although it was used to treat a variety of internal nematode infections, it was most known as the essential mainstay of 2 global disease elimination campaigns that has nearly eliminated the world of two of its most disfiguring and devastating diseases."

That's right. Billions of humans around the world have taken ivermectin (approved by the FDA and considered an "essential medicine" by the World Health Organization) under mass distribution programs to eradicate onchocerciasis (river blindness) and other tropical diseases. Ivermectin has

also been shown to inhibit a broad range of viruses in laboratory studies, including HIV, influenza, West Nile virus and other RNA viruses. In 2018, more than 130,000 patients in the U.S. were prescribed the drug. It is a human drug, no matter how many times the mad cows in the media try to fear-monger you into believing otherwise.

So, should ivermectin be pursued as a treatment or prophylaxis for covid-19?

The covid-19 control freaks don't even want you to ask the question out loud or debate it on the internet. But unlike farm animals, you can exercise your free will and search for the evidence yourselves.

■ A study in the peer-reviewed journal *Antiviral Research* reported that ivermectin inhibited the replication of SARS-CoV-2 in vitro and concluded that "ivermectin is worthy of further consideration as a possible SARS-CoV-2 antiviral."

■ An analysis published in the peer-reviewed *International Journal of Antimicrobial Agents* in November 2020 found that "countries with routine mass drug administration of prophylactic chemotherapy including ivermectin have a significantly lower incidence of covid-19 . . . Prophylactic use of ivermectin against parasitic infections is most common in Africa and we hence show that the reported correlation is highly significant both when compared among African nations as well as in a worldwide context . . . It is suggested that ivermectin be evaluated for potential off-label prophylactic use in certain cases to help bridge the time until a safe and effective vaccine becomes available."

■ A small, pilot, double-blind, placebo-controlled randomized clinical trial conducted in Spain and published in *The Lancet* in January didn't find statistically significant differences in covid-19 viral loads but did find "a marked reduction of self-reported anosmia/hyposmia, a reduction of cough and a tendency to lower viral loads and lower (antibody) titers which warrants assessment in larger trials."

■ A systematic review of ivermectin's antiviral effects published in the peer-reviewed journal *Nature* found that it "could serve as a potential candidate in the treatment of a wide range of viruses including covid-19 as well as other types of positive-sense single-stranded RNA viruses."

■ A study in the peer-reviewed journal *Chest* found statistically significant lower mortality rates among hospitalized covid-19 patients prescribed ivermectin (along with hydroxychloroquine, azithromycin or both) compared with patients without ivermectin in Broward County, Florida.

You can find more related studies on ivermectin and covid-19 in PubMed, the federal scientific database, and weigh all the costs and benefits for you and your families. Remember: "Misinformation" simply means information that the powers that be want you to miss.

Recently, one of Canada's best-known rabbis (an American by birth and a graduate of prestigious colleges in the USA) asked me bluntly and simply to explain the essence of Critical Race Theory. This is what I told him.

Critical Race Theory is the latest version of Marxism, except it has gone racial. This means that unlike traditional Marxist theory, which used to focus on the injustices experienced by working men and women in industrial and industrializing societies around the world and preached violent revolution to overthrow the capitalist democracy that persecutes them, the new victims are any kind of minority, usually people of color, but not exclusively. The "white" working class no longer counts.

In the USA, Cultural Marxists have elected African Americans to fulfill the role of those persecuted by capitalism, which is done by white people or people with white skin (despite the fact that more than 50% of self-defined African Americans belong to the silent, non-protesting, law-abiding middle classes or "bourgeois").

(Historical scholarship and truth are in short supply among the Cultural Marxists).

Old style, traditional Marxists and Leninists like Marx, Lenin, Stalin, Che Guevara, and Fidel Castro believed that the working class around the world would eventually rebel and set up a classless society. That did not happen. Workers in states have shown more loyalty to their nation than their class.

So just after WW II, Cultural Marxists (the Frankfurt School) began a campaign launched from New York City to undermine and subvert the bourgeois values practiced by lawyers, implemented by administrators, and until recently supported by police, the military, the media, and the educational elites. Greek mythology tells the tale of Erysichthon, the powerful King of Thessaly. The story goes that Erysichthon, seeking wood, ordered the trees in a sacred grove to be cut. When his workers refused, fearing divine retribution, he did it himself; for this he was cursed. The curse placed upon Erysichthon was simple: unending hunger. In the end, Erysichthon ended up selling his daughter into slavery for the money to buy more food. Eventually, Erysichthon, lacking the resources to feed himself, ate his own body.

A nation that understands itself—that understands its purpose in the world—flourishes. Such nations, historically, have not shied away from their part on the stage of history. They have recognized a simple truth: In the game of power, vacuums are filled, generally by those who are most aggressive. And thus, surrender of the good means victory for the bad.

Historically, America has understood this. America has always been uncomfortable with the realities of foreign policy but has never shied away from its actual role as a player on the world stage. “Eye on the World” comment: An active nurse (not a family member and not a close friend) somewhere in the United States recently told the publisher of “Eye on the World” that citizens should not trust the numbers reported about covid diagnosis and covid deaths—because there is financial incentive to classify a diagnosis and a death as covid-related. ### **The claim: Hospitals get paid more if patients are listed as covid-19, and on ventilators**

Sen. Scott Jensen, R-Minn., a physician in Minnesota, was interviewed by “The Ingraham Angle” host Laura Ingraham on April 8 on Fox News and claimed hospitals get paid more if Medicare patients are listed as having covid-19 and get three times as much money if they need a ventilator.

The claim was published April 9 by The Spectator, a conservative publication. WorldNetDaily shared it April 10 and, according to Snopes, a related meme was shared on social media in mid-April.

Jensen took it to his own Facebook page April 15, saying, in part:

“How can anyone not believe that increasing the number of covid-19 deaths may create an avenue for states to receive a larger portion of federal dollars. Already some states are complaining that they are not getting enough of the CARES Act dollars because they are having significantly more proportional covid-19 deaths.”

On April 19, he doubled down on his assertion via video on his Facebook page.

Jensen said, “Hospital administrators might well want to see covid-19 attached to a discharge summary or a death certificate. Why? Because if it’s a straight-forward, garden-variety pneumonia that a person is admitted to the hospital for—if they’re Medicare—typically, the diagnosis-related group lump sum payment would be \$5,000. But if it’s covid-19 pneumonia, then it’s \$13,000, and if that covid-19 pneumonia patient ends up on a ventilator, it goes up to \$39,000.”

Jensen clarified in the video that he doesn’t think physicians are “gaming the system” so much as other “players,” such as hospital administrators, who he said may pressure physicians to cite all diagnoses, including “probable” covid-19, on discharge papers or death certificates to get the higher Medicare allocation allowed under the Coronavirus Aid, Relief and Economic Security Act. Past practice, Jensen said, did not include probabilities.

He noted that some states, including his home state of Minnesota, as well as California, list only laboratory-confirmed covid-19 diagnoses. Others, specifically New York, list all presumed cases, which is allowed under guidelines from the Centers for Disease Control and Prevention as of mid-April and which will result in a larger payout.

Jensen said he thinks the overall number of covid-19 cases have been undercounted based on limitations in the number of tests available.

### **Provision in the relief act**

The coronavirus relief legislation created a 20% premium, or add-on, for covid-19 Medicare patients.

There have been no public reports that hospitals are exaggerating covid-19 numbers to receive higher Medicare payments.

Jensen didn’t explicitly make that claim. He simply suggested there is an “avenue” to do so now that “plausible” covid-19, not just laboratory-confirmed, cases can be greenlighted for Medicare payment and eligible for the 20% add-on allowed under the relief act.

The initial \$30 billion—out of \$100 billion—in the grants dedicated to health care providers to address the pandemic was disbursed according to 2019 Medicare reimbursements.

The second wave will focus on providers in areas more heavily affected by the outbreak, according to Kaiser Health News, giving rise to Jensen’s concern that hospitals could exploit the CDC’s guidelines allowing presumed cases.

Jensen did not return an email request from USA TODAY for comment about his claim.

USA TODAY reached out to Marty Makary, a surgeon and professor of health policy and management at Johns Hopkins Bloomberg School of Public Health, about the claim. Makary said in an email April 21 that "what Scott Jensen said sounds right to me."

Makary did not elaborate, answer additional questions or respond to a request for an interview.

USA TODAY reached out to the American Hospital Association and Federation of American Hospitals on April 22, but as of publication had not received a response.

### **How does Medicare pay?**

Snopes investigated the claim, finding it's plausible Medicare pays in the range Jensen mentions but doesn't have a "one-size-fits-all" payment to hospitals for covid-19 patients.

As explained by nurse Elizabeth Davis in her piece for [verywellhealth.com](https://www.verywellhealth.com), each hospital has a base payment rate assigned by Medicare. It takes into account nationwide and regional trends, including labor costs and varying health care resources in each market.

Then, each diagnosis-related group, which classifies various diagnoses into groups and subgroups, is assigned a weight based on the average amount of resources it takes to care for a patient. Those figures are multiplied to determine the payment from Medicare. A hospital in one city and state may be paid more or less for treating a patient than a hospital in another.

PolitiFact reporter Tom Kertscher wrote, "The dollar amounts Jensen cited are roughly what we found in an analysis published April 7 by the Kaiser Family Foundation, a leading source of health information."

Ask FactCheck weighed in April 21: "The figures cited by Jensen generally square with estimated Medicare payments for covid-19 hospitalizations, based on average Medicare payments for patients with similar diagnoses."

Ask FactCheck reporter Angelo Fichera, who interviewed Jensen, noted, "Jensen said he did not think that hospitals were intentionally misclassifying cases for financial reasons. But that's how his comments have been widely interpreted and paraded on social media."

Ask FactCheck's conclusion: "Recent legislation pays hospitals higher Medicare rates for covid-19 patients and treatment, but there is no evidence of fraudulent reporting."

Julie Aultman, a member of the editorial board of the American Medical Association's *Journal of Ethics*, told PolitiFact it is "very unlikely that physicians or hospitals will falsify data or be motivated by money to do so."

### **Our ruling: True**

We rate the claim that hospitals get paid more if patients are listed as covid-19 and on ventilators as TRUE.

Hospitals and doctors do get paid more for Medicare patients diagnosed with covid-19 or if it's considered presumed they have covid-19 absent a laboratory-confirmed test, and three times more if the patients are placed on a ventilator to cover the cost of care and loss of business resulting from a shift in focus to treat covid-19 cases.

The delta variant accounts for more than 80% of the nation's covid-19 cases, the latest data from the Centers for Disease Control and Prevention shows. It's also two times as transmissible as the original strains of the coronavirus.

As cases continue to rise, mask mandates are making a comeback throughout the country. Companies like McDonald's, Apple and Disney have announced a face mask requirement in the past week.

The new guidelines come after the CDC revised its mask guidance, now recommending individuals—even if they're vaccinated—to wear a mask indoors in high transmission areas.

Transmissibility in an area is considered high when there are 100 or more new cases per 100,000 in the past seven days, and 10% or higher positive nucleic acid amplification tests (NAATs) in that period.

Here's what we know about testing for the delta variant.

### **Is there a test for the delta variant?**

There is not a specific test for the delta variant.

However, since the vast majority of covid-19 cases in the U.S. are the delta variant, it's likely a positive test result indicates you could be infected with the delta variant, according to Human and Health Services of Texas.

### **Does a covid-19 test detect the delta variant?**

A viral test, either the nose or throat swab, can detect if you are positive for covid-19. It's not designed to tell you which variant you might be infected with, according to Human and Health Services of Texas.

(Fact check: Genomic sequencing, not PCR testing, detects covid-19 variants.)

### **How do you test for the delta variant?**

To detect the delta variant, a specific type of covid-19 test is required—genomic sequencing.

Genomic sequencing decodes the coronavirus' complete set of genes and searches for new mutations. It also matches known variants.

Labs at some state and local health departments have access to genomic sequencing.

Due to the volume of covid-19 cases, genomic sequencing isn't performed on every test, according to Human and Health Services of Texas, but could be performed on some if a covid-19 test comes back positive. It just depends on where you got the test.

### **Is there a rapid covid-19 test for the delta variant?**

No. Rapid covid-19 tests only detect whether or not you are infected with covid-19, not the specific strain or variant.

A newly published medical study found that infection from covid-19 confers considerably longer-lasting and stronger protection against the Delta variant of the virus than vaccines.

"The natural immune protection that develops after a SARS-CoV-2 infection offers considerably more of a shield against the Delta variant of the pandemic coronavirus than two doses of the Pfizer-BioNTech vaccine, according to a large Israeli study that some scientists wish came with a 'Don't try this at home' label," the *Scientific American* reported Thursday. "The newly released data show people who once had a SARS-CoV-2 infection were much less likely than vaccinated people to get Delta, develop symptoms from it, or become hospitalized with serious covid-19."

Put another way, vaccinated individuals were 27 times more likely to get a symptomatic covid infection than those with natural immunity from covid.

### **A death blow to vaccine passports?**

The findings come as many governments around the world are demanding citizens acquire "vaccine passports" to travel. New York City, France, and the Canadian provinces of Quebec and British Columbia are among those who have recently embraced vaccine passports.

Meanwhile, Australia has floated the idea of making higher vaccination rates a condition of lifting its lockdown in jurisdictions, while President Joe Biden is considering making interstate travel unlawful for people who have not been vaccinated for covid-19.

Vaccine passports are morally dubious for many reasons, not the least of which is that freedom of movement is a basic human right. However, vaccine passports become even more senseless in light of the new findings out of Israel and revelations from the CDC, some say.

Harvard Medical School professor Martin Kulldorff said research showing that natural immunity offers exponentially more protection than vaccines means vaccine passports are both unscientific and discriminatory, since they disproportionately affect working class individuals.

“Prior covid disease (many working class) provides better immunity than vaccines (many professionals), so vaccine mandates are not only scientific nonsense, they are also discriminatory and unethical,” Kulldorff, a biostatistician and epidemiologist, observed on Twitter.

Nor is the study out of Israel a one-off. Media reports show that no fewer than 15 academic studies have found that natural immunity offers immense protection from covid-19.

Moreover, CDC research shows that vaccinated individuals still get infected with covid-19 and carry just as much of the virus in their throat and nasal passage as unvaccinated individuals

“High viral loads suggest an increased risk of transmission and raised concern that, unlike with other variants, vaccinated people infected with Delta can transmit the virus,” CDC Rochelle Director Walensky noted following a Cape Cod outbreak that included mostly vaccinated individuals.

These data suggest that vaccinated individuals are still spreading the virus much like unvaccinated individuals.

### **The bottom line**

Vaccine passports would be immoral and a massive government overreach even in the absence of these findings. There is simply no historical parallel for governments attempting to restrict the movements of healthy people over a respiratory virus in this manner.

Yet the justification for vaccine passports becomes not just wrong but absurd in light of these new revelations.

People who have had covid already have significantly more protection from the virus than people who’ve been vaccinated. Meanwhile, people who’ve not had covid and choose to not get vaccinated may or may not be making an unwise decision. But if they are, they are principally putting only themselves at risk.

Two of the FDA's most senior vaccine leaders are exiting from their positions, raising fresh questions about the Biden administration and the way that it's sidelined the FDA.

Marion Gruber, director of the FDA's Office of Vaccines Research & Review and 32-year veteran of the agency, will leave at the end of October, and OVR deputy director Phil Krause, who's been at FDA for more than a decade, will leave in November. The news, first reported by BioCentury, is a massive blow to confidence in the agency's ability to regulate vaccines.

The bombshell announcement comes at a particularly crucial moment, as boosters and children's shots are being weighed by the regulator. The departures also come as the administration has recently jumped ahead of the FDA's reviews of booster shots, announcing that they might be available by the week of Sept. 20.

FDA's former acting chief scientist Luciana Borio added on Twitter, "FDA is losing two giants who helped bring us many safe and effective vaccines over decades of public service."

"These two are the leaders for Biologic (vaccine) review in the US. They have a great team, but these two are the true leaders of CBER. A huge global loss if they both leave," Former BARDA director Rick Bright wrote, weighing in on the news. "Dr. Gruber is much more than the Director. She is a global leader. Visionary mastermind behind global clinical regulatory science for flu, Ebola, Mers, Zika, Sars-cov-2, many others."
