With all the ominous things taking place in America—and there are certainly quite a few—perhaps none is more ominous than this: Parents are being demonized. Moms and dads have become the enemy. It is now the government (or the education system) vs. those entrusted with raising the next generation. How on earth did this happen? We have certainly come a long way from the days of Father Knows Best—a very long way.

Back in the 1960s, when the generation gap grew large as a result of the counterculture revolution, young people viewed their parents as out of touch, out of step, and out of style. But that was the view of the kids, not the view of the state (or of “the system”). Parental authority remained firmly ensconced when it came to the education of their children.

But that authority has been increasingly challenged in recent decades, with schools hosting GSA (Gay Straight Alliance) clubs, where kids can “come out” to their peers, counselors, and teachers, without their parents knowing. Or where objectionable curricula can be taught at the teacher’s discretion, without parental notification, from K-12.

One mother told me that, without her or her husband’s knowledge, their 16-year-old daughter’s school was about to announce publicly that their daughter was now “he,” with a new name and a new set of pronouns. The parents only found out because they happened to meet with her daughter’s teachers the night before the announcement was planned, having been concerned about the negative influence the school was having on their daughter. How can this be? Who gave the public school system such rights?

Something has been brewing under the surface for some time now, and today, it has reached the boiling point. And the more that parents learn what is really going on, the more they are taking a stand.

The line must be drawn in the sand. If not now, then when?

Back in 2013, atheist biologist Richard Dawkins spoke out against parents “forcing” their religious beliefs on their children—in other words, he spoke out against raising them in the faith.

He said, “What a child should be taught is that religion exists; that some people believe this and some people believe that.”

Yes, he opined, "Forcing a religion on your children is as bad as child abuse." And he added, "There is a value in teaching children about religion. You cannot really appreciate a lot of literature without knowing about religion. But we must not indoctrinate our children."

He followed this up in an interview in 2015, speaking together with physicist Lawrence Krauss at Trinity College in Dublin.

As reported by the Independent, Dawkins "called on schools to protect children from being indoctrinated by their religious parents."

In his words, "There is a balancing act and you have to balance the rights of parents and the rights of children and I think the balance has swung too far towards parents." Really? The balance has swung too much towards parents?

He continued, "Children do need to be protected so that they can have a proper education and not be indoctrinated in whatever religion their parents happen to have been brought up in."

Krauss, himself an atheist as well, agreed with Dawkins, saying, "That means parents have a limited—it seems to be—limited rights in determining what the curriculum is."

In his view, "The state is providing the education, it's trying to make sure all children have equal opportunity. And parents of course have concerns and a say, but they don't have the right to shield their children from knowledge."

Sorry about that, moms and dads. The state knows best. Stay out of the way!

And if some lawmakers in California have their way, you will be told to stay out of the way when it comes to your child's own health, with children as young as 12 forced to receive the COVID-19 vaccination if they want to remain in school.

I ask again: how on earth did this happen?

Perhaps more shocking still was the recent announcement from the Department of Justice that parents who spoke against their school's attempt to indoctrinate their children with radical race ideology could be viewed as "domestic terrorists" guilty of "hate speech." This was now a matter for the FBI.

As expressed by Matt Walsh, "Leftist activists can come to your house with bull-horns. Film you in the bathroom. Loot your business. Burn police stations. The FBI does nothing.

"But if conservative parents raise their voices at a school board meeting, they're hunted down as terrorists.

"The law is dead."

As for those parents who actually made threats against school board members, administrators, or teachers, something that is unacceptable and unjustifiable, why is this a matter for the FBI? And how on earth does this make these overzealous parents "domestic terrorists"?

The bad news is that things are going from bad to worse.

The good news is that, with tens of millions of parents in America, we can say no to these radical and destructive ideas. That doesn't mean with threats of violence or intimidation, God forbid. But it does mean taking principled stands. And if enough parents will stand strong, others will follow.

Looking back to June, a report of a book by Parth Shah, Imani Thornton, Danielle Turrin and John E. Hipskind titled "Informed Consent" was posted at ncbi.nlm.nih.gov (National Center for Biotechnology Information) on June 14, 2021. Following are excerpts of the report.

Introduction

Informed consent is the process in which a health care provider educates a patient about the risks, benefits, and alternatives of a given procedure or intervention. The patient must be competent to make a voluntary decision about whether to undergo the procedure or intervention. Informed consent is both an ethical and legal obligation of medical practitioners in the US and originates from the patient's right to direct what happens to their body. Implicit in providing informed consent is an assessment of the patient's understanding, rendering an actual recommendation, and documentation of the process.

The Joint Commission requires documentation of all the elements of informed consent "in a form, progress notes or elsewhere in the record." The following are the required elements for documentation of the informed consent discussion.

- The nature of the procedure
- The risks and benefits and the procedure
- Reasonable alternatives
- Risks and benefits of alternatives
- Assessment of the patient's understanding of 4 elements listed above

It is the obligation of the provider to make it clear that the patient is participating in the decision-making process and avoid making the patient feel forced to agree to with the provider. The provider must make a recommendation and provide their reasoning for said recommendation.

Issues of Concern

- Adequacy of Informed Consent

The required standard for informed consent is determined by the state. The three acceptable legal approaches to adequate informed consent are (1) Subjective

standard: *What would this patient need to know and understand to make an informed decision?* (2) *Reasonable patient standard: What would the average patient need to know to be an informed participant in the decision?* (3) *Reasonable physician standard: What would a typical physician say about this procedure?*

Many states use the “reasonable patient standard” because it focuses on what a typical patient would need to know to understand the decision at hand. However, it is the sole obligation of the provider to determine which approach is appropriate for a given situation.

■ Exceptions to Informed Consent

Several exceptions to the requirement for informed consent include (1) the patient is incapacitated, (2) life-threatening emergencies with inadequate time to obtain consent, and (3) voluntary waived consent.

If the patient’s ability to make decisions is questioned or unclear, an evaluation by a psychiatrist to determine competency may be requested. A situation may arise in which a patient cannot make decisions independently but has not designated a decision-maker. In this instance, the hierarchy of decision-makers, which is determined by each state’s laws, must be sought to determine the next legal surrogate decision-maker. If this is unsuccessful, a legal guardian may need to be appointed by the court.

■ Children and Informed Consent

Children (typically under 17) cannot provide informed consent. As such, parents must permit treatments or interventions. In this case, it is not termed “informed consent” but “informed permission.” An exception to this rule is a legally emancipated child who may provide informed consent for himself. Some, but not all, examples of an emancipated minor include minors who are (1) under 18 and married, (2) serving in the military, (3) able to prove financial independence or (4) mothers of children (married or not). Legislation regarding minors and informed consent is state-based as well. It is important to understand the state laws.

■ Informed Consent for Blood Transfusion

Informed consent is essential to patient autonomy. Informed consent requires a thorough understanding of transfusions and the ability to convey this information to a patient in a way that they can understand it. However, obtaining consent often has deficiencies in the explanation where benefits may not be entirely true and risks related are omitted. It has been shown that involving experts from transfusion units in obtaining informed consent for transfusion results in patients having a better understanding of the risks and benefits. However, always involving an expert may not be the most efficient way to obtain consent, although new graduate physicians have a knowledge deficit when it comes to transfusion medicine. However, physicians that had previous transfusion medicine education displayed more understanding than those who did not. As most physicians will need to obtain informed consent for a transfusion at one point in their career, it could be argued that physicians should have enough education in regards to transfusion medicine.

Clinical Significance

Informed consent is required for many aspects of health care. These include the following.

1. Treatment
2. Dissemination of patient information
3. Discussion of HIPPA laws
4. Specific procedures
5. Surgery
6. Blood transfusions
7. Anesthesia

Obtaining informed consent in medicine is a process that should include the following.

- Describing the proposed intervention
- Emphasizing the patient's role in decision-making
- Discussing alternatives to the proposed intervention
- Discussing the risks of the proposed intervention
- Eliciting the patient's preference (usually by signature)

Discussion of all risks is paramount to informed consent in this context. Most consent includes general risks, risks specific to the procedure, risks of no treatment and alternatives to treatment. Additionally, many consent forms express that there are no guarantees that the proposed procedure will provide a cure to the problem being addressed.

Patient safety is a major focus in health care, and effective informed consent is considered a patient safety issue. The Joint Commission recently addressed the challenges to ensuring effective informed consent. The emphasis of a patient signature as an indication of understanding is being called into question. The process of informed consent is shifting to focus more on communication and less on signatures. Studies of informed consent have found that there are many barriers to obtaining effective informed consent. One major barrier is that some consent forms contain language that is at too high a reading level for many patients. Use of visual and digital communication tools is being encouraged to address some the inefficiencies in the process of obtaining consent. Patients should be actively engaged as a way to enhance communication and ensure patient safety and understanding.

Informed consent may be waived in emergency situations if there is no time to obtain consent or if the patient is unable to communicate and no surrogate decision maker is available. Also, not every procedure requires explicit informed consent. For example taking a patient's blood pressure is a part of many medical treatments. However, a discussion regarding the risks and benefits of using a sphygmomanometer usually is not required.

Shared Decision Making

Informed consent is a collaborative process allowing patients and healthcare providers to make decisions together when more than one reasonable alter-

native exists, accounting for the patient's unique preferences and priorities and the best scientific evidence available.

It is most appropriate in weighing the benefits and harms of invasive procedures, computed tomography (CT), and post-ED disposition including the use of thrombolytics for acute ischemic stroke, lumbar puncture to rule out subarachnoid hemorrhage, and CT for minor pediatric head injuries.

Shared decision-making (SDM) challenges in Emergency Medicine include patient, provider, system and evidence level limitations. Examples include: (1) if patients are capable of or willing to engage in decision making (2) if providers feel it provides more or less medico-legal protection, (3) if the Emergency Department is overwhelmed and time is of the essence to make decisions, and (4) if the facility lacks well-validated risk prediction tools to guide decision making.

The Vaccine Adverse Event Reporting System (VAERS) was established in 1990 and is managed by both the Centers for Disease Control and Prevention (CDC) and the Food and Drug Administration (FDA) as a way to collect information about harmful side effects potentially caused by vaccinations. It's meant to serve as a sort of "early warning system" so healthcare professionals can pivot in the event a vaccine causes unforeseen damage to patients.

When this happens, and it occasionally does with all vaccines, the National Vaccine Injury Compensation Program (VICP) provides a claims procedure to potentially provide compensation for those who are injured. The law under which the VICP was created—the National Childhood Vaccine Injury Act (NCVIA)—also conveniently shields vaccine manufacturers from liability for their products. (I say "conveniently" because it's certainly convenient for vaccine makers, but I also somewhat understand the logic, since vaccine makers would be hesitant to produce anything at all if they were held financially liable for anything and everything that went wrong even after FDA approval of their products.)

Of course, simply looking at VAERS data and assuming at face value that every single entry was directly caused by the vaccination in question is problematic for several reasons that begin with the fact that literally anyone, including patients and parents, can claim anything they wish. However, intentionally filing a false VAERS report is against Federal law and punishable by fine and imprisonment. Additionally, healthcare providers and vaccine manufacturers are also required to submit any adverse events they run into to the database. In other words, not every VAERS claim is some whack job insisting a vaccine turned him into the Incredible Hulk. Yes, that happened (the claim, not the metamorphosis). Some, if not most, of them are quite real.

Still, the vaccine cultists consistently use obviously wrong entries—such as the example of a woman in her 50s who died after a motorcycle accident but was incorrectly included in VAERS simply because she had recently received the Moderna coronavirus vaccine—to discredit all of them and give the impression, though they are careful to no longer specifically say it, that the Covid vaccines are ‘100% safe and effective.’

“All those reported deaths are not from the vaccine, instead, they are all reported deaths of people that got the vaccine,” reads this CBS report, the author of which is undoubtedly unaware of the ironic fact that Covid realists have been pointing this out about Covid deaths for almost two years. One thing doesn’t necessarily follow the other. However, sometimes it does. Sometimes people die FROM Covid, and sometimes people die FROM a vaccine. - No medical treatment, vaccines included, comes without risk.

- And even when vaccines have been mandated, there have typically been easily obtainable exemptions.

To lend some perspective, suppose you are the owner of a company with ten employees. You force your workers to get a vaccine, then one of them dies because the vaccine you required them to get reacts badly to a preexisting condition that worker unknowingly had. Sure, the odds were low that it would happen, but it did, and it happened to your employee. Would you feel guilty about that? I know I would, especially if I had mandated the vaccine to ‘fight’ a virus that posed little to no statistical risk to that employee.

As I’ve stated many times, it would be one thing if the following were true.

- If this were a super deadly disease
- If the vaccines produced far significantly fewer side effects than these do.
- If they actually were sterile, eliminating contraction and transmission.

If there were another smallpox-like disease, for example, with a 30% fatality rate and a readily available vaccine that eliminated it, I suspect Congress and the president would have zero trouble passing a nationwide vaccine mandate instantly, and that it would hold up in court. You know, a real law rather than color of law and obscure regulations and leaning on private businesses to do their dirty work for them. What’s more, they probably wouldn’t have to, because 99% of Americans would probably be lining up and begging for the shot.

But sadly, none of that is the case here, is it? Instead, we're stuck with a product that is showing itself to be increasingly inferior week by week. Already, the fact that Pfizer's vaccine wanes significantly after just 6 months has made national news, and I suspect that's just the tip of the coming iceberg. Given this shoddy performance, nobody in their right mind has any business forcing or coercing anyone else to get a potentially dangerous jab that only provides limited protection for the individual receiving it for a few months at best. It's absolutely insane, yet it's where we are right now.

■ And please, don't insult my intelligence by saying people aren't technically being "forced" into taking the vaccine. When you threaten people's livelihoods, their ability to travel, and even their right to function normally in society, you are for all intents and purposes "forcing" them to acquiesce to your demands.

■ Should employees who suffer adverse side effects after being coerced into taking the shot by their employer claim worker's compensation? Absolutely they should, and they generally will be on solid ground.

But it's deeper than that. In a just world, someone who causes someone else's death, even indirectly, would face serious civil and even criminal penalties. In a just world, people forcing this shot on others who are then seriously harmed or killed would face a Nuremberg-style trial followed by swift justice after a guilty verdict.

■ Am I saying that Covid vaccine mandaters should face prison time for their nefarious acts, which also include willingly and maliciously denying early treatment and cheap & easily obtainable medications to Covid sufferers until they are literally in a hospital bed on death's door? Absolutely and unequivocally, yes, that's exactly what I'm saying.

It's one thing to recommend a medical intervention and even make the pitch that it's better than the alternative, especially to those at-risk groups to whom the 'alternative' is grim. If people then willingly 'buy' it, they are assuming their own risk after having studied all possible outcomes. You know, 'informed consent' and all that. But when you delve into force and coercion, you are morally, and you should be legally, responsible for anything negative that ensues. Full stop.

Sadly, right now we do not live in a sane nor a just world, but these monsters fully deserve the justice that such a society would impose on them. They are evil, soulless ghouls, and they should be behind bars for the rest of their lives. Someday, if the world ever returns to sanity, perhaps they will be.

Yes, the Kamala cackle is incredibly annoying. It's one of the reasons why she was the first to drop out of the Democrats' presidential nomination derby. But it looks as though a semi-successful effort to train her out of it has backfired.

The Democrats briefly thought that maybe, just maybe Kamala Harris would grow out of her repulsiveness and somehow rescue them from the doom that Joe Biden's deteriorating mental faculties portend for the party (and, incidentally, the nation). Four days ago, The Hill optimistically headlined, "Democrats see Harris as major player in midterms," to which many conservatives (including me) reacted with the Dirty Harry catchphrase, "Go ahead, make my day."

The same website, The Hill, reported Thursday, "Vice President Harris has rebounded in recent weeks, regaining her footing with approval ratings that now stand higher than President Biden's."

That's not too hard to do when Biden's poll ratings are plummeting. The same article, 19 paragraphs into the body of it, admitted: "To be sure, Harris's polling numbers are not spectacular. The same Gallup poll that showed her with a 49 percent approval rating showed she had a 49 percent disapproval rating."

But it failed to note that Harris's rise in the polls has coincided with relatively little about her appearing in the media. She hasn't been subjected to "the lid" the way Biden is when he loses all lucidity, but when it comes to Kamala's visibility and popularity, Mies van der Rohe's axiom on modernist architecture applies: "Less is more."

That strategy unexpectedly fell apart Tuesday [Sept. 28] when she made what was intended to be an uncontroversial visit to George Mason University to discuss "voting rights." It should have been a safe topic for her. Lots of canned phrases such as "voter suppression" and students at a second-tier state university shouldn't be expected to pose really difficult questions.

But Kamala forgot to cackle when a female student launched an attack on Israel for "ethnic genocide" and claimed she needed to raise the issue because "it affects my life and people I care about's lives."

I am fairly sure Kamala has had advanced behavioral training to suppress her cackle under stress because it is so very annoying and insincere. But the problem is that there was a function to it—it provided a release of her stress and allowed a little extra time to think over what she should say. Not that she was capable of using that time wisely. But lacking that margin, she committed a major blunder and, after nodding along with the student's attack, said: "I'm glad you did [raise her points]. And again, this is about the fact that your voice, your perspective, your experience, your truth, should not be suppressed and it must be heard, right? And one of the things we're fighting for in a democracy, right."

The student said nothing about her views being suppressed, and anyone who observes life on all but a handful of college campuses knows that it is not left-wing attacks on Israel that are suppressed these days, but rather pro-Israel and conservative points in view that face censorship. So Kamala went off on a tangent.

But she also by nodding along, saying she was "glad" and failing to contest anything the student said while decrying the nonexistent suppression of her views, implicitly endorsed what she said ("your truth"). It wasn't just supporters of Israel who noticed.

Let the wicked forsake his way, and the unrighteous man his thoughts; let him return to the LORD, and He will have mercy on him; and to our God, for He will abundantly pardon. ‘For My thoughts are not your thoughts, nor are your ways My ways,’ says the LORD. For as the heavens are higher than the earth, so are My ways higher than your ways, and My thoughts than your thoughts. For as the rain comes down, and the snow from heaven, and do not return there, but water the earth, and make it bring forth and bud, that it may give seed to the sower and bread to the eater, so shall My word be that goes forth from My mouth; it shall not return to Me void, but it shall accomplish what I please, and it shall prosper in the thing for which I sent it.”
