Communist leader Vladimir Ilyich Ulyanov, aka Vladimir Ilyich Lenin, is reputed to have said, "The capitalists will sell us the rope with which we will hang them."

Whether Lenin said this or not, the message is prophetic. For the sake of cheap labor, some large corporations in America are selling the United States down the river, and they have the cooperation of President Joe Biden's administration in doing so. This is the 2021 version of "The Devil and Daniel Webster," except, this time, "Old Scratch" is not Satan; it's the People's Republic of China.

For years, the PRC has been stealing—mostly from the U.S.—technologies it needs to gain economic and military superiority over America and our Western allies. Under the Biden administration, China need not trouble itself with stealing. American companies are licensing critical technologies to the PRC and contracting with Chinese companies to manufacture essential goods. The previous administration took a strong stand against China's efforts to gain world dominance economically and militarily, but the Biden administration seems either unconcerned about the issue or at a loss as to what to do about it.

One example of an American company making a deal with the devil is the establishment of a new, wholly owned, onshore mutual-fund business in the PRC by BlackRock, an American investment firm in New York City. This is a classic example of letting a fox guard the proverbial hen house.

Access to America's economic hen house is through Wall Street, and BlackRock just gave the PRC a key to the gate. Giving Xi Jinping's PRC access to Wall Street gives "America's number one adversary" access to invaluable data about our nation's businesses, information which will be used to gain advantage over American firms and undermine our economy. We warn of this kind of thing, "unarmed warfare," in our book, "We Didn't Fight For Socialism: America's Veterans Speak Up."

On the subject of warfare, those who doubt the PRC's ability to reverse engineer the technologies it licenses and steals from the U.S. should consider its development of a hypersonic nuclear missile. A hypersonic missile travels at more than five times the speed of sound, making a "swarm" of these weapons impossible to interdict by current U.S. intercontinental ballistic missile defense systems. In congressional hearings, the Pentagon has warned China launched such a missile in August 2021. The U.S. currently has no defense against such a missile and is far behind developing our own hypersonic missiles or defenses against them.

The PRC's next step in their strategy for becoming the world's strongest superpower is the semiconductor industry. The PRC is now stealing and "licensing" skills necessary to rapidly develop its own advanced microchips and semiconductors.

These are the most essential components in all electronic devices from toasters to trucks, autos and military hardware, including hypersonic missiles.

The PRC currently manufactures semiconductors, but it relies on Western technologies to do so. China must import most of the equipment and materials needed to produce microchips. Much of this essential technology comes from the U.S. The PRC's near-term inability to manufacture these devices in sufficient quality and quantity is just one more reason the Chinese Communist Party is casting covetous glances at Taiwan. Together, Taiwan and South Korea manufacture more than 70% of the world's semiconductors.

Jinping's hypersonic missiles and his goal of having the PRC dominate global semiconductor production didn't make it on the agenda at last week's G-20 "hydrocarbon summit" in Rome. He didn't bother to attend.

In July The National Interest published an essay entitled "Can America Lose to China?" written by Kishore Mahbubani, a fellow at the National University of Singapore's Asia Research Institute and a former Singapore UN ambassador.

The essay focuses on the China-U.S. political, economic and social competition. Mahbubani begins with an observation: Americans believe “an open society like America has many natural advantages” over China’s autocracy. By assuming inherent advantage, “Americans cannot even conceive of the possibility of losing out to China.”

That may well be true, though not quite in the way he frames the problem.

I disagree with several of Mahbubani’s subsequent points. He believes the U.S. should reintegrate its economy with China’s. Sure, trade is beneficial, but U.S. overreliance on China is a strategic error. Fair trade does not exist when dictatorial whim rigs contracts and court decisions.

At times he portrays Beijing as relatively benign and misunderstood. He says the U.S. can get along with China as long as it “doesn’t disrupt the world order.”

Disruption is Beijing’s business. China has encroached on the Philippines’ maritime exclusive economic zone. (See the 2016 Hague Court of Arbitration ruling.) Vietnam has repeatedly confronted Chinese drilling rigs and “sea militia” boats invading internationally recognized Vietnamese waters. Indian and Chinese forces skirmish in the Himalayas and have since 1962.

Prominent Americans have contemplated losing the economic and political competition with China, with a resulting loss in wealth and diplomatic clout. Mahbubani clearly despises former President Donald Trump. Perhaps faculty club virtue-signaling blinds him to an obvious truth: Trump saw and still sees the possibility of losing to China.

Still, the ambassador deserves credit for recognizing a failure to contemplate uncomfortable alternative futures. I frame it this way: The majority of the American public and national leaders have yet to think about the consequences of losing a major war to China.

The Pentagon concentrates on military deterrence and, failing that, winning in combat. For seven decades U.S. and allied planners have conducted war games examining “what ifs” in a Taiwan Strait conflict and other east Asian scenarios.

In the last decade several games have examined a shooting (kinetic) war in the western Pacific and Asian littoral pitting the U.S. and allies against China. Occasionally Russian forces cooperate with China.

The Pentagon acknowledges conducting several classified war games in 2020. In March 2021 Yahoo News discussed one of them, a U.S. Air Force war game in the 2030 time frame. The scenario began with “a Chinese biological-weapon attack that swept through U.S. bases and warships in the Indo-Pacific region.” A Chinese military exercise camouflaged “the deployment of a massive invasion force,” which launched a lightning “assault on the island of Taiwan.”

Chinese missiles struck “U.S. bases and warships” throughout the region.

Yahoo quoted U.S. Air Force Lt. Gen. S. Clinton Hinote: “The (game’s) definitive answer if the U.S. military doesn’t change course is that we’re going to lose fast.”

Hinote added “More than a decade ago, our war games indicated that the Chinese were doing a good job of investing in military capabilities that would make our preferred model of expeditionary warfare, where we push forces forward and operate out of relatively safe bases and sanctuaries, increasingly difficult.”

Hinote didn’t discuss America’s loss in ships and planes and killed, wounded and captured personnel. But clearly America lost the simulated military campaign.

If China took Taiwan, then it would have achieved a major CCP goal, one with horrifying real-world military, diplomatic, economic and territorial consequences.

It is foolish to believe an intense war involving China and the U.S. would be confined to the Taiwan Strait and end with Taiwan’s loss. In the scenario, missiles hit regional U.S. bases—meaning Japan, South Korea, Guam, perhaps Australia, Singapore and Hawaii.

Go a step farther. What keeps this western Pacific war from escalating to a war for national survival?

Next week’s column will examine several very uncomfortable consequences of America losing a war to China. One scenario has war erupting before the 2024 U.S. national election.

In July Japan’s Vice Defense Minister Yasuhide Nakayama told the Hudson Institute that China and Russia could launch a surprise “Pearl Harbor-style attack” in the Pacific. The Washington Examiner and Reuters quoted Nakayama as insisting the U.S. and Japan must demonstrate the will to deter both China and Russia because “they are doing their (military) exercises together.” They conduct exercises from “Honolulu to Japan,” which means America’s “protection line is going . . . backwards . . .”

Nakayama said China would likely target Taiwan. But that threatens Okinawa (a Japanese island with U.S. bases). Mid-Pacific exercises demonstrate targeting Hawaii and the West Coast, so he couldn’t rule out an attack on Hawaii reprising 1941 but employing 21st-century weaponry. In 1941 Japan also attacked the Philippines and Southeast Asia—a multi-pronged strategic offensive.

Nakayama called Chinese President Xi Jinping’s regime “aggressive . . . (in) thought and will . . . So wake up. We have to wake up.”

I agree. In last week’s column I argued it’s “foolish to believe an intense war involving China and the U.S. would be confined to the Taiwan Straits and end with Taiwan’s loss.” Chinese anti-ship and land-attack missiles can reach the eastern Pacific. In a recent Pentagon war game, Chinese missiles hit region-

al U.S. bases—meaning they hit Japan, South Korea and Guam and perhaps Australia, Singapore and Hawaii.

China has territorial goals. China wants to move through the “first island chain” (southern Japan to Borneo). That means seizing Taiwan. China also targets the “second island chain” from the east coast of Honshu (Tokyo’s location) through Guam to New Guinea.

Note: Guam is sovereign U.S. territory. Like California and Vermont.

Communist China is conducting “military preparation of the battlefield” operations on four fronts, three in the Pacific.

- No. 1: In the Himalayas confronting India, Chinese road crews inch forward—supply routes for a subcontinent war.
- No. 2: China’s artificial islands in the South China Sea (west Pacific) step toward Singapore, the Straits of Malacca and the Indian Ocean.
- No. 3: Chinese forces routinely probe neighboring air and sea spaces. The most provocative probe Taiwan and Japan.
- No. 4: Chinese diplomats seek bases worldwide but especially Pacific bases. In 2019 Kiribati cut diplomatic ties with Taiwan. Now China intends to upgrade Kiribati’s airfields—1,800 miles from Hawaii.

What’s the time frame for triggering this war? In 1992/93, the late director of the Secretary of Defense’s Office of Net Assessments, Andrew Marshall, gave his consultants a long-term thought experiment: How could the U.S. fight and win a war for national survival against China circa 2020 or 2025?

Yes, chillingly prescient. What keeps a Taiwan or western Pacific war with China from escalating to a war for national survival?

Nothing—which is why China must either be deterred or stopped cold if it attacks Taiwan.

Three factors suggest China might strike in 2023 or election year 2024.

- No. 1: The Biden administration is incompetent. Its Afghanistan debacle created serious concerns about U.S. reliability.
- No. 2: Division erodes American public will to resist. A hot-button example: morale-sapping faculty club nostrums like “critical race theory” (recast Marxist tribalism) being imposed on the military. Will matters. Prussian strategic theorist Carl von Clausewitz called war a clash of wills.
- No. 3: The U.S. has no immediate counter for China’s Anti-Access/Area Denial strategy that threatens U.S. carrier battle groups with destruction as they move to the western Pacific. The U.S. Navy can’t risk losing carriers.

If China quickly wins the big Taiwan battle and breaks out, what could be lost? Here’s a list of terrible consequences to mull. Okinawa—Japanese territory lost to China. Beijing neutralizes Singapore, gaining control of the primary route to the Indian Ocean. South Korea, Japan and Australia are isolated.

If China says it will nuke California unless the U.S. gives up Guam, what do characters like President Joe Biden and Secretary of State Antony Blinken say? Is Beijing making an offer political hacks can't refuse?

We can deter China—if we don't project weakness. The Navy's 2021 fleet battle problem and the Army's long-range fires concept are examples of creative military operational concepts that can defeat China. What we could use are several score small, cheap ships armed with weapons to suppress Chinese shore-based firepower so the carriers can deliver a coup de grace.

A British leftist group calling itself the Center for Countering Digital Hate has issued a report on what it calls the "Toxic Ten," which are so-called fringe websites spreading "climate change denial." The ten include our group, the Media Research Center, as well as Breitbart, The Daily Wire, Townhall Media, Newsmax, The Washington Times and The Western Journal.

So, any challenge to Greenpeace climate-crackdown orthodoxy is now classified as "toxic" and "digital hate."

Their solution? To press Facebook and Google to "stop monetizing" these conservative sites, stop allowing them to buy ads and to "comprehensively label" their climate reporting as misinformation. You don't have to prove conservatives wrong. Just "comprehensively label" them as false.

Once again, the left wants to win debates by stopping any debate from happening. The founder of this "Digital Hate" squad is a man named Imran Ahmed, who previously co-authored the book "The New Serfdom: The Triumph of Conservative Ideas and How to Defeat Them," with Angela Eagle, a Labour Party member of Parliament.

Ahmed can already count on jihad from the "objective media." Their British socialist friends at The Guardian awarded their report with the headline "'Super polluters': the top 10 publishers denying the climate crisis on Facebook."

Offering any criticism of climate panic (and climate policy) is "super polluting." Does this sound like science, or does it sound like political hyperbole? Naturally, Ahmed told The Guardian, "big tech is once again on the wrong side of science, truth and human progress."

The Washington Post also provided a pliant piece headlined "Breitbart has outsized influence over climate change denial on Facebook, report says." Tech reporter Cat Zakrzewski warned, "The far-right news and commentary site is one of just 10 publishers responsible for nearly 70 percent of interactions with climate change denial content on Facebook."

On Twitter, Zakrzewski gushed, “The nonprofit has been effective in drawing policymakers’ attention to falsehoods on social media, as it did with its ‘disinformation dozen’ report earlier this year.”

The Post reporter avoided any evidence of “falsehoods” by engaging with conservative articles. She blithely wrote that, “For years, Facebook has faced pressure to issue a broad ban on climate misinformation,” and that somehow doesn’t strike her as distasteful censorship.

My column on ClimateDepot founder Marc Morano’s book “Green Fraud” was pictured under the Daily Wire section of the report. The MRC section is illustrated with a Joseph Vazquez article on NewsBusters about . . . Marc Morano. He’s apparently Digital Hater No. 1.

In my Morano column, I noted that the climate panic lobby is never held accountable for failed predictions of doom from decades ago. In one PBS series called “Race to Save the Planet,” Meryl Streep claimed, “By the year 2000—that’s less than 10 years away—the earth’s climate will be warmer than it’s been in over 100,000 years. If we don’t do something, there’ll be enormous calamities in a very short time.”

In 2021, that can be defined as climate misinformation.

But panic helps Democrats sell a crackdown. The Post story quoted Sen. Sheldon “Whites Only” Whitehouse complaining, “Facebook and other social media companies make money when they send users down rabbit holes of climate change denial. That’s a very dangerous business model for the future of the planet.”

Apparently, the “business model” is this: Only the leftists get to talk on climate policy; everyone else should be suppressed. No one is allowed to question the failed predictions and overwrought “solutions” of climate experts like Greta Thunberg and Alexandria Ocasio-Cortez.

The Washington Post should embrace their business model with the slogan “Climate Democracy Dies in Darkness.”

Primarily because the global climate debate has become wholly a matter of belief (whether you believe or doubt the gospel of climate change and imminent climate catastrophe), the church of climate change has promoted its theology by falsifying and suppressing facts about the climate in the world we live in.

This is reminiscent of the tactics of the old religions, which incorporated into their teachings discredited representations of the universe such as belief in a flat earth.

It requires religious fervor to believe that the climate debate is closed and settled in favor of their theology.

It's time to describe as "obscurantism" the tactic of climate change fanatics to proclaim to the world that the climate debate is closed and then, in the same breath, suppress facts and opinions that suggest the contrary.

In the 18th century, Enlightenment philosophers applied the term obscurantist to any enemy of intellectual enlightenment and the liberal diffusion of knowledge. In the 19th century, in distinguishing the varieties of obscurantism found in metaphysics and theology and modern philosophical skepticism, Friedrich Nietzsche said: "The essential element in the black art of obscurantism is not that it wants to darken individual understanding, but that it wants to blacken our picture of the world and darken our idea of existence."

Climate alarmism, it is now clear, has been doing its utmost to blacken our picture of the world and darken our idea of existence.

I want to discuss here today the articles of several journalists and publications that report on how the public is failing to secure and understand vital facts about the climate and climate change.

Six facts about climate change

First is an article by David Simon in the Real Clear Politics website on July 12, 2021, entitled: "Six facts the left doesn't want you to know about global warming."

I quote below key passages from Simon's most informative article: "President Biden implores us that climate change is an 'existential threat' to humanity. Special presidential envoy for climate John Kerry preaches to us that '[t]he climate crisis as a whole is a national security threat because it is disruptive to the daily lives of human beings all over the world.' Congresswoman Alexandria Ocasio-Cortez warns us that in 2030, 'the world is going to end . . . if we don't address climate change.' Hold on to your wallet. The Left's global warming Chicken Littles insist that the sky is falling but don't want you to know six key facts."

■ "First, in his new book *Unsettled*, the Obama administration Department of Energy chief scientist Steven Koonin shows that the models relied upon by the Left to predict future global warming are so poor that they cannot even reproduce the temperature changes in the 20th century. If these models cannot reproduce past temperatures already known when the models were developed, how can they possibly reliably predict temperatures decades into the future?"

■ "Second, Koonin's book also documents that the United Nations Intergovernmental Panel on Climate Change's (IPCC) own analysis indicates that any negative economic impact that global warming eventually may have will be so modest that it warrants no action."

■ "Third, the National Oceanic and Atmospheric Administration (NOAA) and the IPCC do not claim that a link has been established between global warming and natural disasters. In 2020, the NOAA stated: 'It is premature to conclude with high confidence that increasing atmospheric greenhouse gas con-

centrations from human activities have had a detectable impact on Atlantic basin hurricane activity, and 'changes in tropical cyclone activity . . . are not yet detectable.' The UN IPCC, the Wall Street Journal reported, 'says that it too lacks evidence to show that warming is making storms and flooding worse.' "

■ "Fourth, as the earth's temperature has risen, natural disasters have become far less deadly. Since 1920, the planet's temperature has risen by 1.29 degrees Celsius and world population has quadrupled from less than two billion to over seven and half billion—yet EM-DAT, The International Disaster Database, reports that the number of people killed by natural disasters has declined by over 80 percent, from almost 55,000 per year to less than 10,000 per year."

■ "Fifth, some of the world's best scientists believe that global warming will be beneficial rather than harmful. In 2017, a group of eminent scientists—such as Richard Lindzen of MIT, William Happer of Princeton, and Judith Curry of Georgia Tech—wrote that 'observations [over the last] 25 years . . . show that warming from increased atmospheric CO₂ will be benign.' Carbon dioxide, they noted, 'is not a pollutant but a major benefit to agriculture and other life on Earth.' "

■ "Sixth, global warming saves lives. A study published in 2015 by the British medical journal The Lancet found that cold kills over 17 times more people than heat. This study by 22 scientists from around the world—which examined over 74 million deaths in Australia, Brazil, Canada, China, Italy, Japan, South Korea, Spain, Sweden, Taiwan, Thailand, the United Kingdom, and the United States in 1985-2012, 'the largest dataset ever collected to assess temperature-health associations'—reported that cold caused 7.29 percent of these deaths, while heat caused only 0.42 percent. We must not let the Left bully us into draconian action with unfounded claims of a looming climate catastrophe. Know the facts. Global warming is not a problem."

Two more facts the public should know

To Mr. Simon's six facts, I want to add two more facts from other recent articles in US journals.

■ An editorial in the Issues and Insights website titled "Another Global Warming Fact Alarmists Want Buried," published on July 15, 2021, says: "The entire climate change movement has been shady from its beginnings. Data have been hidden, truth has been sacrificed to politics, and hypocrisy and personal interests among its 'leaders' have produced a giant credibility deficit. The more we learn, the worse the alarmists look. Take, for instance, a new report that shows greenhouse gas emissions are not an American or Western problem. They are primarily a Chinese problem. A study from Sun Yat-sen University in China found that more than half of the world's urban greenhouse gas emissions are generated in only 25 big cities, and 23 of them are located in China. In other words, if the entire developed world cut its greenhouse gas emissions as activists, politicians, journalists and celebrities have demanded, nothing would change regarding the climate."

■ In an article in this month's issue of The Atlantic magazine, "The green new deal, strictly speaking, does not exist," the author Robinson Meyer wrote: "Since its ascension in 2018, the Green New Deal has defined the terms of the global

climate debate. Perhaps no other climate policy in history has been as successful. Democrats and Republicans alike have been judged by how closely they seem to hew to it. Abroad, the European Union has dubbed its 1-trillion-euro attempt to decarbonize its economy 'the European Green Deal.' And on the histrionic fields of social media, progressives ask how society can afford flooded subways, horrific droughts, deadly heat waves, and uncontrollable wildfires but not pay for a Green New Deal. With so much ballyhoo, it's become easy to miss the central, implacable fact about the Green New Deal: It does not exist. Nobody has written it down. Three years after the idea of a Green New Deal broke into the mainstream, you can't find an authoritative and detailed list of Green New Deal policies anywhere. There is no handbook, no draft legislation, no official report that articulates what belongs in a Green New Deal and what doesn't. This is more than just an academic point. It means that tens of thousands of Americans want very badly to see Congress adopt a political program that definitionally cannot pass, because there is no 'it' for lawmakers to vote on. It means that at a moment of historic possibility, American climate politics still has one leg stuck in the spectral and symbolic, when it should be knee-deep in the real."

All this shows that Philippine immersion today in talk about climate change and green energy is misplaced. Proponents, local as well as foreign agents, have a lot of work to do to persuade our people that it is sensible to enlist in the climate change movement. We should all support and take part in a Senate public inquiry into the substance or the lie of a climate crisis.

More Americans are now refusing Covid-19 vaccinations not because they oppose the "shoulder jab" but because they oppose a mandate from a president they do not trust. Ironically, using vaccine mandates in a futile effort to boost his sagging poll numbers, this feckless president has only hardened opposition to the vaccine.

"I had Covid-19 in May. My doctor tells me I'm better protected than any vaccine. What law gives this president the authority to tell my employer (an airline) to fire me next month if I don't get vaccinated?" That question was posed this weekend while we waited for a delayed flight.

There is no law. President Joe Biden's mendacious mandate is merely an unprecedented executive power grab. This is the kind of government coercion and socialist tyranny we explain in our book, "We Didn't Fight for Socialism: America's Veterans Speak Up."

New scientific findings in the prestigious Lancet Infectious Diseases journal blow a hole in the argument that workers need to get vaccinated to protect those around them. The findings prove the foolishness of forcing police and other public employees to get jabbed or lose their pay. And President Joe Biden should retract his order to the Occupational Safety and Health Administration to compel large employers to mandate vaccines.

The Journal reported Thursday that Covid-19 vaccines have “minimal” impact on preventing transmission of the delta strain. Delta is the Covid strain currently causing over 99% of U.S. cases.

Vaccines protect the people getting the shots from serious illness, but they don’t stop the delta variant from spreading to others.

Don’t get me wrong. Americans should choose to get vaccinated. The key word is “choose.” Though shots are no guarantee against getting infected and spreading it to others, they provide significant protection (90% or more) against hospitalization and death. I’m triple-jabbed.

- Choosing not to get vaccinated is choosing to risk your own life.
- The health risk to others is minimal.

Most vaccines—against polio, smallpox, measles and other diseases—prevent infection and spread. But not covid-19 vaccines. Now that the battle is against the delta variant, they’ve become disease-tamers rather than infection preventers.

Tell that to Mayor Bill de Blasio, who gave New York City employees until Monday to get at least one shot or be sent home without pay. As of Monday, 9,000 are on unpaid leave because they have refused the shots. Twenty FDNY companies were shuttered because many of New York’s bravest refuse the vaccine. Police Commissioner Dermot Shea claims the mandate will not further diminish the number of New York’s finest on the street. That remains to be seen.

Governors and mayors from Maine to Los Angeles are demanding that public employees, and even nurses and doctors, hailed just months ago as heroes, get vaxxed or go without a job.

Maine Gov. Janet Mills says, “just as vaccination defeated smallpox and vaccination defeated polio, vaccination is the way to defeat covid-19.” Sorry, Governor, but you don’t know what you’re talking about.

Just as politicians don’t read the bills before voting on them, they don’t keep up with science but still want to tell the rest of us what to do.

The groundbreaking findings in Lancet show that fully vaccinated people who came down with covid infected others in their household at the same rate (about 25%) as unvaccinated people did (about 23%). The vaccinated had just as much viral load in their upper respiratory tract, making them just as contagious. “Our findings show that vaccination alone is not enough to prevent people from being infected with the delta variant and spreading it,” study co-author Ajit Lalvani said.

The British researchers also found that vaccinated people were only somewhat less likely to contract the virus (25%) compared with the unvaccinated (38%). That conflicts with Centers for Disease Control and Prevention data showing the vaccinated are far less likely to contract covid.

One thing is for sure: The science is uncertain on this. So, government should not be using a heavy hand to impose mandates claiming to make workplaces safer.

Meanwhile, the White House is pressing large companies to mandate vaccinations and calling on OSHA to enforce that policy with hefty penalties. The Build Back Better bill increases the penalties tenfold to as much as \$700,000 per incident for hazardous conditions, threatening bankruptcy for all but the largest enterprises. The Biden administration expects to publish the rules in the Federal Register in the coming days, affecting about two-thirds of the private sector workforce.

Yet the new science undercuts OSHA's claim that unvaccinated people are a workplace hazard. So far, workplace mandates have been challenged at least 39 times in federal courts with little success, but the new scientific evidence may change that.

Lancet Infectious Diseases stressed the urgency of improving current vaccines or developing new ones to actually "protect against asymptomatic infections and onward transmission."

Foolishly, the Biden administration and Democrats in Congress vilify the vaccine developer Moderna for making a profit and threaten to seize its patents. It's possible covid will continue morphing into new variants, requiring new vaccines from companies like Moderna.

When you're fighting a war—in this case, against a killer disease—attacking your own ammunitions maker is no way to win it.

But critical race theory isn't taught in Virginia schools!

The Republican sweep in Virginia Tuesday night has nullified that claim. Glenn Youngkin beat Terry McAuliffe in the governor's race. Republicans took the lieutenant governor's office and, most important, beat the incumbent, George Soros-installed attorney general. In a shocking upset, the GOP even flipped the House of Delegates.

All this, despite the incessantly repeated claim on MSNBC and CNN that "CRT isn't taught in Virginia schools!" uttered every five minutes like "Weather on the Ones!" Who were they trying to fool? Liberal women in New York? They don't vote in Virginia. But MSNBC and CNN so enjoyed sneering about the stupidity of Republicans that they never bothered to consider that the people who would be voting could see with their own eyes what was being taught to their children.

Disturbingly, even with McAuliffe announcing that parents should have no say in what their children are learning in school—and then telling Virginia teachers that the white ones would have to go—the election was ridiculously close. The current tally is about 51% to 49%.

Liberals thought they had a lock on Virginia, no matter what lunacies their candidates spouted. They had a gigantic immigrant population (non-English

speakers are a key Democratic constituency); illiterates (same), who were specifically given the right to vote by Democrats; and felons (duh), more than 300,000 of whom were enfranchised by the last two Democratic governors.

After Tuesday's election, it looks like the Biden administration is going to have to ship a lot more immigrants into the Old Dominion. But in tens of thousands of Haitians and, in five or six years, McAuliffe can come out for white slavery and win.

That's rough. Democrats had specifically earmarked those immigrants for Texas and Florida.

All night on Tuesday, liberal commentators kept talking breathlessly about the early vote/mail-in vote, correctly presuming it to be overwhelmingly Democratic. That should tell you what early voting is really about.

Early voting has nothing to do with the convenience of the voters. It's about the convenience of Democratic operatives, who need weeks and weeks to drag their voters to the polls and help them fill out absentee ballots. Conveniently, Virginia has "no-excuse" absentee voting, allowing anyone to request a mail-in ballot for any reason, for up to 45 days before an election.

Ordinary voters don't say, If I'm going to get out of work early, I'm gonna need a 45-day window. Nobody needs 45 days to do anything. That's not a human-size requirement. It's a Democratic machine-size requirement.

To collect ballots from their unmotivated voters, Democrats need to send out an army of operatives. Luckily, they have no shortage of manpower—anyone with an administrative job in education, sanitation or county government.

But they need time. A lot of time. One day of voting is not going to permit Democrats to collect ballots from every nursing home, halfway house and sober living community in the state.

Republicans gain nothing from early voting because of the following.

- They don't have government employees with no-show jobs who can spend weeks harvesting ballots.
- GOP voters tend to be self-motivated individualists who don't need inducements to vote.

By contrast, Democratic voters need a lot of attention and a lot of handling. OK, OK, if it means that much to you, I'll vote. How about giving me a ride? Oh, and I'm hungry—how about a box lunch? Democratic "get out the vote" drives are less informational operations and more like hauling the kids to Grandmother's house.

This is not a level playing field. Relaxed voting requirements help only Democrats. Unenthusiastic voters make mistakes, ruin ballots and forget to bring I.D.

But Republicans have been so mau-maued by the Democrats that they can barely put up a fight just to end the covid-era voting rules. Remember the worldwide pandemic? In 2020, Democrats wailed: DO YOU WANT PEOPLE TO

DIE??? We're going to need universal mail-in ballots, months of early voting, same-day registration and no I.D. requirements.

But now they say Republicans are returning us to the dark days of Jim Crow for insisting on voting rules circa 2018.

Forget that. How about a federal law restricting elections to what is known as "Election Day"? The Constitution requires Congress to choose "the Day" of voting. It further states that the "Day shall be the same throughout the United States." Make it a federal holiday. But make it one day.
