A recent NBC News headline announced: "FDA advisory panel OKs Pfizer vaccine for children 5 to 11." How could a panel that is supposedly composed of rational clear-headed scientists make such an inexplicable recommendation?

Consider the following facts.

■ According to a presentation by Fiona Havers, who works at the Centers for Disease Control and Prevention (CDC) and who is a member of the agency's Covid-19 Response Team, "[D]uring the 12-month period October 2, 2020 through October 3, 2021, there were 66 covid-19 associated deaths in children 5-11." Yes, you read it right. In the last twelve months, there were only 66 covid-related

deaths in the 5 to 11 demographic in the whole of the United States of America. To give you a sense of perspective, children in that age bracket are three hundred percent more likely to be murdered (207 deaths) and thirty percent more likely to die of flu and pneumonia (84 deaths) than they are to die of covid.

■ To give another point of comparison, according to the CDC in 2019, “608 child passengers age 12 and younger died in motor vehicle crashes.” Please contemplate this point well. Children under 12 years of age are nearly 1000 percent more likely to be killed in a vehicular mishap than to die of covid-19.

■ One more piece of reference data. According to Statista, there were 20 deaths and a hundred injuries due to lightning strikes in the United States in 2019. Thus, your child is nearly 200 percent more likely to be struck by lightning than to be felled by covid.

■ But even this does not tell the full story, because not all of those unfortunate 66 children who died *with* covid died *of* covid. Most of them had serious underlying conditions, which according to Fiona Havers, included: “... obesity, chronic metabolic disease, feeding tube dependence, cardiovascular disease, neurologic disorders, chronic lung disease, blood disorders, immunosuppressed conditions, and ‘other’ conditions.” Thus, most—if not all—of the children in the 5-11 age bracket who died while being covid positive suffered from serious, life-threatening co-morbidities.

■ To state the situation in a different way, it is virtually unheard of for an active, healthy child to die of covid-19. For all practical purposes, the chance of your healthy child dying of this disease is zero.

Even the scare-mongering New York Times had to concede that to healthy children “the danger of severe covid is so low as to be difficult to quantify.” In other words, the risk is essentially non-existent.

The obvious question is this: Why are we going to mass vaccinate healthy children against covid-19 given that they face virtually no serious risk from this particular disease?

The only valid medical reason for vaccination of this age cohort would be to stop the spread of infection.

This, however, cannot be the case, because it is now widely known that the covid vaccines do not prevent infection.

This was publicly affirmed some three months ago by none other than CDC director Rochelle Walensky. Speaking of the vaccines in her CNN interview on August 5 with Wolf Blitzer, Walensky said: “What they can’t do anymore is to prevent transmission.”

The combination of extremely low covid risk to the young, and the vaccines’ inability to prevent transmission, makes vaccinating children a *non sequitur* from the point of view of public health.

Not only there is no real benefit of doing so, but there are also considerable risks associated with this procedure. It is well known that the covid vaccines have not been properly subjected to trials and tested. It normally takes

between 6 and 10 years to develop and test a vaccine that can be declared safe and effective for mass implementation. The covid shots have been around for less than 18 months, which makes it impossible to know what their long-term side effects may be.

Meanwhile, in the short term, we have every reason to be deeply concerned about these inadequately tested pharmaceuticals. According to an analysis of the Vaccine Adverse Event Reporting System database (VAERS), between December 2020 and October 15 of this year, there have been records of more than seventeen thousand deaths and over eight hundred thousand adverse reactions in connection with the vaccines.

This, however, does not give a true picture as it represents only a small fraction of the actual cases. According to a Harvard study, only about one percent of vaccine injuries get logged in the VAERS database. Do the math.

This being said, it does not mean there is a causal connection in every reported case between the vaccine and the bad health event. Nevertheless, in a substantial portion of reported cases, such a connection does exist. Keeping in mind the findings of the Harvard study should give you an idea of how deep our safety concerns should be.

And yet despite all this, members of the FDA advisory panel still thought that injecting children who have virtually zero risk of serious covid with these inadequately tested substances is a good idea.

To say that this is reckless and irresponsible would be an understatement.

Why would they do such a thing?

■ Money is the main reason. The effort to inject your children likely is primarily driven by a desire to further increase the already immense profits of the pharmaceutical giants that produce these vaccines.

The dictum "follow the money" applies well here. A recent US News headline should give you a good idea of what is involved here: "Pfizer Expects 2021, 2022 Covid-19 Vaccine Sales to Total at Least \$65 Billion." Pfizer's covid vaccine stands to become the most profitable pharmaceutical product in history.

You can easily see through their game when you look at who sits at the advisory panel that issued the recommendation.

According to a report by Zero Hedge: "[T]he meeting roster shows that numerous members of the committee and temporary voting members have worked for Pfizer or have major connections to Pfizer. Members include a former vice president of Pfizer Vaccines, a recent Pfizer consultant, a recent Pfizer research grant recipient, a man who mentored a current top Pfizer vaccine executive, a man who runs a center that gives out Pfizer vaccines, the chair of a Pfizer data group, a guy who was proudly photographed taking a Pfizer vaccine, and numerous people who are already on the record supporting Coronavirus vaccines for children. Meanwhile, recent FDA Commissioner Scott Gottlieb is on Pfizer's board of directors."

As if this were not bad enough, the acting chair of the board that made the recommendation was one Arnold S. Monto who was a paid Pfizer consultant up until 2018.

Dr. Robert Malone, the inventor of mRNA vaccines and a true and honest scientist, called this “a staggering conflict of interest.”

It also shows us how brazen these people are since they did this in open view. This is part of a larger pattern whereby nearly all regulatory agencies of the US government have fallen into the hands of those they are supposed to oversee. The name for this process is *regulatory capture*. As a result, we can no longer have trust in government bodies tasked with protecting the safety and well-being of the population.

To endanger the health of children in the absence of a medical justification and for the sake of profit is a travesty of unspeakable proportions.

The White House's official press release announcing the Build Back Better Act (BBB) pitches it as a "PLAN TO REBUILD THE MIDDLE CLASS." It rhapsodizes about "working families" squeezed by the economy, and reminds voters that "Biden promised to rebuild the backbone of the country—the middle class."

A cartoon illustrates the sort of person who would benefit from Biden's Build Back Better programs: "Linda," a white woman, who works at a manufacturing plant but struggles to raise her son, "Leo."

One thing the White House's official press release did not mention is that almost all of the \$2 trillion doled out under BBB is expressly designated for Black, Latino, Native American, Asian American, Pacific Islander and non-English speaking individuals. White Americans will get nothing and like it.

Over and over again, the bill is written expressly NOT to help the hardworking Linda, apparently because she is white. Here are just a few examples:

- \$1 billion to Native American, Alaska Native and Native Hawaiian communities for housing "needs."
- \$500 million for minority-serving schools of medicine.
- \$112 million for teacher preparation programs at Historically Black Colleges and Universities (HBCUs) and Minority Serving Institutions (MSIs).

- \$75 million for culturally appropriate care management and services for older individuals who are racial and ethnic minorities or are underserved due to sexual orientation or gender identity.
- \$75 million to study maternal health for pregnant and postpartum minority individuals.
- \$50 million study maternal mortality among minorities.
- \$50 million to improve behavioral health outcomes for communities of color with substance abuse.
- \$75 million to increase research capacity at minority-serving institutions.

And on and on and on.

The very first item in Title II of the bill, titled “ELEMENTARY AND SECONDARY EDUCATION,” is a program to distribute more than \$100 million in grants to address “low diversity within the teacher and school leader workforce.” To be eligible for a grant, the recipient must have a plan “to increase the diversity of qualified individuals entering into the teacher, principal, or other school leader workforce.”

Similarly, the first provision of BBB’s “ECONOMIC DEVELOPMENT” section is: “Minority Business Development Agency.”

But wait—here’s a plot twist! This part also includes something for rural America! (So Democrats have heard of Appalachia.) Twenty-one percent of the country is rural. Twenty-four percent is non-white. Guess how the money is divvied up?

One billion dollars for minorities and \$200 million for “rural business centers.”

Even provisions that don’t explicitly exclude whites, turn out, on closer examination, to exclude whites. I’ve never seen so many synonyms for “non-white,” such as “persistent poverty communities,” “historically economically distressed,” “historical injustice” and “underserved communities.”

Hang on, Ann—what makes you think “underserved” means “non-white”?

I refer you to page 111 of the bill: “This section also defines an ‘underserved community’ as a group of people who have been systematically denied the full opportunity to participate in aspects of economic, social, and civic life. Underserved communities include Black, Latino, Indigenous and Native American persons, Asian American and Pacific Islanders, other persons of color, [etc.]”

How about changes to our environmental laws? White people love the environment! Sorry, out of luck, again, white boy.

BBB allocates almost \$7 billion for “national service programs to carry out projects related to climate resilience and mitigation.” Unfortunately, however, all those billions have to go to “entities that serve and have representation from low-income communities . . . ; utilize culturally competent and multilingual strategies; . . . implemented by diverse participants from communities being served.”

One billion dollars of the “Climate Resilience and Mitigation” loot is specifically directed to “individuals who were formally incarcerated.” [Sic.] Sure, climate change is important—but not as important as giving money to convicted felons!



What the [heck] happened to Linda?

Linda is wearing a hardhat, so her job has probably been outsourced. Maybe she'll be helped by BBB's humongous expansion of the Trade Adjustment Assistance program (TAA). That's the law passed in the 1960s to compensate American workers whose jobs have been shipped abroad by globalist swine who couldn't care less about their fellow Americans and don't mind that every single thing we need, including masks and medicine, is made in China.

Surely, some white people will qualify for that—steelworkers, autoworkers, glass, plastic and paper manufacturing employees.

In fact, the BBB hijacks the whole idea of compensating globalism's losers and turns the TAA into just another massive welfare scheme. Both the eligibility requirements and payment amounts are expanded beyond all reason, entitling "workers" to years and years of payouts, with no minimum employment period required, and no stipulation that trade has anything to do with the loss of their jobs.

Republicans seem to think that if they just talk about how much Biden's BBB plan costs, their job is done. They ought to read the bill. It might prompt them to finally say something about the Democrats' clear animus against white Americans.

We learn from special counsel John Durham's indictment of Igor Danchenko that "the FBI ultimately devoted substantial resources attempting to investigate and corroborate the allegations" in the now-infamous Steele dossier. "Ultimately" is right—but not before it relied on the shoddy document to surveil an American citizen in an investigation that produced the Mueller probe and a two-year-long obsession with Trump and Russian built on a preposterous foundation.

The web of deceit is a tangled one, but while the indictment details a shocking story of transnational dirty tricks weaponized at the highest level of American politics, the most significant moral failure was on the part of the FBI itself.

Durham, who is investigating the origins of the FBI's Trump-Russia investigation, indicted Danchenko on five counts of lying to the Bureau's investigators regarding the compilation of the information in the dossier. The document was a collection of political opposition research posing as intelligence reports, gen-

erated at the behest of the Hillary Clinton campaign, which portrayed Donald Trump and his 2016 campaign as clandestine agents of the Kremlin.

It is worth relating the background in detail.

These reports were crafted by a former British spy, Christopher Steele, in partnership with Glenn Simpson, co-founder of the political research firm Fusion GPS. Perkins Coie, the sharp-elbowed Democratic law firm that represented the Clinton campaign, retained Simpson for the project. Simpson, in turn, recruited Steele, who brought in Danchenko, his business associate.

Danchenko's background, which is worthy of a second-rate spy novel, came to light in late 2020, when a Justice Department inspector-general investigation was unsealed. A Russian citizen transplanted to Washington as a geopolitics scholar, he landed at the Brookings Institution, a prominent Clinton-friendly think-tank. In 2009, the FBI opened a counterintelligence investigation of Danchenko. He had allegedly suggested to two Brookings staffers, who appeared to be headed for jobs in the Obama administration, that he could make it worth their while if they passed along classified information. The staffers (one of whom believed Danchenko must be a Russian agent—imagine that!) instead passed along word of Danchenko's entreaty to the FBI. The Bureau learned that Danchenko appeared to be tied to two Russian agents who were also under investigation.

Agents prepared to seek national-security surveillance of Danchenko under the Foreign Intelligence Surveillance Act (FISA). But, in what would become an alarming theme, the FBI did not follow through and closed the investigation in March 2011, apparently believing that Danchenko had gone back to Russia.

In fact, he had begun working with Steele. Danchenko was introduced to Steele in 2010 by Fiona Hill, another Brookings Russia scholar. Hill, you may recall, was a Trump White House National Security Council member who provided key testimony in the House's impeachment of then-President Trump in the Ukraine kerfuffle. (Hill appears not to have been knowingly complicit in the unrelated Trump-Russia hype.)

When Steele was recruited for the Clinton campaign's anti-Trump project in spring 2016, he relied on Danchenko to supply most of the information. Contrary to Steele's later claims, Danchenko did not have a network of useful contacts. But here again, Hill appears inadvertently to have advanced the plot. In 2016, she introduced Danchenko to Charles Dolan, a Russia-focused businessman and Democratic Party activist.

Dolan is identified in the indictment as "PR Executive-1" because he helped run a public-relations firm. He is a longtime Clinton insider, having worked on Bill Clinton's successful 1992 and 1996 presidential campaigns, as well as Hillary's failed 2008 and 2016 bids. In the interim, he was appointed by President Clinton to a State Department advisory committee. From 2006 until 2014, the Kremlin retained Dolan to be its global public-relations agent. For much of that time, conveniently, Secretary of State Hillary Clinton was the Obama administration point-person on the "Russia Reset," in which the State Department promoted Russian economic development.

As the indictment details, Dolan hired Danchenko to consult on a conference he planned for October 2016 in Moscow. In the preceding months, Dolan had constant communication with Danchenko and made a preparatory trip to Moscow, meeting with Danchenko. Dolan would pass information to Danchenko, which Danchenko would embellish, sometimes beyond recognition, in passing it on to Steele, who dutifully included it in the dossier without disclosing its origins.

In the most notorious example, Dolan had meetings in a Moscow hotel and was given a tour of the presidential suite, in which he was told Donald Trump had once stayed. Danchenko was not present for these meetings, and the indictment says there was no discussion of any sexual hijinks. Dolan then communicated some of the details to Danchenko who, within days, flew to London to meet with Steele. By the time Steele finished writing up what Danchenko told him, the episode had been spun into the now infamous “pee tape” claim—i.e., that Trump had cavorted with prostitutes in the presidential suite, which they defiled because Trump hated the Obamas (who had supposedly stayed there earlier), and Putin thus had a recording of the whole sordid affair. In reality, Danchenko is Steele’s source, has no first-hand knowledge, and appears to have made the whole thing up.

According to the indictment, Danchenko lied to the FBI about getting information from Dolan. He also lied about having learned directly from a close Trump associate that Trump’s campaign was in a “well-developed conspiracy of cooperation” with the Kremlin. Danchenko claimed that this information came from the president of the Russian-American Chamber of Commerce—identified in the indictment as “Chamber President-1,” and in public reporting as Sergei Millian.

A minor real-estate developer, Millian did some business with the Trump organization and started this obscure “chamber” in order to raise his profile. In reality, Danchenko never spoke or met with Millian. He continued to cling to his incredible story in several interviews by the FBI throughout 2017. As a result, four of the five false statement counts relate to this alleged fabrication. The other concerns Danchenko’s alleged concealment of Dolan’s role.

The spotlight on Danchenko, and on the seminal role of the Hillary Clinton campaign in creating and disseminating the Trump-Russia “collusion” tale, is understandable. It should not, however, divert attention from the FBI’s stunningly inept performance. On its face, the dossier is a screed full of blatant nonsense. The Danchenko indictment shows that if a modicum of fair-minded investigation had been done, a borderline competent FBI agent would quickly have spotted its glaring weaknesses. Yet, the Bureau took no meaningful action to corroborate the Steele/Danchenko claims before seeking FISA warrants under oath. Agents did not even interview Danchenko, *the main source*, until four months later.

Too good to check is an impulse that never serves journalists well, and it’s even worse when it is the policy of a law-enforcement agency wielding awesome powers. At best, the FBI allowed itself to get duped into playing along with a political hit against, first, a presidential candidate and, then, the duly elected president of the United States. May John Durham continue to expose the details of this sorry scheme, and hold accountable anyone who broke the law in the course of advancing it.
