Just over two months before Israel and China celebrate 30 years of full diplomatic relations, the presidents of the two countries, Isaac Herzog and Xi Jinping, engaged in a lengthy telephone conversation on Wednesday.

In a sense, it was historic, because it was the first presidential, bilateral telephone conversation between the two countries.

Although there was military and other cooperation between Israel and China long before there were diplomatic ties, there was no official agreement prior to November 1991, when then-defense minister Moshe Arens paid a secret visit to China to negotiate the expansion of military cooperation and take steps toward diplomatic ties.

On January 24, 1992, then-foreign minister David Levy, during a four-day visit to China, signed an agreement for the establishment of diplomatic relations with his Chinese counterpart, Qian Qichen.

Since 1949, when China recognized Israel, there had been many failed attempts by the Jewish state to enter into full diplomatic relations, including one by Herzog's late father in November 1986. While visiting Hong Kong, president Chaim Herzog paid a secret visit to the Chinese mainland where he met with high-ranking officials.

But there was still a need for much greater effort and a change of the political circumstances before the late British-born Zev Sufott, who had been wounded in the War of Independence and joined the Foreign Ministry in 1950, opened the liaison office of the Israel Academy of Sciences and Humanities in Beijing in 1990, as a stepping stone to his becoming Israel's first ambassador to China.

Not surprisingly, Chaim Herzog was subsequently the first president of Israel to officially visit China.

In their amicable telephone conversation on Tuesday, presidents Herzog and Xi discussed ways and means of enhancing bilateral ties, with each inviting the other to visit his country. It was not the first time they had been in contact with each other: Xi sent a congratulatory letter to Herzog in September, when the latter celebrated his 61st birthday.

Herzog expressed his deep admiration for Chinese culture and the Chinese people, and both leaders noted that Israel and China are two ancient civilizations that have much to contribute to the world.

Herzog updated Xi on matters related to the Abraham Accords, noting that this constitutes a positive development in the Middle East that must be encouraged.

He also stressed that this trend toward normalization stands in complete contrast to the Islamic Republic of Iran's activities, which are damaging and undermining stability in the region. Herzog emphasized the need to prevent Iran from acquiring nuclear weapons capability.

Both presidents voiced hopes for greater Israeli-Chinese collaboration in the future, concurring that more meaningful cooperation can be promoted in the fields of culture, economy, tourism and more. They reaffirmed their commitment to the China-Israel comprehensive innovation partnership, which will find expression in the fifth meeting of the China-Israel Joint Committee for Innovation Cooperation in January 2022.

A reported memo from the Director of the Office for Civil Rights within the Biden Administration’s Health and Human Services Department hints of the Biden administration’s apparent desire to roll back religious liberties.

In a draft memo to Secretary of the Department of Health and Human Services Xavier Becerra from Lisa Pino, the Director of the Office for Civil Rights (OCR), she writes of the Trump administration’s delegation in 2017 for the Office of Civil Rights (OCR) to prevent violations of religious liberty: “Prior to the delegation in 2017, no division was singularly responsible for the Department’s compliance with RFRA (Religious Freedom Restoration Act) or the First Amendment . . . That model recognized that all components of HHS had a responsibility for compliance and that OGC [Office of General Counsel] was a central partner in providing key legal advice on RFRA and defending the Department when RFRA claims were raised. Rescinding the delegation to OCR does not lessen the commitment of the Department to compliance, but ensures that it is not misused by any one agency to enact a broad, proactive agenda.”

After former Attorney General Jeff Sessions issued guidelines on various religious liberty issues, HHS gave OCR authority for RFRA compliance reviews

and to “initiate such other actions as may be necessary to facilitate and ensure compliance with RFRA,” Fox News noted.

Pino’s memo also states, “While nothing in RFRA legally restricts an agency to work proactively to address a complainant’s (or ‘would be’ complainant’s) religious needs or rights, there is a serious concern that such an approach broadens the effect of RFRA in a way that may not be legally required and while causing significant detriment to civil rights and public health protections.”

CHRIS WALLACE, FOX NEWS ANCHOR: *Glenn Youngkin’s victory in the Virginian governor’s race was the big story on election night. But there was someone else on the ballot who also won. And she’s also creating a stir, taking on tough issues and nailing one-liners. Here’s our “Power Player of the Week.”*

WINSOME SEARS, VIRGINIA LT. GOVERNOR-ELECT: *I’ve just always assumed that whatever room I am in, I belong. Whatever I want to pursue, it’s mine for the taking.*

WALLACE (voiceover): *Virginia Republican Winsome Sears will soon be taking the office of lieutenant governor.*

SEARS: *How sweet it is.*

WALLACE: *Once considered a longshot, she’ll be the first black woman in that post.*

WALLACE (on camera): *What do you think Virginia voters were saying on Election Day when they made you lieutenant governor?*

SEARS: *They're tired of the black against white and the Asian against Latino. They're tired of it, and they're tired of politicians who won't let the wounds of the past heal . . .*

WALLACE (voiceover): *We were with Sears this week as she toured the state capital in Richmond, checking out the Senate floor, where she'll preside.*

SEARS: *Wow. How awesome is this.*

WALLACE (voiceover): *The power of the moment was not lost on her.*

SEARS: *A black lieutenant governor was handing off to another black lieutenant governor, and that has never happened.*

UNIDENTIFIED FEMALE: *So that's history.*

SEARS: *That is history. God bless Virginia.*

WALLACE (voiceover): *Sears ran at a time when race and education are the focus of charged debate.*

SEARS: *Nobody is denying that we don't want to hear all the history, least of all me. I certainly don't want the sins of the past to be repeated. We don't have to tear one person down in order to build another up. That's no way to be. That's not America.*

WALLACE (voiceover): *Sears' love for America is rooted in her life story. She immigrated from Jamaica and served in the Marines.*

SEARS: *Everything that I've had, I've had to work for. No one gave me anything.*

WALLACE (voiceover): *She isn't shy about how her lived experience shapes her worldview.*

SEARS: *In case you haven't noticed, I am black and I have been black all my life . . . But that's not what this is about.*

SEARS: *Sometimes what happens to you isn't because you're black or because you're a woman, it's simply life. I mean, some days you're the pigeon and some days you're the statute. It's just life.*

SEARS: *We need to wake up.*

WALLACE: *Her victory, her politics, and this photo made headlines beyond the commonwealth.*

SNL's MICHAEL CHE: *. . . was elected as Virginia's first black female lieutenant governor. But this is actually a win for Democrats because nothing will get Republicans to support gun control faster than this picture.*

WALLACE (on camera): *Did you think the joke was funny?*

SEARS: *Well, I did, because I thought, well, I don't think he knows what he's saying. And the fact that his audience thought it was quite hilarious was also very telling about their character. So, you know, it's a bunch of hypocrisy, but it's all right. I can handle it. I'm a big girl.*

WALLACE (voiceover): *It's that tenacity that has political insiders asking already if she has bigger plans.*

SEARS: *I just want to serve, you know, in the end. And I really want others to see me, especially the children, to say, well, if Winsome can do it, I can do it, because I didn't do anything special except stay in school and study. And I never let anybody walk over me. And if they did, they didn't get a second chance.*

Critical Race Theory (CRT) was a lightning rod during the recent election, as parents learned to see woke ideology through a new lens. No, it wasn't from a pedagogical perspective as a way to teach historical awareness of racism, but from a more pragmatic perspective as a tool being used to politicize children.

In truth, CRT has recast Marx's old division of oppressor and oppressed. Now, instead of economic division, it is about racial division. In schools, this translates into making children responsible for the tragedies of history.

Parents have seen for themselves, as school was online during covid, the new formula that has poisoned the curriculum.

History Exposes Critical Theory

CRT may very well be the most recent mother lode of bad ideas. Born of Marx's "Critical Theory" and embellished by Theodor W. Adorno and Max Horkheimer, it has been taught in law school since 1995, but for a different purpose. Chaos is brewing as Americans face unprecedented injection mandates that order them to comply or risk losing their jobs or freedom to partake in education and society. In a Full Measure report, host and investigative journalist Sharyl Attkisson described the resulting "debate over freedom, science and government control," which is creating a sharp divide across the U.S.

"Covid-19 vaccine mandates have set up the ultimate showdown," she said. ". . . Already, there are mass firings, resignations and lawsuits. Now, a national mandate is on the way. Never before has the federal government mandated vaccination for such a large segment of society."

Legal Challenges Against Vax Mandates Mount

September 9, 2021, President Joe Biden issued an executive order that would require executive branch federal employees and federal contractors to get a covid-19 shot by December 8; he pushed the deadline forward November 5, 2021, to January 4, 2022, for full implementation. With the deadline approaching, 11 U.S. states quickly sued the federal government in order to block the mandate, calling it an unlawful, unconstitutional violation of federal procurement law.

Indiana noted Thursday, November 4, 2021, that they would file three separate lawsuits: One against the mandate for federal contractors; the second one against OSHA; and the third one will be against mandates for nursing homes workers, hospitals and other agencies that accept Medicare and Medicaid payments.

Meanwhile, November 5, 2021, OSHA issued its first notification⁵ on its plans to enforce Biden's order, with a list of "frequently asked questions." Interestingly, the vaccine mandate and testing will not apply to employees working exclusively from home, or who work entirely outdoors, even though they'll be counted toward an employer's workforce number.

A UC Hastings professor who is often called upon to discuss vaccine law, Dorit Reiss, told 10News San Diego that the reason OSHA isn't enforcing the mandates on remote or outside workers is because OSHA doesn't have the legal authority to do so.

"The agency can only impose emergency standards on issues where workers are in 'grave danger,'" Reiss said. "OSHA is saying we have really good evidence that covid-19 is a grave danger to people in indoor places. We don't have the same kind of evidence that it's a great danger to people working remotely, not working with other employees, or working outside."

In New York, which issued an injection mandate that New Yorkers must comply with in order to visit restaurants, bars and gyms, Mayor Bill de Blasio stated, "If you want to participate in our society fully, you've got to get vaccinated. It's time." In the real world, though, Attkisson found that only one of four restaurants they visited actually asked them for proof of vaccination.

New York hospital workers, who are also mandated to get the shot, are also resisting, with 72,000 still choosing not to get a covid-19 injection. Across the

U.S., everyone from health care workers to police to professional athletes are standing up for their health freedom.

Attkisson reported: *"There are already countless legal challenges moving through court. Teachers, police, and other first responders around the country, including 500 LA firefighters. And it's about to get much bigger. Millions of federal workers and contractors are counting down toward a deadline to get vaccinated. And the mandate is about to expand to all private employers with 100 or more workers. About 100 million people, in all."*

Businesses Could Be Fined \$700K for Violating Vax Mandates

Attkisson is referring to a White House announcement in September 2021 that companies with 100 or more employees will have to ensure staff have gotten a covid-19 injection or be tested regularly for covid-19. Fines on employers that do not comply could run as high as \$70,000 for serious infractions and \$700,000 for each "willful" or repeated violation.

Currently, the fines only apply to businesses with 100 or more employees, but there's nothing stopping them from changing it to 50 employees—or one employee. Anything could happen at this point. It's worth noting that, at this point, the mandate doesn't actually exist.

Speaking with The Federalist in October 2021,, a spokeswoman for the Indiana Occupational Safety and Health Administration explained, "There is nothing there yet that gives employers any mandate. The president made an announcement on this asking OSHA to do it, but we've not yet seen anything come from it yet."

This may be why more lawsuits haven't been filed to challenge the mandate—there's nothing to challenge just yet. Still, Rep. Chip Roy of Texas and Sen. Mike Lee, R-Utah, introduced a bill—the No Taxation Without Congressional Consent Act—September 30, 2021, that would prohibit the federal government from imposing a fine, fee or tax on individuals or businesses for violating a covid-19 vaccine mandate issued by OSHA or other agencies.

As it stands, less than 2% of U.S. businesses will be affected by the mandate, as more than 98% of U.S. businesses have fewer than 100 employees, exempting them from the mandate. However, those 2% account for about two-thirds of U.S. employees, so they're a sizeable minority.

Many of these large corporations have already put injection mandates into place or were planning to. The "mandate" announcement allows these mega-corporations to mandate the jabs without having to be the bad guy. In another instance, Los Angeles recently approved one of the strictest mandates in the U.S. and will require a vaccine passport to enter indoor public spaces like shopping malls, museums, restaurants, spas and other locations.

In San Francisco, city officials announced as soon as the shot was approved them that children aged 5 years and older will now need a vaccine passport to enter restaurants and grocery stores.

California also became the first U.S. state to require students in kindergarten to grade 12 to receive covid-19 shots following full FDA approval. Council

President Nury Martinez called the move “a necessary step towards returning to normalcy,” but there’s nothing “normal” about presenting proof of an injection to go about your daily life.

Will Mandates Further Hinder Economic Recovery?

Iowa Gov. Kim Reynolds called the mandate an “abuse of power” that would only worsen labor shortages and supply chain woes, further hindering economic recovery. Yet, speaking with Attkisson, Lawrence Gostin, head of the World Health Organization Center on Global Health Law and an adviser to the Biden administration, said the opposite—that vaccine mandates would boost the economy.

“Many people haven’t been to work for a year and a half. And so, they’re coming in, and they want to feel safe. And they’re not going to feel safe unless you have a largely vaccinated population around you,” he said, adding, “I actually do think that it’s about protection primarily, but it will have economic benefits as well.”

Sen. Ron Johnson, however, told Attkisson, “It’s going to be a disaster for our health care industry and for many segments of our economy.”

He explained: “Before President Biden announced the coercive, freedom robbing mandate from the federal government, hospitals were mandating vaccines. I’ve been hearing from their doctors, from their nurses, people that are heroes. They read the science, they see the study out of Israel that says that natural immunity is 13 to 27 times more effective than the vaccine. They’re treating the injuries. They’re not going to get vaccinated. They don’t want to lose their job. They love their jobs, they love taking care of patients. But what they’re going to do is they’re going to be terminated and then we are going to experience an enormous loss of manpower and experience and expertise in our healthcare system. It’s already occurring. It’s hard to quantify exactly how many have already quit or been fired over vaccine mandates. 600 at United Airlines. Teachers. First responders. Military troops. More than 3000 among a small sampling of hospital systems. There are already staff shortages and bed cuts at some hospitals.”

No Exemptions for Natural Immunity

The other glaring issue is that mandates make no exceptions for people with natural immunity. It’s the elephant in the room that the mainstream covid-19 narrative refuses to acknowledge. A sizable number of Americans already have natural immunity from a prior covid-19 infection.

How can you threaten a person with fines or loss of employment to get an injection for a disease to which they’re already immune? This is likely to prompt more than a few lawsuits, especially since it’s been shown that natural immunity may protect you significantly better than an injection.

This is one of Rep. Thomas Massie’s top complaints with vaccine mandates.

“I guess my top gripe is, they’re unscientific,” he told Attkisson, noting: “The latest study shows that you’re 27 times less likely to contract symptomatic covid if you have immunity from prior infection, versus having the vaccine and never having been infected before. So why would you force those people to take the vaccine? It doesn’t make any sense . . . Ultimately, I have hope that the Supreme

Court is going to find this illegal like they did with CDC's eviction moratorium. But in the meantime, Joe Biden is going to be able to bluff many corporations. He's targeting 100 million Americans, those are their numbers. He may, without ever promulgating this rule, effectively get 50 or 80 million of them to comply."

Experts also disagree about booster shots, and CDC director Dr. Rochelle Walensky overruled the CDC's expert panel and went ahead with the recommendation to issue a booster shot for adults at high risk of infection. This is only the second time in the CDC's history that its own ACIP advisory panel has been overruled.

Meanwhile, mounting concerns are being raised regarding shots for children, with Dr. Robert Malone, the inventor of the mRNA and DNA vaccine core platform technology, among those who have stated that the risk of damage is greater from the injection than from the disease itself, especially among males.

Also being ignored by the mainstream narrative is the fact that those who've received the injections can still be infected by, and transmit, SARS-CoV-2. As Johnson said, "There's no logical rationale for the mandate. We know that vaccinated individuals can get infected, they can transmit the disease. So what benefit are we getting from segregating our society, vaccinated versus unvaccinated?"

Vaccine Makers Are the Undisputed Winners

Who's profiting from this increasing division of American society? Big Pharma, including Pfizer and Moderna. "As the fight continues, undisputed winners in the whole mess are the vaccine makers," Attkisson said. "Even before the national mandate, Moderna was expected to pull in \$19 billion in taxpayer money for selling covid-19 shots this year. Pfizer: \$26 billion."

As for whether legal challenges will be able to stop the onslaught of mandates, Johnson told Attkisson that he's hopeful they will, but with a major caveat: "I believe the challenges to federal mandates will succeed, but probably too late, it'll probably be too late. The damage will have already been done."

A tremendous part of the enormous frustration felt by an ever-growing segment of the population over the past nigh-on two years is rooted in the fact that little if anything about the actions the powers-that-be have taken in response to the covid-19 pandemic has ever made any logical or scientific sense. When even a layperson like myself can time and time again drive a semi-truck through the 'reasoning' put forth by our overlords to justify their ridiculous measures, the

fact that the insanity still continues virtually unabated is a testament to the magnitude of their evil grip on the psyches of far too many.

Ever true to form, the seemingly endless logical absurdities contained within the Occupational Safety and Health Administration's workplace vaccination mandate, released earlier this month, came as no surprise to any of us over here on Team Reality. It's carefully worded, to be sure. Clearly, well-qualified attorneys wrote that 490-page monstrosity fully expecting legal challenges to ensue and hoping their crafty verbiage would head some of the pushback off at the pass. Yet, it would seem, even the most carefully applied lipstick cannot possibly dress up this pig. And if you take the 5th Circuit's words at face value—"give cause to believe there are grave [emphasis mine] statutory and constitutional issues with the Mandate . . ."—any *sane* court isn't about to buy what they're selling.

Now I'm not a lawyer, and I don't even pretend to be one on Townhall. Nevertheless, even a lowly columnist like myself can pinpoint several gaping logical discrepancies in OSHA's mandate. Here are a few of the most flagrant violations.

1. The mandate purports to "protect" employees at companies with more than 100 workers from the "grave danger" posed by covid-19. Assuming that's true (a BIG assumption, I know), wouldn't the "danger" faced by workers at smaller companies also be considered at least equally as "grave"? Yes, there are reasons cited, such as the potential difficulty small companies would have implementing these measures. However, aren't we talking about a "grave danger" here? If a small company had a vat of boiling oil in the middle of a warehouse floor where workers could easily fall, would OSHA accept that they can't afford to build guardrails around it as an excuse?

2. If the danger posed by this virus at work is so "grave," why does it take effect four months from Biden's original announcement and two months from the mandate's publication? Did the virus promise to take a breather while this is all being sorted out? Maybe it's sort of like how, you know, it only spreads while people are walking around restaurants and not sitting maskless at tables, or at night and not during the day? I mean, this is a "GRAVE DANGER" we're talking about here, right? Aren't we supposed to believe people are dropping dead all over the place, or something?

3. Covid-19, this "grave danger," is virtually everywhere, spreads mostly in households, and most everyone will likely be exposed to it at some point if they haven't already. As such, this isn't even close to a work-specific issue that should be addressed by OSHA. Have we had similar mandates for the flu or any other communicable disease? Short of mandating HAZMAT suits, how are workplaces supposed to stop a virus anyway?

4. The mandate considers all "vaccinated" people the same and doesn't require boosters for those vaccinated more than 6 months ago, even though the latest science has shown that these vaccines wane significantly over time. In other words, if you got the shot before May 2021, you are, for all intents and purposes, unvaccinated. Yet, the low-IQ powers-that-be consider you "vaccinated" for the purposes of their ridiculous mandate.

5. The mandate doesn't take into account occupation and risk levels. For example, is the risk of contracting covid in a sparsely populated office environment the same as that in, say, a crowded poultry processing plant? Of course not, yet an unvaccinated, unmasked office worker with an open door and nobody else around within 50 feet is technically out of compliance with the mandate's masking requirement.

6. The mandate calls for punitive measures—weekly testing and workplace indoor masking—for the unvaccinated only, despite the fact that the vaccinated can still contract and transmit the virus even during the few months in which it actually helps with potential deaths and hospitalizations. Logically, if the vaccine is masking symptoms which would otherwise force the infected to stay home, the vaccinated would seem more likely to spread the virus asymptotically. But neither this mandate nor any other aspect of public health policy takes this into account.

7. The masking and weekly testing are portrayed as "incentives" (read: punishments) against choosing to remain unvaccinated, almost as if OSHA knows they don't actually prevent anything. Our medical overlords have always portrayed masking as 'source-control,' not 'protective' to the wearer. Yet, the mandate purports to "protect" unvaccinated workers by forcing THEM to wear masks. If, as they state in the document, they really wanted to "protect" the unvaccinated, and they sincerely believe masks will do that, why do only the unvaccinated have to wear them?

8. The mandate ignores and even completely and summarily dismisses natural immunity, despite the dozens of studies that show that immunity from prior infections is both durable and long-lasting. This is patently absurd and completely unscientific. Yet our overlords, here and elsewhere, continue to marginalize those with natural immunity, ignoring both the lifelong protection such immunity likely offers as well as the fact that the prior infected are more likely to suffer severe adverse reactions to the vaccines. (That's right. Far from 'protecting' us, they are actively trying to HURT us.)

9. The mandate is generally unenforceable given its broadness and the level of intrusion and micromanaging involved. However, the enforcement that does take place will employ "whistleblowers" (read: snitches), meaning disfavored areas and companies will likely bear the brunt. Selective enforcement has always been a useful tool of the left, and we'll have it here in spades. If you liked Lois Lerner's IRS, you're gonna love what's coming!

10. Finally—and this is an overall Biden administration criticism—workers are forced to be vaccinated or be punished, but illegal immigrants, welfare recipients, and other 'favored' groups are given a pass. Some "grave danger"!

Last week's victory in the 5th Circuit is but the first salvo in a long battle to come. The enemy has made it clear they aren't about to give up and intend to push this all the way. With this mandate, the Biden Administration and OSHA have declared all-out political and legal war on red states. This is violence. This is tyranny. And if the Supreme Court ultimately lets it stand, red states should respond in kind, together, nullifying the nonsense and daring the feds to enforce. Yes, it's that serious. If we don't stop this, worse, will come.
