“The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature , or of the Executive (when the Legislature cannot be convened) against domestic Violence.”—Article IV, Section 4 US Constitution “Guarantee Clause”

“No State shall, without the Consent of Congress, lay any Duty of Tonnage, keep Troops, or Ships of War in time of Peace, enter into any Agreement or Compact with another State, or with a foreign Power, or engage in War, unless actually invaded, or in such imminent Danger as will not admit of delay.”—Article 1, Section 10, Clause 3 US Constitution

There are two definitions of the word invasion.

■ The first is “an instance of invading a country or region with an armed force.” That is happening in Ukraine.

■ The second definition of an invasion is “an incursion of a large number of people or things into a place of sphere of activity.” That is happening here in America. It seems unbelievable that so many are asking for legal opinions and articulations of something so very simple.

Above are the two very clear articulations on the issue from our Constitution, our rule of law.

Those two sections tell us two things.

■ The Biden administration is derelict of its constitutional duty; this is clearly enumerated as to what they must “guarantee” to each state in the union.

■ As well, the states are given an enumerated power when the federal government fails to execute theirs on the matter of invasion . . . so we also have governors who bear the responsibility of protecting the border. In the State of Texas, Article 4, Section 7 of the state constitution articulates that as Commander-in-Chief of Texas military forces, the Governor has the duty to “repel invasions.”

These failures by elected officials and bureaucrats are the reasons why several border counties in Texas declared an invasion. As expected, the pro-

gressive socialist leftists, who embrace an open borders policy, asserted this was just a political stunt. And the Governor of Texas issued a weak executive order which failed to support those counties and declare an invasion, but rather bolstered what has been determined a "catch and release" policy.

Perhaps it is best to put all this into terms that are irrefutable, albeit disconcerting.

It is indisputable that there has been a large incursion into the U.S. Since the Biden administration implemented their open borders policy, there have been nearly 3 million who have illegally entered the United States. Of that number, there have been approximately 800,000 who are designated as "got aways." These are the individuals, often dressed in black and camouflage, who avoid apprehension.

It is imperative that we realize that the 800,000 illegal immigrants, mostly single military-aged males, represent a number greater than the active-duty strength of our U.S. Army and U.S. Marine Corps combined. Yes, there has been an illegal incursion, invasion, of more individuals into America in the past 18 months than those who currently serve on active duty in our two primary military ground combat services.

Meanwhile, the Biden administration undermines state and national security by punishing 60,000 National Guard members who have not taken "the shot." Thankfully the founders recognized government's inability to protect citizens and asserted in the Second Amendment, *"A well regulated militia being necessary for the security of a free State, the right of the people to keep and bear arms, shall not be infringed."*

To put this in perspective, the Vietnam Veterans Memorial Wall in Washington, D.C., has the names of 58,281 Americans who lost their lives in service to this nation during that war. In 2021, America lost 71,238 citizens due to fentanyl. Fentanyl originates in China and finds its way to Mexico where the cartels refine and transport it across our porous border into the United States.

China is supplying a transnational narco-criminal terrorist organization with a substance that is killing Americans. Not only are we dealing with an invasion, we are also confronting an insurgency against a non-state, non-uniformed enemy combatant that is well armed and resourced.

The constitutional failures of elected officials have enabled a drug, sex, and human trafficking epidemic in America. While there is a recession in America, the narco-criminal terrorists who control the southern border zone are amassing billions of dollars a month thanks to politicians who do not understand plain and simple English.

At the American Constitutional Rights Union, we understand the simplicity of the language and the enumerated duties and responsibilities articulated in the Constitution. We affirm that this is an invasion on our southern border, as do the veterans who are part of our Committee to Support and Defend who are publicly calling out elected officials to step up to support and defend the Constitution of the United States as written.

As ACRU's Executive Director, I have been to the border and witnessed it personally. The lack of security highlights why ACRU works to defend the Second

Amendment and our God-given right to protect ourselves against known terrorists and criminals who have infiltrated our constitutional Republic.

As the opening to the preamble of the Constitution states, it always comes down to "We the People."

While gestalt psychologist Solomon Asch showed how quickly people bow to group pressure—even into saying something they know to be false—social psychologist Stanley Milgram, a Jew, took Asch's "Asch Conformity Experiment" to a darker level.

Baffled by why Germans remained so obedient during the butchery of the Holocaust, Milgram conducted experiments to show how quickly ordinary people could inflict painful shocks on innocent people when an authority figure ("expert" in a white coat) insisted that it was for the greater good.

In Milgram's case, participants were part of a rigged experiment that tested a made-up theory that people learn better through punishment. Tied to what looked like an electric chair, the "learner" (an actor) was given a shock by participants anytime he answered a question incorrectly. The intensity of the shock, between 15 and 450 volts, increased with every wrong answer.

Though disturbed by the learner's awful screams, two-thirds of Milgram's 40 participants inflicted the max voltage when prodded by the authority figure to continue.

If participants were so disturbed that they threatened to stop, the authority figure politely asked them to continue. If they insisted on leaving, he told them sternly that they "had no choice." Assured that they wouldn't be responsible for the learner's injury or death, most of the participants continued, even against their deepest moral sense that it was wrong.

"The ordinary person who shocked the victim did so out of a sense of obligation," Milgram wrote in 1965. "With numbing regularity, good people were seen to knuckle under to the demands of authority and perform actions that were callous and severe. Men who are in everyday life responsible and decent were seduced by the trappings of authority, by the control of their perceptions, and by the uncritical acceptance of the experimenter's definition of the situation into performing harsh acts."

Trappings of authority. Control of perceptions. Uncritical acceptance of the "experts'" definition of the situation. Overriding their own basic sense of right and wrong.

Sound familiar?

The Biden administration, Democrats and American socialists have pushed the country to one of the strangest moments in our history. While looking at

us squarely in the eyes, people sworn to uphold our constitution deliberately use butchered language, twisted narratives and provable lies to “seduce” Americans into becoming obedient agents of “harsh acts” that are ripping our institutions to shreds.

The unscientific response to covid, including the recent approval of covid shots for children 6 months to 5 years, is not the only example.

To inflict severe pain on the Democrats’ political enemies, they’ve created a committee with the trappings of authority to deepen the perception that the Jan. 6 riot was a plotted and planned “insurrection.”

Ignoring the pain that race division has inflicted on the lives of so many since George Floyd’s death, authorities are injecting a lethal narrative of “whiteness” into the veins of every institution to push a tyrannical strain of race equity.

And while sending “electric shocks” into America’s social control apparatus by defunding, dismantling and discouraging law enforcement, they openly side with criminals while muffling victims’ screams, then work like the devil to take guns away from those they’ve made more vulnerable to cocky criminals.

But of all the butchery created by today’s sheepish obedience to unjust authority, none is darker than those who “control the perceptions” that abortion is something other than the taking of a human life. And since the awful screams come from voiceless babies, the crime is morally digestible, as if death isn’t real.

With so many abortions, we no longer wonder what we would’ve done during Hitler’s Holocaust. We’re doing it.

In America, 63,459,781 babies were terminated since Roe v. Wade legalized abortion, effectively as contraception, in 1973, according to the National Right to Life Committee. That’s at least 10 million more human beings than all the deaths—military and civilian—who died as a direct cause of World War II (50 to 56 million), the deadliest conflict in human history.

Globally, abortion was the leading cause of death in 2021, according to Worldometer, with 43 million babies aborted. That amounts to 42 percent of all deaths last year.

But it’s not as if no one’s been screaming. The March for Life has been yelling about the moral perils of unbridled abortions since Jan. 22, 1974, with an estimated 150,000 marching this year. You just couldn’t hear them because the media, master manipulators of perception, ignored them.

Yet they amplify the screams of a few pro-abortion protestors, especially since the Dobbs decision. They pipe-bombed and vandalized pro-life pregnancy centers, scrolling threats painted in the color of blood, and they illegally protested in front of the doxxed homes of Supreme Court justices while a man sits in jail for attempting to murder Justice Kavanaugh.

“Keep protesting,” an enfeebled Joe Biden whimpered, Sunday.

"We certainly believed that certain issues (Roe v. Wade) are just settled," Kamala Harris said in a CBS interview on Friday.

With a country smoldering with problems that could really use louder screams, why all the high-intensity voltage on the abortion issue? What's the "greater cause" fueling the psychotic frenzy to seduce agents of "harsh acts" into inflicting pain and death?

A woman's "reproductive rights"? Sure. But it's more than that. Global, in fact, driven by climate change and population control. And it's no secret.

Steven Mosher, Population Research Institute president told the Epoch Times, last week, that elitists billionaires and the United Nations believe there's too many people in the world, enlarging the globe's carbon footprint and competing for limited resources.

Although population controllers write that the world's 7.7 billion population would be more ideal at 1 billion, Mosher said that thanks to Roe v. Wade and global depopulation programs over the years, the population fertility rate is actually below the replacement rate of 2.1 children per woman.

But even if that rate drops to say, 1.3 or 1.4 children—an absolute population decline—depopulation programs would continue because maniacal population controllers believe the proper number is 1 billion.

"Which raises the question of what they're going to do with the other 6 billion of us over time," said Mosher.

Whatever the designs of the pro-abortion tyrants, the covid dictators, the gun confiscators, or the authoritarian race hustlers, none of its possible without the people's willing or unwilling obedience to unjust and godless authority.

That's what made the difference for those who refused to inflict more pain in Milgram's shock experiment. Being "good" no longer meant being loyal to the authority figure who took responsibility for your actions. It meant accepting the full weight of responsibility for your own actions—and I take it further—to shift obedience to a higher moral authority.

Here's an amazing but true statistic. After more than a decade of declining carbon emissions here in the United States, in 2021, President Joe Biden's first year in office, emissions rose.

In other words, not only have Biden's energy policies been a disaster for our economy and national security as we have become more dependent on Russia and Iran, but they haven't worked as a global warming solution.

To understand the utter futility of Biden's "renewable energy" crusade, we must go back about 15 years in time to when the amazing shale revolution, thanks to energy pioneers such as Harold Hamm of Oklahoma, the man who drilled the Bakken Shale in North Dakota, began. These new drilling techniques have vastly expanded America's natural gas production over the past decade and turned America into the world's leading oil and gas superpower.

Because clean natural gas production soared and replaced coal as the No. 1 source of power generation, not only did America get rich off these bountiful resources but we also reduced our greenhouse gas emissions. In fact, over the six years covering 2014 through 2020, we led the world in our reductions in carbon dioxide emissions. Our emissions fell by 22%. That was more than former President Barack Obama's cap-and-tax plan would have reduced these emissions.

Ironically, the 10-year trend of declining carbon dioxide emissions actually ended when Biden took office. The conventional explanation for this is that as the economy opened up after covid-19, emissions rose. People were flying less and driving their cars a lot more.

But that is only part of the story. Iconoclastic environmentalist Michael Shellenberger explains the bigger story: "In 2021, emissions in the U.S. increased mostly because of increased coal use, *not* because of higher econ growth. Why? Because nat gas became more expensive. Why? Because of inadequate supply. Why? Chronic 'under-investment in production & pipelines, thanks to ESG & climate activists,'" he wrote recently.

We need to add Biden's war on fossil fuels to that mix. The Energy Department data confirms that in 2021, coal use rose in the U.S. and natural gas consumption fell. That was because Biden's Green New Deal agenda made coal a more attractive alternative in terms of costs.

So Biden's agenda has backfired. More evidence rolls in from the rest of the world. Germany has acknowledged that it will burn more coal in the years ahead to get cheap power. But they aren't going to get much of it from the U.S. Rather, they'll get it from China, which has tripled its coal output and doesn't care at all about whether its increased production will negatively affect the environment. China has among the laxest environmental laws in the world. So none of this is stopping climate change.

China has been one of the biggest winners from the Biden war on energy. The second winner is Russian dictator Vladimir Putin, who is waltzing to the bank. Russia has made \$100 billion selling oil and gas to the U.S. and others at inflated prices.

Meanwhile, Biden's war on coal production at home has led to a more than doubling of the world price of coal, and in some cases, the price increases in Europe have risen tenfold because of mining restrictions.

I don't oppose coal production, and I believe the environmentalist movement's crusade against coal as part of our energy mix makes no economic sense. We are simply displacing West Virginia and Pennsylvania coal miners with Chinese mining. We need coal in our energy mix, as even the Germans now admit.

Then there is the collateral damage of \$100 billion of lost annual output in the U.S. because of the anti-energy climate change agenda. Again, none of this makes any sense. Why are we sacrificing our own economic opportunities and handing them to China on a silver platter?

Biden, however, could not be bothered to care. At the NATO conference this past week, he chattered about the virtues of windmills and solar panels, as if the U.S. is not experiencing an energy crisis of his own making.

What all this means is that if we want to save our economy from raging inflation and at the same time save the planet, we should be producing all of the U.S. energy we can.

Glorious pictures from the edge of the universe have arrived on Earth just when events here force us to consider the possibility that governments are run by aliens. They are so out of touch with common sense that they must come from other planets.

The James Webb Space Telescope, a wonder of human ingenuity, resourcefulness, imagination, and creative curiosity, is revealing the birth of galaxies to a world in which, by contrast, overreaching oligarchs and bossy bureaucrats constrict the actions of ordinary people trying to make their own lives and the lives of others better.

Much of the world groans under immiserating rules handed down by a "theory class," even though they obviously don't work. The accolade for the most disastrous policy outcome is hotly contested, and Wednesday's grim revelation of 9.1% inflation shows that President Joe Biden's spending agenda is a strong contender. But even that might not take the cake.

Worse, perhaps, are the results of hyper-alarmism on climate change. Excessive environmental policies are proving disastrous worldwide. Suddenly, all the green chickens are coming home to roost.

Intolerant "liberals" keen to "save the planet" are ruining it—officially preventing the poor from lifting themselves out of poverty, forcing wealthy nations to retreat from comfort and efficiency into backwardness, even killing people by the hundreds of thousands.

Humankind long ago acquired the technological ability to thrive in all climes, but citizens of the most advanced nations must now check the weather fore-

cast to know if their fridges and household lights will work or be shut down in an electricity blackout.

In Britain, overdependence on wind turbines built to cut carbon emissions leaves inhabitants at the mercy of the weather . When the wind doesn't blow, the economy doesn't work.

Likewise, in Germany, the world's fourth-biggest economy, calm summer air means turbines stand idle, incapable of producing electricity and jacking up energy prices irrespective of the nation's equally asinine overdependence on gas supplies from a recalcitrant Russia.

Excessively tight emissions rules, which amount to "anti-farming policies," have triggered protests across Europe. They started in the Netherlands, where 30% of farms might be put out of business. And they have spread to Germany, Italy, Spain, and Poland, where farmers fear being subjected to the same privations.

If, as expected, bureaucratic meddling slashes Dutch output—the Netherlands is one of the biggest and most efficient farming nations in the world—production will shift to less efficient, more polluting producers elsewhere.

This is similar to the attack that green zealots in the Democratic Party launched against American energy production at the start of the Biden administration. By shutting down energy leases and discouraging investment in the United States because of exaggerated and parochial climate concerns, the green oligarchy transfers production and wealth to dirtier producers overseas, such as Russia.

As a result, gas prices across the country are higher than they've ever been and getting higher still. Basic energy costs, such as heat and air conditioning, are also more expensive. And yet California Democrats' response to this crisis has been to pass local ordinances forcing citizens to phase out natural gas , one of the most affordable sources of energy, altogether over the next several years.

The results of shortsighted, self-defeating enviro-extremism are bad enough in rich nations. But they are even worse in the undeveloped world. In Sri Lanka, which banned chemical fertilizers in a fit of adherence to global green pressure, crops collapsed and food inflation spiked to 80% in June. The result has been a public revolt, including the overthrow of the president and an occupation of his palace by disgruntled citizens.

The specter of starvation is now being reported from Africa, and the latest analysis from the U.N. World Food Program suggests that 670 million people, 8% of the world's population, will face hunger by the end of the decade.

The World Health Organization calculates that 439,000 Africans die every year from indoor air pollution because they are forced—for cooking, lighting, and heating—to burn charcoal and cattle dung, which one researcher compared to smoking 400 cigarettes per hour in the home. The reason Africans still use these primitive methods to generate energy is that green ideologues in rich nations won't allow them to get financing to build coal-fired power stations.

Extreme environmentalism is an ideology that cares little for human life, even regards it as a blight on the Earth that should be reduced. Its instinctive sympathies are against our species. It wants less economic growth, less entrepreneurial spirit, less development, less energy, less safety, less food, less comfort.

Who suffers? Those in poor nations, of course, and we in the rich nations that impose our obsessions on ourselves and on others wherever we can.

But we can't impose them everywhere. So, who doesn't suffer? Our enemies, China in particular, that watch our self-harming foolishness with delight and perhaps a little astonishment. Beijing, which in recent years built more coal-fired power stations than the rest of the world combined, sits back and watches as the self-doubting, self-hating West cedes its prosperity and global leadership.

We're now able, with our dazzling technology, to look billions of light years from the surface of our planet all the way to the rim of outer space and to peer back as far as the beginning of the universe. But here on Earth, we blind ourselves with ideology and cannot see what's staring us in the face.
