The war raging in Eastern Europe is now at its most critical stage. In the last few days it has risked turning from a conflict between Russia and Ukraine to a global conflagration.

North Korea has sent 10,000 troops to boost Putin’s forces and the U.S. has permitted the use of its long-range missiles on targets on Russian soil.

Can the war be fought out any longer solely between Kyiv and Moscow?

Within hours of U.S. President Joe Biden authorizing Ukraine to use the ATACMS (Army Tactical Missile Systems), President Zelensky launched a strike.

At 3:25 local time yesterday morning, six ATACMS were fired at a Russian military facility – reportedly used to store North Korean supplied shells – in the Bryansk region, just 80 miles from the Ukrainian border.

Asked about the weapons on Sunday, Zelensky remarked laconically that missiles will speak for themselves. Now they have roared.

One only need listen to the escalation in rhetoric from an enraged President Putin to discern how keenly the blow has been felt in the Kremlin.

Even before the ATACMS missile had been fired, he had issued a revised nuclear doctrine to declare that an attack on Russia by any nation supported by a nuclear power will be considered a joint attack by both countries.

In other words, if Washington allowed Ukraine to fire US-made missiles into Russia, Moscow would consider the Americans to be directly involved in the war in Ukraine.

Russian foreign minister Sergei Lavrov accused the West of “escalation” and said the ATACMS were being operated by “American military experts.” And indeed, these missiles can only be fired by US personnel and with the help of US satellite data.

The response Russia has promised is cataclysmic, with one senior politician close to Putin saying the firing of the missiles would be a “big step towards World War 3.”

A fortnight ago, Putin warned that Russia would respond to any attack from the West with “overwhelming nuclear firepower.” Underlying his point, he conducted nuclear drills with missiles fired from land, sea and air.

Terrifying stuff – and yet this is hardly the first time that Western leaders have ignored one of Vladimir Putin’s red lines. And each time they have done so without the Russian president making good on this tyrannical threats and nuclear bluster.

At the start of the invasion of Ukraine in February 2022, Putin warned that any interference from the West would be met with consequences “such as you have never seen in your entire history.”

Ever since, he has used blood-curdling threats to try to intimidate the West into inaction – an approach that has proven highly effective, with risk-averse Western leaders who have, fatally, prevaricated over every decision.

From the use of tanks to fighter jets and long-rang missiles, the West has hesitated before finally giving the go-ahead.

Indeed, had the ATACMS been used six months ago, Ukraine’s current energy crisis (caused by the unprecedented destruction of its power plants) might have been averted.

We cannot yet be sure what damage was caused by those six ATACMS, or even how many got through. But the Russians have admitted to a fire at the base. Another line has been undeniably crossed and there can now be no going back.

So how worried should we be? There is no doubt that with each crossed line, the risk increases. The arrival of over 10,000 North Korean soldiers on the border with Ukraine shows how the conflict is spreading. With South Korea supplying munitions to Kyiv, the risk of a new Korean War is looming on the horizon, too.

This should all be a collective wake-up call for the West which may, perhaps, have become complacent about a brutal war now well into its third year – as though it is simply a feature on the landscape, not a potentially all-devouring monster.

As Putin's new nuclear doctrine makes clear, should the Prime Minister follow in President Biden's footsteps and grant permission for Ukraine to use our Storm Shadow cruise missiles, it could make our island a Russian target.

Even without the terrifying prospect of nuclear weapons, the risk of hybrid warfare now looms large – and may indeed already be unfolding.

There is also the grim prospect of the use of thermobaric bombs (which scatter fuel before igniting it in a cloud that can vaporize human bodies), deployed by the US military in Afghanistan and dubbed “the mother of all bombs.”

Not nuclear but as devastating as a tactical nuke, maybe one would act as a “warning” to NATO by taking out the airbase in eastern Poland at Rzeszow – the hub for transferring weapons from the U.S. to neighboring Ukraine.

All this is alarming enough, but this unfolding crisis (one that is as threatening to global geopolitical stability as the Cuban Missile Crisis in 1962) is taking place against the backdrop of a deeply worrying vacuum of power in Washington.

John F. Kennedy was in his mid-40s during the Cuban missile crisis. Sixty-two years later, the current incumbent of the Oval Office is 81, and by his own admission no longer fit to hold office.

Unlike the Kremlin, the White House lacks a strong leader. A frail and lame duck president (surrounded by factions) will shortly give way to the unknown quantities of a Trump administration.

Our own wartime leader (Winston Churchill) said that you can always rely on the Americans to make the right decision – but only when they have tried all the alternatives.

The rest of the world tends to sit out the lame-duck weeks at the end of a presidential reign, holding its breath to see what the new commander-in-chief will do once in the Oval Office.

Not this time.

With eight weeks to inauguration day, there's a sense of growing instability that gives the countdown to the end of Joe Biden's term in the White House an almost uniquely dangerous character.

In fact, we seem closer to a World War III-style clash between superpower rivals than at any time since the Cuban missile crisis of 1962.

Back then, we had John F. Kennedy steering America's ship of state – a president at the height of his intellectual powers and energy.

Today we have Joe Biden, an incumbent many believe is now too frail in mind and body to give full 24/7 attention to the developing crisis over Russia.

It's even more alarming, then, that Biden and his team appear to be throwing caution aside and even revving up American engagement with the world's most fraught conflict: on the bloody battlefields of Ukraine.

By suddenly allowing Kyiv to fire U.S.-made, long-range missiles hundreds of miles inside Russia – after saying he wouldn't for more than two years – as well as adding antipersonnel mines to a massive new \$275 million delivery of American weapons, Biden is seriously upping Washington's commitment to this conflict even as Donald Trump tries to project himself as a peacemaker in the wings.

Not only is this a recipe for confusion, it could make a vicious war more deadly still. There is no guarantee that calm will return when Trump takes over in January.

Indeed, hopes that this long war (surpassing its 1,000<sup>th</sup> day this week) might be entering its latter stages seem more distant than ever.

On Tuesday, President Putin performatively changed Russian law to lower the threshold for the use of nuclear weaponry.

On Thursday, he hit back at increasing Western involvement, announcing that his forces had carried out an attack in the eastern Ukrainian city of Dnipro – using an experimental “new” hypersonic missile (code-named Oreshnik).

It is certainly likely that the chaos of Afghanistan and America's visible weakness there, emboldened Putin to think he could invade Ukraine.

Now Putin is hell-bent on bringing Ukraine to heel. It's not just Kyiv that he wants to cow – other neighbors must be kept compliant too.

He also wants to crush any hopes of liberation that restive regions within Russia (such as

Chechnya) might hold.

Even the brutal cost (both human and financial) of the war in Ukraine makes sense to the Kremlin because it sends this clear message to its citizens: “Look at the terrible price of smuggling up to the West. This is what happens if you dare to defy Moscow.”

It’s a nasty, ruthless calculation, but Putin knows that a long-drawn-out war of attrition works for him.

And there’s also the issue of indecision among U.S. leadership. In the Kremlin, there is an impressive unity. There is no doubt or division over what to do next or, more importantly, who is in charge.

Washington, with its slow transfer of power and mixed messaging, is quite different – uncomfortably like Berlin in 1914 on the eve of the First World War. It’s a historical parallel worth pursuing – for Ukrainians are like the Austrians were back then. Ukraine has placed its hope in a great ally (America) just as the collapsing Austrian empire once sought protection from the might of Germany (its industrial neighbor to the north).

By the end of June 1914, peace was in sight. Serbia (blamed for the fateful assassination of Franz Ferdinand, heir to the imperial throne of Austria) had accepted all but one of Vienna’s belligerent demands. But that all changed when the Austrian foreign minister received two telegrams from his allies in Berlin.

- The first came from German Emperor (William II) who said that, as the Serbs were cooperating, honor was satisfied and he (William) could resume his summer cruise.
- The chief of the German general staff sent a very different message: “The Serbs have rejected one of your demands. Invade now!”

“Who rules in Berlin?” asked the bewildered Austrian foreign minister. In the end, he did what the German generals demanded – setting in motion one of the most terrible conflicts in the history of humanity.

Today, the question haunting the world is: “Who rules in Washington?”

Experts from NordVPN have outlined a four-step process that anyone can follow to find out whether their phone is listening in and using private discussions for targeted advertising, Daily Mail reported.

- Step 1 – Choose a topic that is unique and unrelated to anything you’ve previously searched for, shown interest in online or even mentioned near your phone – something that wouldn’t normally appear in your advertisements.
- Step 2 – Once you have your topic, engage in several conversations about it near your phone over the next few days.
- Step 3 – Continue using your phone as you normally would during the test and not interact with any content that could be linked to your test topic in any way.
- Step 4 – After a few days of continuing your normal phone usage, observe any changes in your targeted ads.

Pay close attention to the advertisements that pop up in you social media feeds, streaming services, or any other platforms connected to your device for ads that seem to be directly or indirectly related to your secret topic. If you notice ads relating to your topic appearing without any direct interaction on your phone, it could indicate that your phone has been listening in on your conversations.

To protect your privacy and keep your conversations to yourself, cyber security experts advise deactivating Siri, Alexa, Google Assistant and any other virtual assistants or apps with microphone access.
