An article by Avi Ashkenazi titled “Israel’s Eyes and Ears: The IDF Squadron [The Nahshon Squadron] That the Entire Middle East Fears” was posted at jpost.com on July 19, 2025.

The Nachshon Squadron is the eyes and ears of the entire Air Force, Lt. Col. N said following a ceremony on Tuesday [July 14] at the Nevatim Air Force Base to mark the Nachshon 122 Squadron’s change of command.

Lt. Col. P will replace Lt. Col. N. as the head of the squadron when the latter takes office. The Nachshon Squadron knows how to handle a variety of critical capabilities for planning and executing any operation that requires air activity – from attacking in Gaza, Lebanon, Yemen, or Iran and from landing forces deep in Syria to rescue the wounded from the battlefield.

Lt. Col. N said: “We are very much in the aviation world: Operations, control, management, and working with fighter jets. If you take Syria, this is reflected in the mission of providing an intelligence response during the operation to maintain air superiority and then also on the ground. Some of the things moved from information collected in the past, through the various elements, and you need to introduce intelligence in real time.”

Lt. Col. N did not believe when he took office that the multi-front war, sparked by the October 7 massacre, would continue for so long.

What began with the failures on October 7 continued into a massive war on seven fronts, the highlight of which was the 12-day war as part of Operation Rising Lion – when the Nachshon

Squadron led the Israel Air Force (IAF) in attacks throughout Iran and opened the skies to fighter jets.

When Lt. Col. N was in the IAF (approximately a year before he was appointed squadron commander) he wrote a thesis on the Air Force's surprise in the Yom Kippur War. A month and a half after taking office (in early September 2023), he gathered all the pilots and personnel of the squadron and presented them with his research and conclusions in detail.

He said: "When we failed, I asked myself where we failed and in the same breath, what I could have done differently. We need to rise up, we can't focus on the past."

The Nachshon Squadron is first and foremost a reconnaissance squadron tasked with monitoring Iran, Gaza, and other regions.

He added: "How did this happen? The General Staff is investigating, and we are learning how to be better. We are part of this failure, too. It may be our failure, even more than for others."

Israel' eyes on the Middle East

The aerospace industry is already working hard on building an array of dozens of observation satellites that will hover in space and provide a 24-hour picture of the Middle East. The Nachshon Squadron understands that the State of Israel will not make a decision to give them up so quickly.

The squadron commander added: "We have things that we still bring that are unique, that other systems do not. The power structure is changing, and systems are being added to and altered, even as we fight. 'Oron' is a tremendous project, and the war accelerated it, yet we know how to provide intelligence in real time. When operating in the air, we bring relative and effective advantages. We open the skies forward."

For example, in Operation Rising Lion, the Nachshon Squadron worked to reflect and provide operational solutions to the IAF in preparation for a variety of target strikes in all phases of combat.

He explained: "I am part of those who bring the information and capabilities so that we are as prepared as possible in the force and as an army."

The Nachshon Squadron has three configurations of aircraft. All are executive aircraft built to meet requirements and equipped with radar, optics, and special communication systems. The various aircrafts are called Itam, Shavit, and the last one is an advanced intelligence aircraft that was fully operational two weeks prior to Operation Rising Lion.

Lieutenant T., 21, an air reconnaissance officer, is part of the team setting up the new aircraft in the squadron. The role is new to the squadron and was created in response to the new aircraft's enhanced reconnaissance capabilities.

He said: “During the war, we operated continuously day and night, defending the country’s skies. We don’t have military personnel in the role of air scouts, so we had a huge and difficult two weeks.”

Lieutenant T. said that his abilities as an air scout in the advanced aircraft are to collect tactical targets on the ground and also to detect threats in the air.

Although he has already flown in most of the Middle East (including targets in the third circle) the activity in Gaza also touched him on a personal level.

He said: “I have quite a few friends there, fighters for whom I carry out protective operations. There is nothing better than a paratrooper friend of mind from childhood, who I studied with, telling me on the phone that he feels safe when I am in the air over Gaza.”

According to Lieutenant T., the difference between the squadron’s aircraft and the HTMs is significant: “Our aircraft is multi-mission and capable of collecting a large number of targets simultaneously over a large area.”

Among the squadron’s veterans is reservist N., an airborne controller. He explained that the airborne controller’s role is to manage air traffic and missions in intense air combat. “It has the potential to be a very complex event, but when you practice for it and prepare for it properly, it becomes simpler.”

Major N. spoke about the activity in which he participated during the first attack on Iran in Operation Rising Lion.

He said: “It’s the moment when we leave the briefing and realize that the moment we have been waiting for 20 years has arrived. A historic point and our opportunity to be the body that protects our families and children. I arrived here 20 years ago. I am 40 years old. A few more years, and I would not have been part of this historic event. On a personal level, the feeling that we have the ability to go out and do this mission, and when I see the lines on the map and see that we are passing one point after another . . . I had several nights when I thought that tonight it would happen, and they would turn it around. Something then made me feel that this time we would not turn around. That morning, I left my phone off so that I could be as focused as possible. When land on the ground (probably in light of the assessments that were made before the operation), there is a sigh of relief and a look forward to the battle that lies ahead of us – thinking about the family at home and entering the battle with great force.”

He reminisced: “On October 7, at 6:00 a.m., I was on a civilian plane on my way to France to pick up my partner for aliyah. The difficult feeling of missing out on that day was felt upon landing. I think about everything we were unable to do that morning every day. My partner, whom I brought here, and I want to ensure her a safe home in Israel.”

Nachson Squadron’s uniqueness

Captain A., a pilot in the squadron, explained the uniqueness of the Nachshon Squadron that distinguishes it from other IAF squadrons.

He concluded: “We don’t have a sister squadron. Take any other squadron, whether it’s transport or helicopters, and there’s another squadron that can do the same thing. We are the only ones with the Nachshon aircraft, and all of its capabilities are unique to us. Each aircraft brings its own unique abilities that are not found anywhere else in the IAF. All the planes are Nachshon planes, but we have three platforms – each with a different mission and different people from different units operating each plane. Due to diversity, we touch on different positions of the IAF: Protecting the country’s skies, deep missions and patrols.”

Hoover Institution Senior Fellow Victor Davis Hanson said on Fox News Monday that the left waged a relentless, multi-pronged campaign to destroy President Donald Trump.

- Career-wise – Presidential-wise – Psychologically

Director of National Intelligence (DNI) Tulsi Gabbard released declassified evidence Friday showing former President Barack Obama’s national security team politicized intelligence after Trump’s 2016 win. During an appearance on “The Ingraham Angle,” Hanson said Democrats and their allies in the intelligence community spent three years undermining Trump’s legitimacy.

Hanson said: “They wanted Donald Trump’s administration to fail, and they wanted to destroy him career-wise, presidential-wise, psychologically. They wanted to destroy him. And so they went through the collusion-false narrative in 2015 and 2016. That failed.”

Hanson said the left launched a coordinated, three-year effort to cripple Donald Trump’s presidency – accusing them of using investigations and impeachment to try to overturn the 2016 election.

Hanson told host Laura Ingraham: “Then they ate up 22 months and \$40 million of his administration to destroy it. Then they took a little breath, and they went into the first impeachment Zelensky phone call and Venman and the quote-unquote whistleblower. And so this was a three-year project to overturn the will of the American people and to destroy [the] administration. [It] makes Watergate, as people have remarked on Laura, look like small potatoes.”

Despite the coordinated attacks, Trump managed to win reelection in 2024. Hanson dismissed the long-published narrative that Trump was soft on Russia as an outright fabrication.

Hanson said: “One of the worst things they did, they created this false narrative that Donald Trump was soft on the Russians. And when you look at his administration, it was the only one in four administrations where Putin didn’t leave his borders. He was tough on them. He sent Zelensky javelins. He got out of an asymmetrical missile deal.”

Hanson said Trump opposed the Nord Stream pipeline and took a tougher stance on Putin than Obama – who was caught offering concessions on missile defense.

Hanson said: “He lectured the Germans. Don’t do the Nord Stream pipeline. He was far stronger than Biden or Obama. And yet, Obama was the one with a hot mic and soul and had this quid pro quo about missile defense in exchange for giving him space. So it had all dimensions, so many dimensions of fraud.”

Journalist Matt Taibbi reported that the intelligence community withheld key findings showing no large-scale foreign tampering in the 2016 election, even as Trump was entitled to see them in his daily briefings. An internal email titled “POTUS Tasking on Russia Election Meddling” said top officials moved to draft an assessment at Obama’s request.

According to a newly released ODNI report, intelligence officials began leaking to the media and falsely claiming Russia influenced the election’s outcome. Despite years of investigations, Special Counsel Robert Mueller found no evidence of collusion between the Trump campaign and Russia.

Previously classified documents released Friday [July 18, 2025] suggested the Obama administration withheld a key intelligence briefing that contradicted allegations of Russian election interference from then President-elect Donald Trump.

The Office of the Director of National Intelligence’s (ODNI) report stated that “foreign adversaries did not use cyberattacks on election infrastructure to alter the U.S. Presidential election outcome” during the 2016 election.

The findings (which would have directly contradicted media reports and intelligence leaks alleging Russian interference) were ultimately pulled from the Presidential Daily Briefing (PDB) just days after Trump’s victory – despite being cleared for inclusion, according to files released by the ODNI.

Following Trump’s 2016 victory, a PDB was drafted by the intelligence community (IC) on December 7 to examine the potential impact of cyber hacks on the election results – but it was “killed” by a senior PDB official who cited “new guidance” (according to ODNI).

- The IC findings demonstrated that “Russian and criminal actors did not impact” the 2016 election.
- The flash point of the revelations was “when” the intelligence community (IC) omitted information showing there was no evidence of large-scale foreign tampering in the 2016 election.
- Trump was entitled to read the PDB as president-elect, so Trump’s former National Security Adviser (Michael Flynn) was reading the PDBs at that point.
- Flynn noted that the last-minute decision to halt the PDB may have “very likely” been because he was reading the briefings.

- Instead of the PDB, a National Security Council Principals Committee (PC) gathered December 9 for a meeting.
- The ODNI report on Friday [July 18, 2025] said: “Deep State officials in the IC” then started leaking to the media and asserting Russia influenced the outcome of the 2016 election.

Legacy media’s biggest players – NBC News, The New York Times (NYT) and others – appear to be in full damage-control mode over the “Russiagate” revelations, director of national intelligence (DNI) Tulsi Gabbard unveiled Friday [July 18].

NBC accused Gabbard of trying to “rewrite the history of the 2016 election” in a Tuesday [July 22] headline.

The lead of NBC’s story accuses Gabbard and President Donald Trump of “seeking to reverse an eight-year-old assessment that Russia waged an information war to boost Trump’s candidacy.”

The story touts conclusions made by the infamous 2017 Intelligence Community Assessment (ICA) and by a 2020 Senate investigation that found that Russian president Vladimir Putin attempted to influence the 2016 U.S. election and damage Hillary Clinton’s candidacy.

Those e-mails, Gabbard claimed in a Friday [July 18] tweet, show that Obama’s own intelligence chiefs found that Russia “‘did not impact recent U.S. election results’ by conducting cyber attacks on infrastructure.”

However, despite accusing Gabbard of attempting to rewrite history, NBC does not cite the Obama administration’s intelligence agency E-mails she declassified until deep into the story. The outlet cites a talking point prepared for the Obama administration’s DNI, James Clapper, which was released by Gabbard Friday [July 18].

On July 18, Gabbard wrote on x.com: “On Dec. 8, 2016, IC officials prepared an assessment for the President’s Daily Brief [PDB], finding that Russia ‘did not impact recent U.S. election results’ by conducting cyber attacks on infrastructure. Before it could reach the President, it [the PDB] was abruptly pulled ‘based on new guidance.’ This key intelligence assessment was never published.”

- NBC also made no mention of a memo sent from a Department of Homeland Security (DHS) official to Obama’s DNI, James Clapper, which read: “The thrust of the analysis is that

there is no indication of a Russian threat to directly manipulate the actual vote count through cyber means,” according to documents Gabbard declassified.

- Similarly, The Washington Post’s fact checker Glenn Kessler claimed Gabbard’s accusations were “based on thin gruel.” In his fact check, Kessler raised doubts about claims that the infamous and now discredited Steele Dossier influenced the 2017 ICA. “Calling it ‘a factor’ in the ICA is a stretch,” Kessler wrote.

Then–Central Intelligence Agency (CIA) director John Brennan was so insistent on including the dossier in the ICA that he apparently defied warnings from numerous agency officials who asserted its inclusion could compromise the assessment’s integrity, according to a 2025 CIA review of the ICA, commissioned by CIA director John Ratcliffe.

“Despite these objections, Brennan showed a preference or narrative consistency over analytical soundness,” the CIA memo stated.

- National Public Radio (NPR) and the NYT also covered the Gabbard documents critically, both joining NBC and The Washington Post in burying a key detail from her revelations.

Gabbard’s documents show Obama canceled a December 9, 2016, Presidential Daily Brief (PDB), which then-president-elect Donald Trump would have seen.

From the outside, the idea made no sense at all. Why would a broadcast network cancel one of its best-known shows that ranks number one in its time slot?

“The Late Show” was losing money and there was no apparent path to turning around its financial position. CBS insiders insist (even when speaking frankly on condition of anonymity) that the move was financially driven – not politically motivated.

The bottom has been falling out of the late-night TV business model for several years now. Audience fragmentation and digital competition have led to a decline in ad revenue across the board. One insider described it as “cratering” at CBS.

Even though Colbert outrated his competition at 11:35 p.m., the overall audience for late-night has been shrinking. The shows hosted by Colbert and his rivals (Jimmy Fallon and Jimmy

Kimmel) are inherently expensive to produce – with hundreds of staffers and elaborate studio productions.

Trump personally celebrated the cancellation on Friday morning, writing on Truth Social: “I absolutely love that Colbert got fired. His talent was even less than his ratings. I hear Jimmy Kimmel is next. [He] has even less talent than Colbert!”

For the past week now, there has been media mewling over the announced cancellation of Stephen Colbert and “The Late Show.”

Some people say: Colbert is being canceled while having the top-rated talk show. But there is a problem with that statement.

For over a year now, “Gutfeld!” on Fox News has been outperforming “The Late Show” – while Colbert sees his numbers eroding, Gutfeld has been steadily building his audience over the years.

It has been revealed that the primary reason behind the Colbert cancellation has been the unwieldy cost of the production. The host sports a hefty \$15 million annual contract, and the show’s reported 200-member staff leads to a \$100 million operating budget.

As a result, “The Late Show” is losing \$40 million for CBS each year. This is all the reason to yank the power cord on the show.

And “Gutfeld!” operates on a smaller budget and crew. The staff is roughly 10% the size of Colbert’s, and the operating expense is nowhere near \$10 million.

Here is another detail. Gutfeld has explained how his show has challenges bringing in writers, as well as having entertainment figures coming on his show – because of the rampant fear that they will become blacklisted in Hollywood. So, as the critics are barking about Colbert allegedly being targeted, Gutfeld operates with a constant stream of resistance. The irony of this was realized recently when Hollywood was in shutdown over the WGA writers strike. As all the other late shows had to shut down during the work stoppage, “Gutfeld!” was on the air.
