- She uses her gavel to mete out “reparative” and “equitable” justice.
- She gave a no-cash bail release for Decarlos Brown, Jr. in January.
- But she’s also the Director of Operations for a mental health and addiction clinic.

Teresa Stokes needs to be investigated.

Magistrate Teresa Stokes, the last of a long line of judges to release DeCarlos Brown Jr. (a

recidivist accused of murdering Iryna Zarutskya) has a pretty eye-opening resume – one that implies that impartiality and the law really aren't her thing.

Having this type of person on the bench (releasing insane, repeat criminals onto the streets) is one more step in destroying Americans' respect for the rule of law. And without the rule of law, civilized society collapses.

- Rule 1.2 of the American Bar Association's Model Code of Judicial Conduct states: "A judge shall act at all times in a manner that promotes public confidence in the independence, integrity, and impartiality of the judiciary, and shall avoid impropriety and the appearance of impropriety."

This is a good rule, because people will not accept the rule of law necessary for a civil society if they take one look at a judge and assume that he or she is untrustworthy or just unworthy. The rule applies to magistrates, too, since they act in a judicial capacity.

North Carolina has a more abbreviated version of the same rule.

- Canon 2: "A judge should avoid impropriety in all the judge's activities."

So, what's the story on Teresa Stokes?

Well, as Olivia Murray wrote [in an americanthinker article on September 8 titled "Judge Who Last Released Iryna Zarutskya's Alleged Killer Reportedly Profits From a Mental Health and Addiction Clinic—Is She Lining Her Own Pockets?"]], we already know that, along with her magistrate position, she runs a mental health and addiction clinic in Charlotte, North Carolina.

That alone raises an interesting question: How in the world could Stokes have missed that Brown was and is mentally ill?

- At the time, this was Brown's 14th arrest.
- He'd been previously arrested – felony larceny, armed robbery & communicating threats
- He'd been diagnosed with schizophrenia.

Yet, Stokes released him into the community when he was quite obviously careening into another schizophrenic breakdown.

Aside from being a businesswoman, what else is Stokes?

Stokes was never even admitted to the North Carolina bar when she assumed her role as a magistrate. I haven't been able to find evidence that she was admitted to the State Bar of Michigan, either. She's certainly not currently in the database. Instead, Stokes and her "wife" used to own a halfway house, fried chicken joint in Lansing, Michigan – as well as being owners and directors of Pinnacle Recovery (another mental health

and addiction organization, this one in Lansing). There is nothing on the internet that explains how Stokes ended up sitting as a judge magistrate reviewing criminal cases in Charlotte, North Carolina. However, it's clear from interviews that Stokes' sole focus is mental illness and substance abuse (she lost her brother and another relative to drug addiction).

- One must assume that she views her role on the court (not as applying the law, but) as protecting addicts from the law.
- Our legal system cannot sustain judges like Stokes.
- As long as we have judges who use the bench to advance their personal policies, civilized life in America will collapse.
- (Note: Stokes is the last link in the chain, so she's getting all the heat – The other 13 judges who left Brown on the streets deserve to be named and shamed, too).

Turning Point USA founder Charlie Kirk said on Fox News Tuesday that the media's race-obsessed narrative finally collided with public backlash, data, and growing skepticism over its selective coverage of violent crime.

Corporate media largely ignored the brutal stabbing of Ukrainian refugee Iryna Zarutka for days – offering only brief coverage after public outrage grew. During an appearance on “The Will Cain Show,” Kirk said America is the least racist country in the world and warned that the left's selective outrage over race-based violence exposes the hypocrisy of the narrative forced upon the nation.

Kirk said: “We're the least racist country ever to exist in the history of the world. In fact, if you want to actually talk about race-focused activity, why is it that you then ignore all the race-focused activity of black on white crime? Will, I want to live in a race-neutral country. I don't like talking about race all the time. But when I see it, and I see the left ignore it, and we try to make them live up to their own standard of rules that they force fed us during the chaos of 2020, it really goes to show the destruction that this can lead to the entire nation.”

Kirk accused left-leaning outlets of fabricating a story of relentless white-on-black violence while deliberately ignoring evidence of black-on-white crimes.

Kirk said: “The media doesn't care about this, and we should start asking why. It doesn't fit a

narrative. This is my most charitable reading. The narrative that they have pushed forward in the last 10 years is that there is a relentless assault against black people on behalf of white people, and the data does not show that.”

Kirk said Tuesday that the media’s post-2020 narrative portraying America as a systemically racist nation has not only warped public discourse, but ignored hard data.

Kirk added: “White individuals are actually more likely to be attacked, especially even per capita, by black individuals in this country. The narrative that they have tried to force feed this nation post 2020 is that we are a systematically racist country to our core. We started to say the word racist more. We started to redesign our corporations. We started to teach things in our classrooms that were from the 1619 project, and all of this has now been met with an appropriate backlash where people said we’re actually not nearly as racist as you say we are.”

Kirk said that the media’s false racial narrative isn’t just rhetoric as it drives real policy, from soft-on-crime policing to multimillion-dollar payouts – all rooted in a lie left unchallenged in schools and public discourse.

Kirk said: “The final thing I’ll say is this is more than just a semantic argument. This is more than just whether or not it’s a race thing or not. Bad policing practices, consent decrees, opening up the prisons. As you say, \$3.3 million is an outgrowth of a media narrative lie. So it’s not just an innocent media narrative lie. Real policies get put into place when you don’t challenge this nonsense in the public schools.”

Newly released footage shows bystanders rushing to help a Ukrainian refugee as she bled out on a Charlotte, N.C. train, moments after she was stabbed.

- The video, made public Friday, quickly went viral – prompting Axios to claim Monday that “MAGA influencers” were exploiting the killing to push a narrative about rising crime.
- The Axios piece triggered backlash online – with critics slamming the outlet for downplaying the media’s silence.
