Politically, we have a firestorm brewing. In Minneapolis, an ICE agent shot and killed a protester. In Portland, ICE shot two more, this time in a felony traffic stop. As I write this, Law Dork reports protests in DC demanding “Stop ICE Terror Now.”

On the opposite side, we have DHS Secretary Noem calling the actions of the protesters in Minneapolis “domestic terrorism,” and VP Vance clearly outlining the facts indicating that the shooting was, in police parlance, “a good shoot” in self-defense.

The cherry on top of this fecal sundae is Minnesota Governor Walz’s assignment of the Minnesota National Guard to “assist Minneapolis police.” One must wonder just what sort of “help” they’ll be ordered to provide after Minneapolis Mayor Frey shouted that ICE *must* “get the f*** out of Minneapolis!”

The single legal question that must be asked is simple. “Does this shoot qualify as self-defense?” Full Stop. If it’s self-defense, then no further legal action can proceed against Officer Ross. Further, if it’s self-defense, qualified immunity will bar civil actions against him as well.

There is no better authority on the Law of Self-Defense in the U.S. than Andrew Branca. He outlines the five elements necessary for a civilian to sustain a claim of self-defense.

1. Innocence

The person using deadly defensive force must not be in the wrong as the instigator.

2. Imminence

The threat of great bodily injury or death must be “right now” or so close to make no difference.

3. Proportionality

The use of deadly defensive force must be in response to a similar threat, not to a trivial insult.

4. Avoidance

Where practical, if the defender can get out of the way of the major threat, deadly force is generally not permissible.

5. Reasonableness

What would a rational, reasonable person do in the same situation?

Note that these all apply to civilians. The police have special dispensations due to their status and duties.

A civilian has no right (contrary to lots of TV shows) to “pick a fight.” If you then use deadly force in that fight (because you are the instigator), you cannot claim self-defense. Again, full stop.

Law enforcement officers are in a radically different position. Their job includes approaching and apprehending hostile individuals who often regard police presence as a provocation to a deadly confrontation. That’s why they generally work as teams. Two officers are often enough to convince a miscreant to quietly turn around and put their hands behind their backs.

If a potentially deadly confrontation arises out of a police encounter, the legal presumption is that the police were acting within the scope of their duties. This is called “qualified immunity.” Yes, there are cases where that is abused, but not this time.

We have video from multiple angles, and some of it has audio – so the circumstances are well established.

In 2025 (in *Barnes vs. Felix*), the Supreme Court established that “the totality of the circumstances” is properly in view, and this inquiry has no time limit. Relevant to Minneapolis, the Department of Homeland Security reports that there were 66 vehicular attacks against ICE

officers in the last year.

These compare with only two in the last year of the Biden occupation of the White House. In particular, the officer in this shooting was the victim of one such attack and suffered serious injuries from it. This would, as VP Vance noted, make him a bit sensitive to the risk of being run over.

Returning to the list, the treat of serious bodily injury or death to the officer was not just imminent; it was immediate.

We know from the officer's video that he walked all the way around the car. While he was near the driver's window, she taunted him. This was part of the training both Good and her partner had received from Minnesota ICE Watch to interfere with ICE.

As Officer Ross continued to walk to the rear and then the passenger side of the car, other officers commanded Renee Nicole Good to "get out of the car." This was a lawful command that Good was obligated to obey.

Instead, as Officer Ross started to cross in front of the car, Good's lesbian partner Rebecca yelled, "Drive, Baby, drive, drive!"

Good put the car in reverse with the front wheel turned hard right, slamming two officers with the side of her car, committing the felony (times two) of assaulting an officer during the performance of his duty.

Good then shifted into Drive and stepped hard on the gas, as evidenced by her tires spinning. Simultaneously, she turned the wheel left, aiming her car directly at Officer Ross – who was moving to get out of her path. Good was now assaulting a third officer. The car lurched forward, and Officer Ross was left with no alternative.

Ross was facing an immediate threat of serious bodily injury or death. His only choices were to be run over or employ deadly force to stop a deadly force attack. He fired three times, and Good died. In the process, he was still struck by the car, but not in a way that caused significant injury.

Good's felonies now include the following.

- Failure to obey a lawful order by a law enforcement officer.
- Three counts of aggravated assault against three different law enforcement officers.
- Attempted murder.
- Unlawful vehicular flight.

Officer Ross acted properly.

The Supreme Court has held that the reckless operation of a motor vehicle is "an extreme danger to human life," justifying deadly force (Scott vs. Harris). This was reinforced in Plumhoff vs.

Rickard. Intentional vehicular flight from police is a “violent felony” (Sykes vs. US).

There can be no logical argument that the shooting was not a proportional response, in that Officer Ross was attempting to end a lethal force encounter. It happened so fast that he had no ability to avoid the confrontation. He could hear the spinning of the tires on the pavement and see the car coming directly at him from a very short distance.

Given the Supreme Court’s rulings, one could say that it would have been unreasonable for him simply to allow Good to continue. He had to react in an instant to a lethal threat. He also had a duty to protect the public from a continuing lethal threat.

The entire event would have been avoided if Good and her partner had simply complied with the law rather than interfering with law enforcement while leading the protest. And that brings us to a second point.

Because Rebecca Good encouraged and participated in Renee’s unlawful acts, under the law she is guilty as well. And because Good died during the commission of felonies, that can be considered First Degree Murder.

Rebecca should be charged with the following.

- Attempted murder of Officer Ross
- First Degree Murder of Renee Good
- Three counts of assault on a law enforcement officer
- Unlawful vehicular flight

America needs a peaceful society. The Left is showing that “by any means necessary” means exactly that. That cannot be permitted to continue.

- We need to believe the Left when they tell us who they are.
- We need to know that those who violate the law will be brought swiftly to justice.
- Only then will our streets become safe.

Legal Observers are the “eyes and ears” of the legal term. They create documentation during events which can later be used in defense cases, public statements, and litigation which aims to hold law enforcement agencies accountable for the actions of their officers.

History of Legal Observing

The idea of community members watching law enforcement officers through organized patrols originates from the Black Power Movement. According to the NYC-based Justice Committee, the practice was started by the Black Panther Party in 1966. The Black Panthers conducted armed citizens' patrols in order to monitor the behavior of law enforcement officers in the Oakland Police Department. This practice later became known as cop-watch. Many local activist organizations continue to cop-watch today.

The National Lawyers Guild (as the first integrated bar association in the U.S.) took components from this practice and developed its Legal Observer Program in 1968 in New York City – in response to protests at Columbia University and city-wide antiwar and racial justice demonstrations. You may read more about NLG's history in mass defense work.

Today, legal observing is a distinct practice from cop-watch. Legal observing acts as a direct form of protester legal support – connecting activists to a much bigger support infrastructure made up of arrest hotlines, jail support teams, community bail funds and legal defense funds, attorney referral networks and more.

The chaos erupting in Minneapolis isn't an organic protest movement, and it certainly isn't spontaneous.

- It's coordinated.
- It's calculated.

- That federal immigration law is illegitimate.

After federal courts in September upheld ICE's authority to make detentive stops, the opposition didn't accept the ruling.

They escalated, moving from rhetoric to coordinated action.

What follows (in Minneapolis and elsewhere) no longer looks like civil disobedience, but like a concerted effort to obstruct federal law enforcement through the following methods.

- Misinformation
- Agitation
- Street-level interference

Every bloody confrontation is the foreseeable result of deliberate instruction and escalation.

"ICE watch" operations run through nonprofits and allied groups are the following.

- Organizing alerts
- Neighborhood monitoring
- Coordinated resistance

You don't need matching jackets to have a conspiracy under the law; you need agreement, purpose and acts of furtherance.

That's what the Racketeer Influenced and Corrupt Organization Act (better know as RICO) is for.

When elected officials make false claims while aligned activist groups organize crowds to provoke obstruction of federal law, the line between protest and conspiracy collapses.

Immigration law is federal law. Under the Constitution's Supremacy Clause – no city, governor or local official has the authority to nullify it.

When leaders claim otherwise, they aren't expressing opinions – but acknowledging misrepresenting the law.

And those lies predictably produce violence.

For the Democratic politicians behind this madness, the hypocrisy is staggering: Their party spent years going full-bore against January 6 protesters.

Wielding wall-to-wall outrage, they professed absolute moral certainty that political belief is no defense to obstructing federal authority – and they jailed people up and down the chain to prove it.

Turns out that rule is still in effect.

Under federal law, obstructing justice and assaulting or threatening federal officers is a crime.

Coordinating efforts to do so raises even more serious exposure.

Every snowball thrown at a federal officer is a crime potentially punishable by prison time – and everyone who encouraged it is complicit.

And all this uproar is based upon a fantasy so detached from reality it borders on parody.

- That immigration law somehow expired because it went unenforced.
- That violating it long enough transmutes illegality into virtue.
- That deportation (of convicted criminals or anyone at all) is immoral by definition.

There is no statute of limitations on removability. There is no amnesty by neglect.

No country in history has ever functioned without border enforcement – and enforcing the law is not radical or cruel, but the bare minimum of governance.

The most tragic part is watching people fall for it, believing that they're heroes on the "right side of history." In reality, they're calculated casualties in a political war.

The people who fed them these lies aren't standing where they stand when the arrests are made, when the charges are filed, and when the consequences arrive.

Accountability must move upstream – not just for those breaking the law in the streets, but also for others.

- For the officials who lied to them.
- For the officials who coordinated the pressure campaign.
- For the officials who knowingly sent them into harm's way.

If these leaders truly believed in change, they'd tell the truth – Laws are made in Congress, not nullified in the streets through criminal activity.

Yet they choose deception, because outrage mobilizes faster than honesty. The anti-ICE movement isn't resistance – It's exploitation. And it's looking an awful lot like a deliberate conspiracy.
